Opposition To Cigarette Tax Born From Industry Self-Interest

A Higher Cigarette Tax is a Win-Win-Win Solution

As Nevada's leaders debate how best to balance the state budget and fund vital programs, one solution – increasing the state's cigarette excise tax – stands out as good fiscal policy, good public health policy, and good politics. In short, increasing the tobacco excise tax is a win-win-win solution. Across the country, a growing number of governors and legislatures from across the political spectrum are realizing that an increase in their cigarette tax will (1) raise substantial revenue, (2) reduce smoking rates and smoking-caused health care costs, and (3) win broad support from voters. The only losers are the tobacco companies themselves.

We urge you to support the increasing of Nevada's cigarette tax. And, we want to take this opportunity to provide you with additional information to counter the tobacco industry and their allies' attempts to raise inaccurate arguments against cigarette tax increases.

## MISINFORMATION - Higher cigarette taxes increase illegal smuggling.

coughing up the truth - Increasing tobacco excise taxes <u>ALWAYS</u> increases state revenues! The tobacco industry uses the threat of a black market for smuggled cigarettes as a scare tactic to block excise taxes. Every single state that has raised its cigarette taxes has experienced increased cigarette tax revenue despite the smoking declines associated with the tax increase and despite any so-called increases in cigarette smuggling or other forms of tax-avoidance purchases. Moreover, a recent study in the journal "Health Economics" found that cigarette smuggling and tax-avoidance purchases account for no more than five percent of total cigarette sales, including purchases by smokers who go over state borders to obtain lower prices.

The problem of cigarette smuggling and tax avoidance is not caused by states raising their cigarette tax rates, but by the incredibly low cigarette tax rates still charged by a handful of states. If the low-tax states, like Nevada, raised their rates to those of surrounding states, the supply of low-cost cigarettes for interstate smuggling would disappear. As a bonus, these low-tax states would also gain substantially more revenue from increasing their cigarette taxes than they currently get from smuggling.
