
ASSEMBLY BILL NO. 107—COMMITTEE ON JUDICIARY

SUMMARY—Provides additional penalty for committing certain crimes in violation of temporary or extended order for protection. (BDR 15-285)

AN ACT relating to crimes; providing an additional penalty for committing a felony in violation of a temporary or extended order for protection; prohibiting a court from granting probation to a person who commits such a crime; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 193 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 ***1. Except as otherwise provided in NRS 193.169, a person***
4 ***who commits a crime that is punishable as a felony, other than a***
5 ***crime that is punishable as a felony pursuant to subsection 5 of***
6 ***NRS 200.591, in violation of:***
7 ***(a) A temporary or extended order for protection against***
8 ***domestic violence issued pursuant to NRS 33.020;***
9 ***(b) An order for protection against harassment in the***
10 ***workplace issued pursuant to NRS 33.270;***
11 ***(c) An order for protection against domestic violence issued in***
12 ***an action or proceeding brought pursuant to title 11 of NRS; or***



1 (d) *A temporary or extended order issued pursuant to*
2 *NRS 200.591,*
3 *shall be punished by imprisonment in the state prison for a term*
4 *equal to and in addition to the term of imprisonment prescribed by*
5 *statute for that crime. The sentence prescribed by this section runs*
6 *consecutively with the sentence prescribed by statute for the crime.*

7 2. *The court shall not grant probation to or suspend the*
8 *sentence of any person convicted of attempted murder which*
9 *involves the use of a deadly weapon, attempted murder which*
10 *results in substantial bodily harm, battery which involves the use*
11 *of a deadly weapon, or battery which results in substantial bodily*
12 *harm if an additional term of imprisonment may be imposed for*
13 *that primary offense pursuant to this section.*

14 3. *This section does not create a separate offense but provides*
15 *an additional penalty for the primary offense, whose imposition is*
16 *contingent upon the finding of the prescribed fact.*

17 **Sec. 2.** NRS 193.169 is hereby amended to read as follows:

18 193.169 1. A person who is sentenced to an additional term
19 of imprisonment pursuant to the provisions of subsection 1 of NRS
20 193.161, NRS 193.162, 193.163, 193.165, 193.167, 193.1675,
21 193.168 or 453.3345 *or section 1 of this act* must not be sentenced
22 to an additional term of imprisonment pursuant to any of the other
23 listed sections even if the person's conduct satisfies the
24 requirements for imposing an additional term of imprisonment
25 pursuant to another one or more of those sections.

26 2. A person who is sentenced to an alternative term of
27 imprisonment pursuant to subsection 2 of NRS 193.161 must not be
28 sentenced to an additional term of imprisonment pursuant to
29 subsection 1 of NRS 193.161, NRS 193.162, 193.163, 193.165,
30 193.167, 193.1675, 193.168 or 453.3345 *or section 1 of this act*
31 even if the person's conduct satisfies the requirements for imposing
32 an additional term of imprisonment pursuant to another one or more
33 of those sections.

34 3. This section does not:

35 (a) Affect other penalties or limitations upon probation or
36 suspension of a sentence contained in the sections listed in
37 subsection 1 or 2.

38 (b) Prohibit alleging in the alternative in the indictment or
39 information that the person's conduct satisfies the requirements of
40 more than one of the sections listed in subsection 1 or 2 and
41 introducing evidence to prove the alternative allegations.

42 **Sec. 3.** NRS 33.100 is hereby amended to read as follows:

43 33.100 1. A person who violates a temporary or extended
44 order is guilty of a misdemeanor, unless a more severe penalty is
45 prescribed by law for the act that constitutes the violation of the



1 order. ~~HH~~ *Except for a violation to which section 1 of this act*
2 *applies, if* the violation is accompanied by a violent physical act by
3 the adverse party against a person protected by the order, the court
4 shall:

5 (a) Impose upon the adverse party a fine of \$1,000 or require
6 him to perform a minimum of 200 hours of community service;

7 (b) Sentence him to imprisonment for not fewer than 5 days nor
8 more than 6 months;

9 (c) Order him to reimburse the applicant, in an amount
10 determined by the court, for all costs and attorney's fees incurred by
11 the applicant in seeking to enforce the temporary or extended order,
12 and for all medical expenses of the applicant and any minor child
13 incurred as a result of the violent physical act; and

14 (d) Order him to participate in and complete a program of
15 professional counseling, at his own expense, if such counseling is
16 available.

17 2. The adverse party shall comply with the order for
18 reimbursement of the applicant before paying a fine imposed
19 pursuant to this section.

20 **Sec. 4.** NRS 125.560 is hereby amended to read as follows:

21 125.560 1. A person who violates a restraining order or
22 injunction:

23 (a) That is in the nature of a temporary or extended order for
24 protection against domestic violence; and

25 (b) That is issued in an action or proceeding brought pursuant to
26 this Title,

27 is guilty of a misdemeanor, unless a more severe penalty is
28 prescribed by law for the act that constitutes the violation of the
29 order or injunction. For the purposes of this subsection, an order or
30 injunction is in the nature of a temporary or extended order for
31 protection against domestic violence if it grants relief that might be
32 given in a temporary or extended order issued pursuant to NRS
33 33.017 to 33.100, inclusive.

34 2. ~~HH~~ *Except for a violation to which section 1 of this act*
35 *applies, if* the violation is accompanied by a violent physical act
36 against a person protected by the order or injunction, the court shall:

37 (a) Impose upon the person committing the act a fine of \$1,000
38 or require him to perform a minimum of 200 hours of community
39 service;

40 (b) Sentence him to imprisonment for not fewer than 5 days nor
41 more than 6 months;

42 (c) Order him to reimburse the person obtaining the order or
43 injunction, in an amount determined by the court, for all costs and
44 attorney's fees incurred by that person in seeking to enforce the



1 order or injunction, and for all medical expenses of the person and
2 any minor child incurred as a result of the violent physical act; and
3 (d) Order him to participate in and complete a program of
4 professional counseling, at his own expense, if such counseling is
5 available.
6 3. The person committing the violation shall comply with the
7 order for reimbursement of the person obtaining the order or
8 injunction before paying any fine imposed pursuant to this section.
