AN ACT relating to public guardians; authorizing a public guardian to appoint deputies; providing for the compensation of such deputies; providing that an appointed public guardian serves at the pleasure of the board of county commissioners; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** Chapter 253 of NRS is hereby amended by adding  
2     thereto a new section to read as follows:  
3     ***1. A public guardian may appoint deputies to perform fully***  
4     ***the duties of his office. A deputy so appointed may perform all***  
5     ***duties required of the public guardian and has the corresponding***  
6     ***powers and responsibilities. Before entering upon the discharge of***  
7     ***his duties, each deputy must take and subscribe to the***  
8     ***constitutional oath of office.***  
9     ***2. Each appointment must be in writing and recorded, with***  
10    ***the oath of office of that deputy, in the office of the county***  
11    ***recorder. Any revocation or resignation of an appointment must***  
12    ***be recorded in the office of the county recorder.***

1       **3.** *The public guardian is responsible on his official bond for*  
2 *any official malfeasance or nonfeasance of his deputies and may*  
3 *require a bond for the faithful performance of the official duties*  
4 *of his deputies.*

5       **4.** *The compensation of a deputy public guardian must be*  
6 *fixed by the board of county commissioners and paid out of the*  
7 *county general fund.*

8       **Sec. 2.** NRS 253.150 is hereby amended to read as follows:

9       253.150 1. The board of county commissioners of any county  
10 may establish the office of public guardian.

11       2. The board of county commissioners may:

12       (a) Appoint ~~the~~ a public guardian ~~for a term of 4 years from~~  
13 ~~the day of appointment;~~ *who serves at the pleasure of the board;*  
14 or

15       (b) Designate an elected or appointed county officer as ex  
16 officio public guardian.

17       3. The compensation of a public guardian appointed or  
18 designated pursuant to subsection 2 must be fixed by the board of  
19 county commissioners and paid out of the county general fund.

20       **Sec. 3.** NRS 253.170 is hereby amended to read as follows:

21       253.170 1. If ~~any~~ a vacancy occurs in the office of public  
22 guardian , ~~before the expiration of a normal term,~~ the vacancy  
23 shall be filled promptly by the board of county commissioners.

24       2. The district court may designate any qualified person to  
25 serve as acting public guardian until a vacancy in such office is  
26 filled.

27       **Sec. 4.** NRS 253.180 is hereby amended to read as follows:

28       253.180 Within the limits of appropriations for his office, a  
29 public guardian may:

30       1. Employ *such* subordinates , *including, without limitation,*  
31 *deputies appointed pursuant to section 1 of this act, as* necessary  
32 for the proper performance of his duties.

33       2. Contract for the services of consultants or assistants.

34       **Sec. 5.** This act becomes effective upon passage and approval.
