AN ACT relating to motor vehicles; requiring certain vehicle dealers to provide copies of certain documents translated into Spanish for viewing by a purchaser or prospective purchaser of a motor vehicle under certain circumstances; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 482 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 ***1. Each vehicle dealer who conducts business in Spanish or***
4 ***advertises that he conducts business in Spanish shall:***
5 ***(a) Arrange for or otherwise cause the translation into***
6 ***Spanish of copies of all sales forms that the vehicle dealer uses on***
7 ***a regular basis;***

1 ***(b) Upon the request of a purchaser or prospective purchaser***
2 ***of a motor vehicle with whom the vehicle dealer or his agent is***
3 ***communicating or has communicated in Spanish as a part***
4 ***of the preliminary discussions and negotiations regarding the***
5 ***purchase or potential purchase of the vehicle, allow the***
6 ***purchaser or prospective purchaser to view the copies described in***
7 ***paragraph (a); and***

8 ***(c) At each place of business, post in a conspicuous location a***
9 ***legible sign written in Spanish, in not less than 48-point type,***
10 ***advising purchasers and prospective purchasers of motor vehicles***
11 ***of their right to view the copies described in paragraph (a) under***
12 ***the circumstances described in paragraph (b).***

13 **2. The Director shall adopt regulations to carry out the**
14 **requirements of this section in a uniform and orderly manner.**

15 **3. As used in this section, "sales form" means any document**
16 **that:**

17 ***(a) A vehicle dealer uses to reduce to writing an agreement or***
18 ***contract, or an aspect thereof, for the sale of a motor vehicle by***
19 ***the vehicle dealer to a private person; and***

20 ***(b) The purchaser of the motor vehicle is required to sign, or***
21 ***otherwise agree to, before the vehicle dealer turns over control of***
22 ***the motor vehicle to the purchaser.***

23 **Sec. 2.** NRS 482.36414 is hereby amended to read as follows:

24 482.36414 A person who assumes operation of a franchise
25 pursuant to NRS 482.36396 to 482.36414, inclusive, must be
26 licensed as a dealer pursuant to the provisions of NRS 482.318
27 to 482.363, inclusive ~~§~~, ***and section 1 of this act.***

28 **Sec. 3.** The Director of the Department of Motor Vehicles
29 shall adopt the regulations required by section 1 of this act on or
30 before January 1, 2004.

31 **Sec. 4.** This act becomes effective upon passage and approval
32 for the purpose of adopting regulations by the Director of the
33 Department of Motor Vehicles to carry out the provisions of
34 section 1 of this act and on July 1, 2004, for all other purposes.
