AN ACT making an appropriation to the Interim Finance Committee for allocation to the Eighth Judicial District of the State of Nevada for operational expenses of a mental health court in Clark County; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Interim Finance Committee for allocation to the
- 3 Eighth Judicial District of the State of Nevada for operational
- 4 expenses of a mental health court in Clark County:
- 5 For the fiscal year 2003-2004 \$300,000
- 6 For the fiscal year 2004-2005 \$300,000
- 7 2. The Interim Finance Committee shall not allocate any
- 8 money appropriated by subsection 1 until the Committee receives



1 such documentation as it deems necessary from Clark County
2 showing that a mental health court has been established in Clark
3 County.

4 3. The Interim Finance Committee is not required to allocate
5 the entire amount appropriated by subsection 1.

6 **Sec. 2.** Any balance of the sums appropriated by section 1 of
7 this act remaining at the end of the respective fiscal years must not
8 be allocated by the Interim Finance Committee after June 30 of the
9 respective fiscal years and reverts to the State General Fund as soon
10 as all payments of money committed have been made.

11 **Sec. 3.** This act becomes effective upon passage and approval.
