AN ACT relating to education; recognizing the establishment of the Center for the Analysis of Crime Statistics at the University of Nevada, Las Vegas; providing that the Center may apply for grants and accepts gifts and donations, and may use such gifts, grants and donations to carry out its duties and functions; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 396 of NRS is hereby amended by adding
2 thereto a new section to read as follows:
3 *The Center for the Analysis of Crime Statistics, established*
4 *within the Department of Criminal Justice at the University of*
5 *Nevada, Las Vegas, may:*
6 1. *Apply for any available grants and accept any gifts, grants*
7 *or donations; and*

2 **carrying out its duties and functions.**

3 **Sec. 2.** NRS 396.020 is hereby amended to read as follows:
4 396.020 The legal and corporate name of the State University
5 is the University of Nevada. The System of:

- 6 1. Universities;
- 7 2. Community colleges;
- 8 3. Administrative services;
- 9 4. Research facilities, including ~~the~~, **without limitation:**

10 **(a) The Desert Research Institute ~~and the~~ established pursuant**
11 **to NRS 396.795;**

12 **(b) The Ethics Institute ~~is~~ established pursuant to NRS**
13 **396.797; and**

14 **(c) The Center for the Analysis of Crime Statistics, established**
15 **within the Department of Criminal Justice at the University of**
16 **Nevada, Las Vegas; and**

17 5. Departments within the Public Service Division,
18 administered under the direction of the Board of Regents is hereby
19 collectively known as the University and Community College
20 System of Nevada. The System is comprised of such branches and
21 facilities as the Board of Regents deems appropriate.

22 **Sec. 3.** This act becomes effective upon passage and approval.
