SUMMARY—Provides multiplier for electricity generated by certain renewable energy systems for purpose of calculating compliance with portfolio standard for renewable energy. (BDR 58-1163)

AN ACT relating to energy; providing a multiplier for electricity generated by certain renewable energy systems for the purpose of calculating compliance with a portfolio standard for renewable energy; deeming electricity generated by certain processes to be electricity not generated by a renewable energy system; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 704 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *For the purpose of complying with a portfolio*
4 *standard established pursuant to NRS 704.7821, a provider shall*
5 *be deemed to have generated or acquired 2.4 kilowatt-hours of*
6 *electricity from a renewable energy system for each 1.0 kilowatt-*
7 *hour of actual electricity generated or acquired from a solar*
8 *photovoltaic system.*

9 **Sec. 3. 1.** *Except as otherwise provided in subsection 2, any*
10 *electricity generated by a provider using any system that involves*
11 *drawing or creating electricity from tires must be deemed to have*

1 *not come from a renewable energy system for the purpose of*
2 *complying with a portfolio standard established pursuant to NRS*

4 *2. For the purpose of complying with a portfolio standard*
5 *established pursuant to NRS 704.7821, a provider shall be deemed*
6 *to have generated or acquired 0.7 kilowatt-hours of electricity*
7 *from a renewable energy system for each 1.0 kilowatt-hour of*
8 *actual electricity generated or acquired from a system that utilizes*
9 *a reverse polymerization process, if:*

10 *(a) The system is installed on the premises of a retail*
11 *customer; and*

12 *(b) At least 50 percent of the electricity generated by the system*
13 *is utilized by the retail customer on that premises.*

14 *3. As used in this section:*

15 *(a) "Reverse polymerization process" means a process that*
16 *generates electricity from a tire that:*

17 *(1) Uses microwave reduction; and*

18 *(2) Does not involve combustion of the tire.*

19 *(b) "Tire" includes any tire for any vehicle or device in, upon*
20 *or by which any person or property is or may be transported or*
21 *drawn upon land.*

22 **Sec. 4.** NRS 704.7801 is hereby amended to read as follows:

23 704.7801 As used in NRS 704.7801 to 704.7828, inclusive,
24 *and sections 2 and 3 of this act*, unless the context otherwise
25 requires, the words and terms defined in NRS 704.7805 to
26 704.7818, inclusive, have the meanings ascribed to them in those
27 sections.

28 **Sec. 5.** This act becomes effective on January 1, 2004.
