AN ACT relating to education; making an appropriation to the Clark County School District for support of its adult family literacy project, Success Through English Program (STEP); making an appropriation to the University and Community College System of Nevada for support of the Southern and Northern Nevada Writing Projects; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Clark County School District the sum of
- 3 \$200,000 for support of its adult family literacy project, Success
- 4 Through English Program (STEP).
- 5 2. Any remaining balance of the appropriation made by
- 6 subsection 1 must not be committed for expenditure after June 30,
- 7 2005, and reverts to the State General Fund as soon as all payments
- 8 of money committed have been made.



1 **Sec. 2.** 1. There is hereby appropriated from the State
2 General Fund to the University and Community College System of
3 Nevada the sum of \$200,000 for support of the Southern Nevada
4 Writing Project and the Northern Nevada Writing Project.

5 2. The money appropriated by subsection 1 must be allocated
6 equally between the Southern Nevada Writing Project and the
7 Northern Nevada Writing Project for deposit in separate accounts
8 for each project.

9 3. Disbursements from these accounts to pay the expenses of
10 the projects must be made by the Board of Regents of the University
11 of Nevada upon the request of the administrator of the respective
12 project.

13 4. Any remaining balance of the appropriation made by
14 subsection 1 must not be committed for expenditure after June 30,
15 2005, and reverts to the State General Fund as soon as all payments
16 of money committed have been made.

17 **Sec. 3.** This act becomes effective on July 1, 2003.
