AN ACT relating to guardianship; making various changes to
provisions regarding guardianship; providing penalties;
and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 159 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 to 47.5, inclusive, of
3 this act.

4 **Sec. 2.** *“Citation” means a document issued by the clerk of*
5 *the court, as authorized by statute or ordered by the court,*
6 *requiring a person to appear, directing a person to act or conduct*
7 *himself in a specified way, or notifying a person of a hearing.*

8 **Sec. 3. 1.** *If the court has reason to believe that*
9 *guardianship proceedings may be pending in another state*
10 *concerning a ward or proposed ward, the court may order*
11 *communication with the court in the other state:*

12 *(a) To determine the involvement or interest of each*
13 *jurisdiction;*

14 *(b) To promote cooperation, expand the exchange of*
15 *information and provide any other form of assistance; and*

16 *(c) To determine the appropriate jurisdiction for the*
17 *proceedings.*

1 2. As used in this section, "guardianship" includes, without
2 limitation, a conservatorship.

3 **Sec. 4. 1.** On or after the date of the filing of a petition to
4 appoint a guardian:

5 (a) The court may appoint a person to represent the ward or
6 proposed ward as a guardian ad litem; and

7 (b) The guardian ad litem must represent the ward or proposed
8 ward as a guardian ad litem until relieved of that duty by court
9 order.

10 2. Upon the appointment of the guardian ad litem, the court
11 shall set forth in the order of appointment the duties of the
12 guardian ad litem.

13 3. The guardian ad litem is entitled to reasonable
14 compensation from the estate of the ward or proposed ward. If the
15 court finds that a person has unnecessarily or unreasonably
16 caused the appointment of a guardian ad litem, the court may
17 order the person to pay to the estate of the ward or proposed ward
18 all or part of the expenses associated with the appointment of the
19 guardian ad litem.

20 **Sec. 5. 1.** Except as otherwise provided in subsection 2, the
21 guardian of an estate shall cause an appraisal or valuation of any
22 asset of a guardianship estate to be conducted by a disinterested
23 appraiser, certified public accountant or expert in valuation and
24 file the appraisal or valuation with the court.

25 2. In lieu of an appraisal, the guardian may file:

26 (a) A verified record of value of an asset where the value of the
27 asset can be determined with reasonable certainty, including,
28 without limitation:

29 (1) Money, deposits in banks, bonds, policies of life
30 insurance or securities for money, when equal in value to cash;
31 and

32 (2) Personal property, including, without limitation,
33 household goods, if the combined value of the personal property
34 does not exceed \$5,000.

35 (b) A statement of the assessed value of real property as
36 determined by the county assessor for tax purposes, except that if
37 the real property is to be sold, the guardian must file an appraisal.

38 **Sec. 6. 1.** Before appraising or valuing any asset of the
39 guardianship estate, each appraiser, certified public accountant or
40 expert in valuation shall certify that the appraiser, accountant or
41 expert will truthfully, honestly and impartially appraise or value
42 the property according to the best of his knowledge and ability.
43 The certification must be included in the appraisal or valuation
44 and filed with the court.



1 2. *The appraisal or valuation must list each asset that has a*
2 *value of more than \$100 separately with a statement of the value*
3 *of the asset opposite the asset.*

4 3. *An appraiser, certified public accountant or expert in*
5 *valuation who performs an appraisal or valuation of a*
6 *guardianship estate is entitled to reasonable compensation for the*
7 *appraisal or valuation and may be paid by the guardian out of the*
8 *estate at any time after the appraisal or valuation is completed.*

9 4. *An appraiser, certified public accountant or expert in*
10 *valuation who directly or indirectly purchases any asset of an*
11 *estate without full disclosure to and approval by the court is guilty*
12 *of a misdemeanor. A sale made in violation of the provisions of*
13 *this subsection is void, and the asset sold may be recovered by the*
14 *guardian, ward or proposed ward.*

15 **Sec. 7. 1.** *If a guardian, interested person, ward or*
16 *proposed ward petitions the court upon oath alleging:*

17 (a) *That a person has or is suspected to have concealed,*
18 *converted to his own use, conveyed away or otherwise disposed of*
19 *any money, good, chattel or effect of the ward; or*

20 (b) *That the person has in his possession or knowledge any*
21 *deed, conveyance, bond, contract or other writing which contains*
22 *evidence of, or tends to disclose the right, title or interest of the*
23 *ward or proposed ward in or to, any real or personal property, or*
24 *any claim or demand,*

25 *the judge may cause the person to be cited to appear before the*
26 *district court to answer, upon oath, upon the matter of the petition.*

27 2. *If the person cited does not reside in the county where*
28 *letters of guardianship have been issued pursuant to NRS 159.075,*
29 *the person may be cited and examined before the district court of*
30 *the county where the person resides, or before the court that*
31 *issued the citation. Each party to the petition may produce*
32 *witnesses, and such witnesses may be examined by either party.*

33 **Sec. 8. 1.** *If the court finds, after examination of a person*
34 *cited pursuant to section 7 of this act, that the person has*
35 *committed an act:*

36 (a) *Set forth in paragraph (a) of subsection 1 of section 7 of*
37 *this act, the court may order the person to return the asset or the*
38 *value of the asset to the guardian of the estate; or*

39 (b) *Set forth in paragraph (b) of subsection 1 of section 7 of*
40 *this act, the court may order the person to return the asset or*
41 *provide information concerning the location of the asset to the*
42 *guardian of the estate.*

43 2. *The court may hold a person who is cited pursuant to*
44 *section 7 of this act in contempt of court and deal with him*
45 *accordingly if the person:*



- 1 (a) *Refuses to appear and submit to examination or to testify*
- 2 *regarding the matter complained of in the petition; or*
- 3 (b) *Fails to comply with an order of the court issued pursuant*
- 4 *to subsection 1.*
- 5 3. *An order of the court pursuant to subsection 1 is prima*
- 6 *facie evidence of the right of the proposed ward or the estate of the*
- 7 *ward to the asset described in the order in any action that may be*
- 8 *brought for the recovery thereof, and any judgment recovered*
- 9 *therein must be double the value of the asset, and damages in*
- 10 *addition thereof equal to the value of such property.*
- 11 4. *If the person who is cited pursuant to section 7 of this act*
- 12 *appears and, upon consideration of the petition, the court finds*
- 13 *that the person is not liable or responsible to the estate of the ward*
- 14 *or proposed ward, the court may order:*
- 15 (a) *The estate of the ward or proposed ward to pay the*
- 16 *attorney's fees and costs of the respondent; or*
- 17 (b) *If the court finds that the petitioner unnecessarily or*
- 18 *unreasonably filed the petition, the petitioner personally to pay the*
- 19 *attorney's fees and costs of the respondent.*
- 20 **Sec. 9.** *If the guardian neglects or refuses to sell any real*
- 21 *property of the estate when it is necessary or in the best interests of*
- 22 *the ward, an interested person may petition the court for an order*
- 23 *requiring the guardian to sell the property. The court shall set the*
- 24 *petition for a hearing, and the petitioner shall serve notice on the*
- 25 *guardian at least 10 days before the hearing.*
- 26 **Sec. 10.** *If real property of the estate of a ward is sold that is*
- 27 *subject to a mortgage or other lien which is a valid claim against*
- 28 *the estate, the money from the sale must be applied in the*
- 29 *following order:*
- 30 1. *To pay the necessary expenses of the sale.*
- 31 2. *To satisfy the mortgage or other lien, including, without*
- 32 *limitation, payment of interest and any other lawful costs and*
- 33 *charges. If the mortgagee or other lienholder cannot be found, the*
- 34 *money from the sale may be paid as ordered by the court and the*
- 35 *mortgage or other lien shall be deemed to be satisfied.*
- 36 3. *To the estate of the ward, unless the court orders*
- 37 *otherwise.*
- 38 **Sec. 11.** *At a sale of real property that is subject to a*
- 39 *mortgage or lien, the holder of the mortgage or lien may become*
- 40 *the purchaser. The receipt for the amount owed to the holder from*
- 41 *the proceeds of the sale is a payment pro tanto.*
- 42 **Sec. 12.** 1. *In the manner required by this chapter for the*
- 43 *sale of like property, a guardian may sell:*
- 44 (a) *The equity of the estate in any real property that is subject*
- 45 *to a mortgage or lien; and*



1 (b) *The property that is subject to the mortgage or lien.*
2 2. *If a claim has been filed upon the debt secured by the*
3 *mortgage or lien, the court shall not confirm the sale unless the*
4 *holder of the claim files a signed and acknowledged document*
5 *which releases the estate from all liability upon the claim.*

6 **Sec. 13.** 1. *A guardian may enter into a written contract*
7 *with any bona fide agent, broker or multiple agents or brokers to*
8 *secure a purchaser for any real property of the estate. Such a*
9 *contract may grant an exclusive right to sell the property to the*
10 *agent, broker or multiple agents or brokers.*

11 2. *The guardian shall provide for the payment of a*
12 *commission upon the sale of the real property which:*

- 13 (a) *Must be paid from the proceeds of the sale;*
14 (b) *Must be fixed in an amount not to exceed:*
15 (1) *Ten percent for unimproved real property; or*
16 (2) *Seven percent for improved real property; and*
17 (c) *Must be authorized by the court by confirmation of the*
18 *sale.*

19 3. *Upon confirmation of the sale by the court, the contract for*
20 *the sale becomes binding and enforceable against the estate.*

21 4. *A guardian may not be held personally liable and the estate*
22 *is not liable for the payment of any commission set forth in a*
23 *contract entered into with an agent or broker pursuant to this*
24 *section until the sale is confirmed by the court, and then is liable*
25 *only for the amount set forth in the contract.*

26 **Sec. 14.** 1. *When an offer to purchase real property of a*
27 *guardianship estate is presented to the court for confirmation:*

- 28 (a) *Other persons may submit higher bids to the court; and*
29 (b) *The court may confirm the highest bid.*

30 2. *Upon confirmation of a sale of real property by the court,*
31 *the commission for the sale must be divided between the listing*
32 *agent or broker and the agent or broker who secured the*
33 *purchaser to whom the sale was confirmed, if any, in accordance*
34 *with the contract with the listing agent or broker.*

35 **Sec. 15.** 1. *If a ward owns real property jointly with one or*
36 *more other persons, the interest owned by the ward may be sold to*
37 *one or more joint owners of the property only if:*

- 38 (a) *The guardian files a petition with the court to confirm the*
39 *sale pursuant to NRS 159.134; and*
40 (b) *The court confirms the sale.*

41 2. *The court shall confirm the sale only if:*
42 (a) *The net amount of the proceeds from the sale to the estate*
43 *of the ward is not less than 90 percent of the fair market value of*
44 *the portion of the property to be sold; and*



1 (b) Upon confirmation, the estate of the ward will be released
2 from all liability for any mortgage or lien on the property.

3 **Sec. 16.** 1. Except as otherwise provided in this section and
4 except for a sale pursuant to section 15 of this act, a guardian may
5 sell the real property of a ward only after notice of the sale is
6 published in:

7 (a) A newspaper that is published in the county in which the
8 property, or some portion of the property, is located; or

9 (b) If a newspaper is not published in that county:

10 (1) In a newspaper of general circulation in the county; or

11 (2) In such other newspaper as the court orders.

12 2. Except as otherwise provided in this section and except for
13 a sale of real property pursuant to section 15 of this act:

14 (a) The notice of a public auction for the sale of real property
15 must be published not less than three times before the date of the
16 sale, over a period of 14 days and 7 days apart.

17 (b) The notice of a private sale must be published not less than
18 three times before the date on which offers will be accepted, over a
19 period of 14 days and 7 days apart.

20 3. For good cause shown, the court may order fewer
21 publications and shorten the time of notice, but must not shorten
22 the time of notice to less than 8 days.

23 4. The court may waive the requirement of publication
24 pursuant to this section if:

25 (a) The guardian is the sole devisee or heir of the estate; or

26 (b) All devisees or heirs of the estate consent to the waiver in
27 writing.

28 5. Publication for the sale of real property is not required
29 pursuant to this section if the property to be sold is reasonably
30 believed to have a value of \$5,000 or less. In lieu of publication,
31 the guardian shall post notice of the sale in three of the most
32 public places in the county in which the property, or some portion
33 of the property, is located for at least 14 days before:

34 (a) The date of the sale at public auction; or

35 (b) The date on which offers will be accepted for a private sale.

36 6. Any notice published or posted pursuant to this section
37 must include, without limitation:

38 (a) For a public auction:

39 (1) A description of the real property which reasonably
40 identifies the property to be sold; and

41 (2) The date, time and location of the auction.

42 (b) For a private sale:

43 (1) A description of the real property which reasonably
44 identifies the property to be sold; and

45 (2) The date, time and location that offers will be accepted.



1 **Sec. 17. 1.** *Except for a sale pursuant to section 15 of this*
2 *act, a public auction for the sale of real property must be held:*
3 *(a) In the county in which the property is located or, if the real*
4 *property is located in two or more counties, in either county;*
5 *(b) Between the hours of 9 a.m. and 5 p.m.; and*
6 *(c) On the date specified in the notice, unless the sale is*
7 *postponed.*
8 **2.** *If, on or before the date and time set for the public auction,*
9 *the guardian determines that the auction should be postponed:*
10 *(a) The auction may be postponed for not more than 3 months*
11 *after the date first set for the auction; and*
12 *(b) Notice of the postponement must be given by a public*
13 *declaration at the place first set for the sale on the date and time*
14 *that was set for the sale.*
15 **Sec. 18. 1.** *Except for the sale of real property pursuant to*
16 *section 15 of this act, a sale of real property of a guardianship*
17 *estate at a private sale:*
18 *(a) Must not occur before the date stated in the notice.*
19 *(b) Except as otherwise provided in this paragraph, must not*
20 *occur sooner than 14 days after the date of the first publication or*
21 *posting of the notice. For good cause shown, the court may*
22 *shorten the time in which the sale may occur to not sooner than 8*
23 *days after the date of the first publication or posting of the notice.*
24 *If the court so orders, the notice of the sale and the sale may be*
25 *made to correspond with the court order.*
26 *(c) Must occur not later than 1 year after the date stated in the*
27 *notice.*
28 **2.** *The offers made in a private sale:*
29 *(a) Must be in writing; and*
30 *(b) May be delivered to the place designated in the notice or to*
31 *the guardian at any time:*
32 *(1) After the date of the first publication or posting of the*
33 *notice; and*
34 *(2) Before the date on which the sale is to occur.*
35 **Sec. 19. 1.** *Except as otherwise provided in subsection 2,*
36 *the court shall not confirm a sale of real property of a*
37 *guardianship estate at a private sale unless:*
38 *(a) The court is satisfied that the amount offered represents*
39 *the fair market value of the property to be sold; and*
40 *(b) The real property has been appraised within 1 year before*
41 *the date of the sale. If the real property has not been appraised*
42 *within this period, a new appraisal must be conducted pursuant to*
43 *sections 5 and 6 of this act at any time before the sale or*
44 *confirmation by the court of the sale.*



1 2. *The court may waive the requirement of an appraisal and*
2 *allow the guardian to rely on the assessed value of the real*
3 *property for purposes of taxation in obtaining confirmation by the*
4 *court of the sale.*

5 **Sec. 20.** *1. At the hearing to confirm the sale of real*
6 *property, the court shall:*

7 *(a) Consider whether the sale is necessary or in the best*
8 *interest of the estate of the ward; and*

9 *(b) Examine the return on the investment and the evidence*
10 *submitted in relation to the sale.*

11 2. *The court shall confirm the sale and order conveyances to*
12 *be executed if it appears to the court that:*

13 *(a) Good reason existed for the sale;*
14 *(b) The sale was conducted in a legal and fair manner;*
15 *(c) The amount of the offer or bid is not disproportionate to*
16 *the value of the property; and*

17 *(d) It is unlikely that an offer or bid would be made which*
18 *exceeds the original offer or bid:*

19 *(1) By at least 5 percent if the offer or bid is less than*
20 *\$100,000; or*

21 *(2) By at least \$5,000 if the offer or bid is \$100,000 or*
22 *more.*

23 3. *The court shall not confirm the sale if the conditions in*
24 *this section are not satisfied.*

25 4. *If the court does not confirm the sale, the court:*

26 *(a) May order a new sale;*
27 *(b) May conduct a public auction in open court; or*
28 *(c) May accept a written offer or bid from a responsible person*
29 *and confirm the sale to the person if the written offer complies*
30 *with the laws of this state and exceeds the original bid:*

31 *(1) By at least 5 percent if the bid is less than \$100,000; or*
32 *(2) By at least \$5,000 if the bid is \$100,000 or more.*

33 5. *If the court does not confirm the sale and orders a new*
34 *sale:*

35 *(a) Notice must be given in the manner set forth in section 16*
36 *of this act; and*

37 *(b) The sale must be conducted in all other respects as though*
38 *no previous sale has taken place.*

39 6. *If a higher offer or bid is received by the court during the*
40 *hearing to confirm the sale, the court may continue the hearing*
41 *rather than accept the offer or bid as set forth in paragraph (c) of*
42 *subsection 4 if the court determines that the person who made the*
43 *original offer or bid was not notified of the hearing and that the*
44 *person who made the original offer or bid may wish to increase his*
45 *bid. This subsection does not grant a right to a person to have a*



1 *continuance granted and may not be used as a ground to set aside*
2 *an order confirming a sale.*

3 **Sec. 21.** 1. *If the court confirms a sale of real property of a*
4 *guardianship estate, the guardian shall execute a conveyance of*
5 *the property to the purchaser.*

6 2. *The conveyance must include a reference to the court*
7 *order confirming the sale, and a certified copy of the court order*
8 *must be recorded in the office of the recorder of the county in*
9 *which the property, or any portion of the property, is located.*

10 3. *A conveyance conveys all the right, title and interest of the*
11 *ward in the property on the date of the sale, and if, before the date*
12 *of the sale, by operation of law or otherwise, the ward has*
13 *acquired any right, title or interest in the property other than or in*
14 *addition to that of the ward at the time of the sale, that right, title*
15 *or interest also passes by the conveyance.*

16 **Sec. 22.** 1. *If a sale of real property is made upon credit,*
17 *the guardian shall take:*

18 (a) *The note or notes of the purchaser for the unpaid portion*
19 *of the sale; and*

20 (b) *A mortgage on the property to secure the payment of the*
21 *notes.*

22 2. *The mortgage may contain a provision for release of any*
23 *part of the property if the court approves the provision.*

24 **Sec. 23.** 1. *After confirmation of the sale of real property, if*
25 *the purchaser neglects or refuses to comply with the terms of the*
26 *sale, the court may set aside the order of confirmation and order*
27 *the property to be resold:*

28 (a) *On motion of the guardian; and*

29 (b) *After notice is given to the purchaser.*

30 2. *If the amount realized on the resale of the property is*
31 *insufficient to cover the bid and the expenses of the previous sale,*
32 *the original purchaser is liable to the estate of the ward for the*
33 *deficiency.*

34 **Sec. 24.** *A guardian who fraudulently sells any real property*
35 *of a ward in a manner inconsistent with the provisions of this*
36 *chapter is liable for double the value of the property sold, as*
37 *liquidated damages, to be recovered in an action by or on behalf of*
38 *the ward.*

39 **Sec. 25.** *The periods of limitation prescribed in NRS 11.260*
40 *apply to all actions:*

41 1. *For the recovery of real property sold by a guardian in*
42 *accordance with the provisions of this chapter; and*

43 2. *To set aside a sale of real property.*



- 1 **Sec. 26. 1.** *A guardian may sell perishable property and*
2 *other personal property of the ward without notice, and title to the*
3 *property passes without confirmation by the court if the property:*
4 (a) *Will depreciate in value if not disposed of promptly; or*
5 (b) *Will incur loss or expense by being kept.*
6 **2.** *The guardian is responsible for the actual value of the*
7 *personal property unless the guardian obtains confirmation by the*
8 *court of the sale.*
9 **Sec. 27.** *A guardian may sell any security of the ward if:*
10 **1.** *The guardian petitions the court for confirmation of the*
11 *sale;*
12 **2.** *The clerk sets the date of the hearing;*
13 **3.** *The guardian gives notice in the manner required*
14 *pursuant to section 43 of this act unless, for good cause shown,*
15 *the court shortens the period within which notice must be given or*
16 *dispenses with notice; and*
17 **4.** *The court confirms the sale.*
18 **Sec. 28. 1.** *Except as otherwise provided in sections 26 and*
19 *27 of this act, a guardian may sell the personal property of the*
20 *ward only after notice of the sale is published in:*
21 (a) *A newspaper that is published in the county in which the*
22 *property, or some portion of the property, is located; or*
23 (b) *If a newspaper is not published in that county:*
24 (1) *In a newspaper of general circulation in the county; or*
25 (2) *In such other newspaper as the court orders.*
26 **2.** *Except as otherwise provided in this section:*
27 (a) *The notice of a public sale must be published not less than*
28 *three times before the date of the sale, over a period of 14 days and*
29 *7 days apart.*
30 (b) *The notice of a private sale must be published not less than*
31 *three times before the date on which offers will be accepted, over a*
32 *period of 14 days and 7 days apart.*
33 **3.** *For good cause shown, the court may order fewer*
34 *publications and shorten the time of notice, but must not shorten*
35 *the time of notice to less than 8 days.*
36 **4.** *The notice must include, without limitation:*
37 (a) *For a public sale:*
38 (1) *A description of the personal property to be sold; and*
39 (2) *The date, time and location of the sale.*
40 (b) *For a private sale:*
41 (1) *A description of the personal property to be sold; and*
42 (2) *The date, time and location that offers will be accepted.*
43 **Sec. 29. 1.** *The guardian may sell the personal property of*
44 *a ward by public sale at:*
45 (a) *The residence of the ward;*



- 1 **(b) The courthouse door; or**
- 2 **(c) Any other location designated by the guardian.**
- 3 **2. The guardian may sell the personal property by public sale**
- 4 **only if the property is made available for inspection at the time of**
- 5 **the sale, unless the court orders otherwise.**
- 6 **3. Personal property may be sold at a public or private sale**
- 7 **for cash or upon credit.**
- 8 **Sec. 30. The following interests of the estate of the ward may**
- 9 **be sold in the same manner as other personal property:**
- 10 **1. An interest in a partnership;**
- 11 **2. An interest in personal property that has been pledged to**
- 12 **the ward; and**
- 13 **3. Choses in action.**
- 14 **Sec. 31. 1. To enter into an agreement to sell or to give an**
- 15 **option to purchase a mining claim or real property worked as a**
- 16 **mine which belongs to the estate of the ward, the guardian or an**
- 17 **interested person shall file a petition with the court that:**
- 18 **(a) Describes the property or claim;**
- 19 **(b) States the terms and general conditions of the agreement;**
- 20 **(c) Shows any advantage that may accrue to the estate of the**
- 21 **ward from entering into the agreement; and**
- 22 **(d) Requests confirmation by the court of the agreement.**
- 23 **2. The court shall set the date of the hearing on the petition.**
- 24 **3. The petitioner shall give notice in the manner provided in**
- 25 **section 43 of this act.**
- 26 **Sec. 32. 1. At the time appointed and if the court finds that**
- 27 **due notice of the hearing concerning an agreement has been**
- 28 **given, the court shall hear a petition filed pursuant to section 31 of**
- 29 **this act and any objection to the petition that is filed or presented.**
- 30 **2. After the hearing, if the court is satisfied that the**
- 31 **agreement will be to the advantage of the estate of the ward, the**
- 32 **court:**
- 33 **(a) Shall order the guardian to enter into the agreement; and**
- 34 **(b) May prescribe in the order the terms and conditions of the**
- 35 **agreement.**
- 36 **3. A certified copy of the court order must be recorded in the**
- 37 **office of the county recorder of each county in which the property**
- 38 **affected by the agreement, or any portion of the property, is**
- 39 **located.**
- 40 **Sec. 33. 1. If the court orders the guardian to enter into the**
