

ASSEMBLY BILL NO. 441—ASSEMBLYMAN PERKINS

MARCH 17, 2003

SUMMARY—Enacts provisions relating to ensuring security of State of Nevada and its residents with respect to acts of terrorism and related emergencies. (BDR 19-1139)

AN ACT relating to homeland security; creating the Nevada Commission on Homeland Security; setting forth the membership and duties of the Commission; providing certain exceptions to the open meeting law; requiring certain political subdivisions to adopt and maintain a response plan; establishing a plan for the continuation of state and local governmental operations; requiring certain utilities to conduct vulnerability assessments and to prepare emergency response plans; revising provisions relating to certain unlawful acts committed against utilities; requiring the Director of the Department of Information Technology to determine the confidentiality of certain records relating to the security of the State; providing for the confidentiality of certain documents, records and other information; imposing certain requirements for interoperability with respect to information and communication systems purchased by this state and local governments; requiring certain governmental entities to place automated external defibrillators in certain buildings and facilities; making various changes with respect to the authority of the Department of Motor Vehicles to accept and reject certain documents; increasing certain criminal penalties with

respect to the fraudulent use of drivers' licenses and identification cards; making an appropriation; providing penalties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Title 19 of NRS is hereby amended by adding
- 2 thereto a new chapter to consist of the provisions set forth as
- 3 sections 2 to 27, inclusive, of this act.
- 4 **Sec. 2.** *The Legislature hereby finds and declares that:*
- 5 1. *The tragic events of September 11, 2001, have refocused*
- 6 *attention on the importance of domestic preparedness for acts of*
- 7 *terrorism and related emergencies.*
- 8 2. *The events of September 11, 2001, not only impacted our*
- 9 *homeland, but also the way of life for all Nevadans.*
- 10 3. *More than ever, the Nevada Legislature, representatives of*
- 11 *local government, law enforcement and other public safety*
- 12 *personnel, health care workers and technical service providers*
- 13 *must lead the charge in fighting against these destructive and*
- 14 *demoralizing acts of violence with strong and effective procedural*
- 15 *deterrents and enhanced criminal penalties.*
- 16 4. *While local efforts and plans to respond to acts of*
- 17 *terrorism and related emergencies are comprehensive, additional*
- 18 *statewide provisions are necessary to adequately prepare for acts*
- 19 *of cyber-terrorism, environmental catastrophes and other related*
- 20 *incidents.*
- 21 5. *As a result of the increased threat of terrorism, the*
- 22 *Legislature is compelled to address critical infrastructures,*
- 23 *governmental oversight and continuity, communications, and the*
- 24 *protection of important government documents and plans.*
- 25 6. *It is therefore within the public interest that the Legislature*
- 26 *enact provisions to:*
- 27 (a) *Protect sensitive state documents and computer systems*
- 28 *from cyber-terrorism;*
- 29 (b) *Secure the State's energy, telecommunications and water*
- 30 *infrastructures;*
- 31 (c) *Ensure the continuity of government in the event of a*
- 32 *terrorist attack;*
- 33 (d) *Develop policies providing for effective communication*
- 34 *and interoperability among federal, state and local law*
- 35 *enforcement and other first responders;*
- 36 (e) *Provide safeguards in the issuance of government*
- 37 *identification; and*



1 (f) Create an effective and comprehensive state oversight
2 structure to coordinate these and other antiterrorism initiatives.

3 **Sec. 3.** (Deleted by amendment.)

4 **Sec. 4.** As used in this chapter, unless the context otherwise
5 requires, the words and terms defined in sections 5 to 11,
6 inclusive, of this act have the meanings ascribed to them in those
7 sections.

8 **Sec. 5. 1.** "Act of terrorism" means any act that involves
9 the use or attempted use of sabotage, coercion or violence which is
10 intended to:

11 (a) Cause great bodily harm or death to the general
12 population; or

13 (b) Cause substantial destruction, contamination or
14 impairment of:

15 (1) Any building or infrastructure, communications,
16 transportation, utilities or services; or

17 (2) Any natural resource or the environment.

18 2. As used in this section, "coercion" does not include an act
19 of civil disobedience.

20 **Sec. 6.** "Commission" means the Nevada Commission on
21 Homeland Security created by section 12 of this act.

22 **Sec. 7.** "Governmental utility" means:

23 1. Any utility that is owned, operated or controlled by this
24 state or an agency or instrumentality of this state, including,
25 without limitation, the Colorado River Commission of Nevada.

26 2. Any utility that is owned, operated or controlled by any
27 county, city, town, general improvement district, special district or
28 other local governmental entity under the authority of any general
29 law, special law or city charter or any cooperative, interlocal or
30 other agreement.

31 **Sec. 8.** "Information system" means any computer
32 equipment, computer software, procedures or technology used to
33 collect, process, distribute or store information that is related to
34 the protection of homeland security.

35 **Sec. 9.** "Political subdivision" means a city or county of this
36 state.

37 **Sec. 10.** "Response agency" means an agency of this state or
38 of a political subdivision that provides services related to law
39 enforcement, firefighting, emergency medical care or public
40 safety, including, without limitation, the Nevada National Guard.

41 **Sec. 10.3.** "Restricted document" means any blueprint or
42 plan of a school, place of worship, airport, gaming establishment,
43 governmental building or any other building or facility which is
44 likely to be targeted for a terrorist attack.



- 1 **Sec. 10.7.** *“System of communication” includes, without*
2 *limitation, any public safety radio system or telecommunication*
3 *system.*
- 4 **Sec. 11. 1.** *“Utility” means any public or private entity that:*
5 *(a) Provides water service, electric service or natural gas*
6 *service to 500 or more service locations; or*
7 *(b) Operates any pipeline that is necessary to provide such*
8 *service.*
- 9 **2.** *The term includes, without limitation:*
- 10 *(a) A governmental utility.*
11 *(b) A public utility that is regulated by the Public Utilities*
12 *Commission of Nevada pursuant to chapter 704 of NRS.*
13 *(c) A rural electric cooperative established pursuant to chapter*
14 *81 of NRS.*
15 *(d) A cooperative association, nonprofit corporation, nonprofit*
16 *association or provider of electric service which is declared to be a*
17 *public utility pursuant to NRS 704.673 and which provides service*
18 *only to its members.*
19 *(e) A community water system that is subject to the*
20 *requirements of 42 U.S.C. § 300i-2.*
- 21 **Sec. 12. 1.** *The Nevada Commission on Homeland*
22 *Security, consisting of the members appointed pursuant to this*
23 *section, is hereby created.*
- 24 **2.** *The Governor shall appoint to the Commission a number*
25 *of members that he determines to be appropriate, except that the*
26 *Commission must include at least:*
- 27 *(a) One member who is a representative of a Nevada law*
28 *enforcement agency; and*
29 *(b) One member who is not employed in the field of law*
30 *enforcement and is not otherwise affiliated with the field of law*
31 *enforcement.*
- 32 **3.** *The Senate Majority Leader shall appoint one member of*
33 *the Senate as a nonvoting member of the Commission.*
- 34 **4.** *The Speaker of the Assembly shall appoint one member of*
35 *the Assembly as a nonvoting member of the Commission.*
- 36 **5.** *Except for the initial members, the term of office of each*
37 *member of the Commission who is a Legislator is 2 years and*
38 *commences on July 1 of the year of appointment.*
- 39 **6.** *The Governor or his designee shall:*
40 *(a) Serve as Chairman of the Commission; and*
41 *(b) Appoint a member of the Commission to serve as Vice*
42 *Chairman of the Commission.*
- 43 **Sec. 13.** (Deleted by amendment.)



1 **Sec. 14. 1.** *The Commission shall meet at the call of the*
2 *Chairman as frequently as required to perform its duties, but no*
3 *less than quarterly.*

4 2. *A majority of the voting members of the Commission*
5 *constitutes a quorum for the transaction of business, and a*
6 *majority of those voting members present at any meeting is*
7 *sufficient for any official action taken by the Commission.*

8 **Sec. 15. 1.** *Each member of the Commission who is not a*
9 *public employee is entitled to receive compensation of not more*
10 *than \$80 per day, as fixed by the Commission, while engaged in*
11 *the business of the Commission.*

12 2. *A member of the Commission who is a public employee*
13 *may not receive any compensation for his services as a member of*
14 *the Commission. Any member of the Commission who is a public*
15 *employee must be granted administrative leave from his duties to*
16 *engage in the business of the Commission without loss of his*
17 *regular compensation. Such leave does not reduce the amount of*
18 *the member's other accrued leave.*

19 3. *Except during a regular or special session of the*
20 *Legislature, each legislative member of the Commission is entitled*
21 *to receive the compensation provided for a majority of the*
22 *members of the Legislature during the first 60 days of the*
23 *preceding regular session for each day or portion of a day during*
24 *which he attends a meeting of the Commission or is otherwise*
25 *engaged in the business of the Commission. The compensation*
26 *and expenses of the legislative members of the Commission must*
27 *be paid from the Legislative Fund.*

28 4. *In addition to any compensation received pursuant to this*
29 *section, while engaged in the business of the Commission, each*
30 *member and employee of the Commission is entitled to receive the*
31 *per diem allowance and travel expenses provided for state officers*
32 *and employees generally.*

33 **Sec. 16. 1.** *Except as otherwise provided in subsections 2*
34 *and 3, the Commission shall comply with the provisions of chapter*
35 *241 of NRS and all meetings of the Commission must be*
36 *conducted in accordance with that chapter.*

37 2. *The Commission may hold a closed meeting to:*

38 (a) *Receive security briefings;*

39 (b) *Discuss procedures for responding to acts of terrorism and*
40 *related emergencies; or*

41 (c) *Discuss deficiencies in security with respect to public*
42 *services, public facilities and infrastructure,*

43 *if the Commission determines, upon a majority vote of its*
44 *members, that the public disclosure of such matters would be*



1 *likely to compromise, jeopardize or otherwise threaten the safety of*
2 *the public.*

3 *3. All information and materials received or prepared by the*
4 *Commission during a meeting closed pursuant to subsection 2 and*
5 *all minutes and audiovisual or electronic reproductions of such a*
6 *meeting are confidential, not subject to subpoena or discovery,*
7 *and not subject to inspection by the general public.*

8 **Sec. 17.** *The Commission shall, within the limits of available*
9 *money:*

10 *1. Make recommendations to the Governor, the Legislature,*
11 *agencies of this state, political subdivisions, businesses located*
12 *within this state and private persons who reside in this state with*
13 *respect to actions and measures that may be taken to protect*
14 *residents of this state and visitors to this state from potential acts*
15 *of terrorism and related emergencies.*

16 *2. Propose goals and programs that may be set and carried*
17 *out, respectively, to counteract or prevent potential acts of*
18 *terrorism and related emergencies before such acts of terrorism*
19 *and related emergencies can harm or otherwise threaten residents*
20 *of this state and visitors to this state.*

21 *3. With respect to buildings, facilities, geographic features*
22 *and infrastructure that must be protected from acts of terrorism*
23 *and related emergencies to ensure the safety of the residents of*
24 *this state and visitors to this state, including, without limitation,*
25 *airports, the Capitol Complex, dams, gaming establishments,*
26 *governmental buildings, highways, hotels, information technology*
27 *infrastructure, lakes, places of worship, power lines, public*
28 *buildings, public utilities, reservoirs, rivers and their tributaries,*
29 *and water facilities:*

30 *(a) Identify and categorize such buildings, facilities,*
31 *geographic features and infrastructure according to their*
32 *susceptibility to and need for protection from acts of terrorism and*
33 *related emergencies; and*

34 *(b) Study and assess the security of such buildings, facilities,*
35 *geographic features and infrastructure from acts of terrorism and*
36 *related emergencies.*

37 *4. Examine the use, deployment and coordination of response*
38 *agencies within this state to ensure that those agencies are*
39 *adequately prepared to protect residents of this state and visitors to*
40 *this state from acts of terrorism and related emergencies.*

41 *5. Assess, examine and review the use of information systems*
42 *and systems of communication used by response agencies within*
43 *this state to determine the degree to which such systems are*
44 *compatible and interoperable. After conducting the assessment,*
45 *examination and review, the Commission shall establish a state*



1 *plan setting forth criteria and standards for the compatibility and*
2 *interoperability of those systems when used by response agencies*
3 *within this state.*

4 *6. Assess, examine and review the operation and efficacy of*
5 *telephone systems and related systems used to provide emergency*
6 *911 service.*

7 *7. To the extent practicable, cooperate and coordinate with*
8 *the Division of Emergency Management of the Department of*
9 *Public Safety to avoid duplication of effort in developing policies*
10 *and programs for preventing and responding to acts of terrorism*
11 *and related emergencies.*

12 *8. Perform any other acts related to their duties set forth in*
13 *subsections 1 to 7, inclusive, that the Commission determines are*
14 *necessary to protect or enhance:*

- 15 *(a) The safety and security of the State of Nevada;*
- 16 *(b) The safety of residents of the State of Nevada; and*
- 17 *(c) The safety of visitors to the State of Nevada.*

18 **Sec. 17.5.** *On or before February 15 of each year, the*
19 *Governor shall:*

20 *1. Prepare a report setting forth:*

- 21 *(a) The activities of the Commission; and*
- 22 *(b) A description of any matters with respect to which the*
23 *Commission held a closed meeting or closed a portion of a*
24 *meeting, if any, accompanied by an explanation of the reasons*
25 *why the Commission determined that the meeting or portion*
26 *thereof needed to be closed; and*

27 *2. Submit a copy of the report to the Director of the*
28 *Legislative Counsel Bureau for transmittal to:*

- 29 *(a) If the Legislature is in session, the standing committees of*
30 *the Legislature which have jurisdiction of the subject matter; or*
- 31 *(b) If the Legislature is not in session, the Legislative*
32 *Commission.*

33 **Sec. 18.** *The Chairman of the Commission may, with the*
34 *approval of the Commission, appoint committees from its members*
35 *to assist in carrying out the duties of the Commission.*

36 **Sec. 19.** *The Governor shall provide such staff assistance to*
37 *the Commission as he deems appropriate and may designate a*
38 *state agency to provide such assistance.*

39 **Sec. 20.** *The Commission may apply for and receive gifts,*
40 *grants, contributions or other money from governmental and*
41 *private agencies, affiliated associations and other persons to carry*
42 *out the provisions of this chapter and to defray expenses incurred*
43 *by the Commission in the discharge of its duties.*

44 **Sec. 21.** *1. A document, record or other item of information*
45 *described in subsection 2 that is prepared and maintained for the*



1 *purpose of preventing or responding to an act of terrorism is*
2 *confidential, not subject to subpoena or discovery and not subject*
3 *to inspection by the general public if the Governor determines, by*
4 *executive order, that the disclosure or release of the document,*
5 *record or other item of information would thereby create a*
6 *substantial likelihood of compromising, jeopardizing or otherwise*
7 *threatening the public health, safety or welfare.*

8 2. *The types of documents, records or other items of*
9 *information subject to executive order pursuant to subsection 1*
10 *are as follows:*

11 (a) *Assessments, plans or records that evaluate or reveal the*
12 *susceptibility of fire stations, police stations and other law*
13 *enforcement stations to acts of terrorism or other related*
14 *emergencies.*

15 (b) *Drawings, maps, plans or records that reveal the critical*
16 *infrastructure of primary buildings, facilities and other structures*
17 *used for storing, transporting or transmitting water or electricity,*
18 *natural gas or other forms of energy.*

19 (c) *Documents, records or other items of information which*
20 *may reveal the details of a specific emergency response plan or*
21 *other tactical operations by a response agency and any training*
22 *relating to such emergency response plans or tactical operations.*

23 (d) *Handbooks, manuals or other forms of information*
24 *detailing procedures to be followed by response agencies in the*
25 *event of an act of terrorism or other related emergency.*

26 (e) *Documents, records or other items of information that*
27 *reveal information pertaining to specialized equipment used for*
28 *covert, emergency or tactical operations of a response agency,*
29 *other than records relating to expenditures for such equipment.*

30 (f) *Documents, records or other items of information*
31 *regarding the infrastructure and security of frequencies for radio*
32 *transmissions used by response agencies, including, without*
33 *limitation:*

34 (1) *Access codes, passwords or programs used to ensure the*
35 *security of frequencies for radio transmissions used by response*
36 *agencies;*

37 (2) *Procedures and processes used to ensure the security of*
38 *frequencies for radio transmissions used by response agencies;*
39 *and*

40 (3) *Plans used to reestablish security and service with*
41 *respect to frequencies for radio transmissions used by response*
42 *agencies after security has been breached or service has been*
43 *interrupted.*

44 3. *If a person knowingly and unlawfully discloses a*
45 *document, record or other item of information subject to an*



1 *executive order issued pursuant to subsection 1 or assists, solicits*
2 *or conspires with another person to disclose such a document,*
3 *record or other item of information, the person is guilty of:*

4 (a) *A gross misdemeanor; or*
5 (b) *A category C felony and shall be punished as provided in*
6 *NRS 193.130 if the person acted with the intent to:*

7 (1) *Commit, cause, aid, further or conceal, or attempt to*
8 *commit, cause, aid, further or conceal, any unlawful act involving*
9 *terrorism or sabotage; or*

10 (2) *Assist, solicit or conspire with another person to*
11 *commit, cause, aid, further or conceal any unlawful act involving*
12 *terrorism or sabotage.*

13 **Sec. 22. 1.** *Unless made confidential by specific statute, a*
14 *restricted document may be inspected only by a person who*
15 *provides:*

16 (a) *His name;*

17 (b) *A copy of his driver's license or other photographic*
18 *identification that is issued by a governmental entity;*

19 (c) *The name of his employer, if any;*

20 (d) *His citizenship; and*

21 (e) *Except as otherwise provided in this paragraph, a statement*
22 *of the purpose for the inspection. A person is not required to*
23 *indicate the purpose for inspecting a restricted document if the*
24 *person is an employee of any fire-fighting or law enforcement*
25 *agency.*

26 2. *Except as otherwise provided in subsection 3, a public*
27 *officer or employee shall observe any person while the person*
28 *inspects a restricted document in a location and in a manner*
29 *which ensures that the person does not copy, duplicate or*
30 *reproduce the restricted document in any way.*

31 3. *A restricted document may be copied, duplicated or*
32 *reproduced:*

33 (a) *Upon the lawful order of a court of competent jurisdiction;*

34 (b) *As is reasonably necessary in the case of an act of*
35 *terrorism or other related emergency;*

36 (c) *To protect the rights and obligations of a governmental*
37 *entity or the public;*

38 (d) *Upon the request of a reporter or editorial employee who is*
39 *employed by or affiliated with a newspaper, press association or*
40 *commercially operated and federally licensed radio or television*
41 *station and who uses the restricted document in the course of such*
42 *employment or affiliation; or*

43 (e) *Upon the request of a registered architect, licensed*
44 *contractor or a designated employee of any such architect or*



1 contractor who uses the restricted document in his professional
2 capacity.

3 4. A public officer or employee shall inform any person who
4 inspects a restricted document of the provisions of this section.

5 **Sec. 23. 1.** A public officer or employee who is the
6 custodian of a restricted document shall establish a log to record:

7 (a) The information described in subsection 1 of section 22 of
8 this act when a person is allowed to inspect the document; and

9 (b) The date and time of the inspection.

10 2. The log is not a public record and may be inspected only
11 by:

12 (a) A representative of a law enforcement agency; or

13 (b) A reporter or editorial employee who is employed by or
14 affiliated with a newspaper, press association or commercially
15 operated and federally licensed radio or television station.

16 **Sec. 24.** Nothing in section 22 or 23 of this act shall be
17 deemed to prohibit a public officer or employee from contacting a
18 law enforcement agency to report a suspicious or unusual request
19 to inspect a restricted document.

20 **Sec. 25. 1.** Each political subdivision shall adopt and
21 maintain a response plan. Each new or revised plan must be filed
22 within 10 days after adoption or revision with:

23 (a) The Division of Emergency Management of the
24 Department of Public Safety; and

25 (b) Each response agency that provides services to the political
26 subdivision.

27 2. The response plan required by subsection 1 must include:

28 (a) A drawing or map of the layout and boundaries of the
29 political subdivision;

30 (b) A drawing or description of the streets and highways
31 within, and leading into and out of, the political subdivision,
32 including any approved routes for evacuation;

33 (c) The location and inventory of emergency response
34 equipment and resources within the political subdivision;

35 (d) The location of any unusually hazardous substances within
36 the political subdivision;

37 (e) A telephone number that may be used by residents of the
38 political subdivision to receive information and to make reports
39 with respect to an act of terrorism or related emergency;

40 (f) The location of one or more emergency response command
41 posts that are located within the political subdivision;

42 (g) A depiction of the location of each police station, sheriff's
43 office and fire station that is located within the political
44 subdivision;



1 (h) *Plans for the continuity of the operations and services of*
2 *the political subdivision, which plans must be consistent with the*
3 *provisions of section 26 of this act; and*

4 (i) *Any other information that the Commission may determine*
5 *to be relevant.*

6 3. *A plan filed pursuant to the requirements of this section,*
7 *including any revisions adopted thereto, is confidential and must*
8 *be securely maintained by the entities with whom it is filed*
9 *pursuant to subsection 1. An officer, employee or other person to*
10 *whom the plan is entrusted by the entity with whom it is filed shall*
11 *not disclose the contents of such a plan except:*

12 (a) *Upon the lawful order of a court of competent jurisdiction;*
13 *or*

14 (b) *As is reasonably necessary in the case of an act of*
15 *terrorism or related emergency.*

16 **Sec. 26. 1.** *In accordance with the provisions of Section 37*
17 *of Article 4 of the Nevada Constitution, the Nevada Legislature*
18 *hereby establishes a plan for continuation of state and local*
19 *governmental operations. The provisions set forth in this section*
20 *apply only in, and must be used in accordance with, the*
21 *circumstances described in subsection 2.*

22 2. *In the event that this state or a portion of this state is*
23 *stricken by a catastrophic emergency of such magnitude that, in*
24 *the opinion of the Governor or, in the absence of the Governor,*
25 *the Lieutenant Governor, the existing provisions of the Nevada*
26 *Constitution and the statutes of this state relating to the filling of*
27 *vacancies in office are not able to provide for a sufficiently*
28 *expedient continuity of government and temporary succession of*
29 *power as a result of vacancies in office created by the catastrophic*
30 *emergency, the provisions of subsections 3 to 10, inclusive, apply.*

31 3. *If a vacancy occurs in the Office of Governor as a result of*
32 *a catastrophic emergency and none of the successors described in*
33 *NRS 223.080 are able or available to act as Governor, the*
34 *Legislature shall elect a person to serve as Governor. If*
35 *the Legislature is not in session at the time the vacancy occurs, the*
36 *Legislature may call itself into special session to elect a person to*
37 *serve as Governor.*

38 4. *If vacancies occur in more than 15 percent of the seats in*
39 *either house of the Legislature as a result of a catastrophic*
40 *emergency:*

41 (a) *The remaining Legislators available for duty constitute the*
42 *Legislature and have full power to act in separate or joint*
43 *assembly by majority vote of those present;*



- 1 ***(b) Any requirements for a quorum applicable to the***
2 ***Legislature must initially be suspended and must subsequently be***
3 ***adjusted as vacant offices are filled pursuant to NRS 218.043; and***
4 ***(c) If the affirmative vote of a specified proportion of members***
5 ***of the Legislature is required for the approval of a legislative***
6 ***measure, the same proportion of remaining members of the***
7 ***Legislature is sufficient for approval of that measure.***
8 ***5. If vacancies occur in more than 15 percent of the positions***
9 ***held by justices on the Supreme Court as a result of a catastrophic***
10 ***emergency, the vacancies must be filled by appointment of the***
11 ***Governor.***
12 ***6. If vacancies occur in more than 15 percent of the positions***
13 ***held by the district judges in any one judicial district as a result of***
14 ***a catastrophic emergency, the vacancies must be filled by***
15 ***appointment of the Supreme Court.***
16 ***7. If vacancies occur on a board of county commissioners as***
17 ***a result of a catastrophic emergency:***
18 ***(a) The remaining members of the board available for duty***
19 ***constitute the board and have full power to act by majority vote of***
20 ***those present; and***
21 ***(b) Any requirements for a quorum applicable to the board***
22 ***must initially be suspended and must subsequently be adjusted as***
23 ***vacant offices are filled.***
