AN ACT relating to motor vehicles; transferring the Program for the Education of Motorcycle Riders from the Department of Motor Vehicles to the Department of Public Safety; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** NRS 480.110 is hereby amended to read as follows:  
2     480.110 Except as otherwise provided therein, the Department  
3 shall execute, administer and enforce, and perform the functions and  
4 duties provided in:  
5     1. Chapters 176A and 213 of NRS relating to parole and  
6 probation;  
7     2. Chapter 414 of NRS relating to emergency management;  
8     3. Chapter 453 of NRS relating to controlled substances and  
9 chapter 454 of NRS relating to dangerous drugs;  
10    4. Chapter 459 of NRS relating to the transportation of  
11 hazardous materials; ~~and~~  
12    5. Chapter 477 of NRS relating to the State Fire Marshal ~~;~~  
13 *and*



1 **6. NRS 486.370 to 486.377, inclusive, and sections 5, 6 and 7**

4 **Sec. 2.** NRS 481.015 is hereby amended to read as follows:  
5 481.015 Except as otherwise provided in chapters 480 and

7 **sections 5, 6 and 7 of this act,** as used in this title, unless the context  
8 otherwise requires:

11 Vehicles.

12 **Sec. 3.** NRS 481.023 is hereby amended to read as follows:  
13 481.023 1. Except as otherwise provided ~~[therein,] in this~~

15 Department shall execute, administer and enforce, and perform the  
16 functions and duties provided in:

17 (a) Chapter 108 of NRS, and perform such duties and exercise

21 the imposition and collection of taxes on motor fuels.

23 relating to motor vehicles. **The Department shall not execute,**  
24 **administer or enforce, or perform the functions or duties provided**  
25 **in NRS 486.370 to 486.377, inclusive, and sections 5, 6 and 7 of**  
26 **this act relating to the education and safety of motorcycle riders.**

27 (d) Chapter 706 of NRS relating to licensing of motor vehicle  
28 carriers and the use of public highways by those carriers.

29 (e) The provisions of NRS 426.401 to 426.461, inclusive.  
30 2. The Department shall perform such other duties and exercise  
31 such other powers as may be conferred upon the Department.

32 **Sec. 4.** Chapter 486 of NRS is hereby amended by adding  
33 thereto the provisions set forth as sections 5, 6 and 7 of this act.

34 **Sec. 5. As used in NRS 486.370 to 486.377, inclusive, and**  
35 **sections 5, 6 and 7 of this act, unless the context otherwise**  
36 **requires, the words and terms defined in NRS 486.370 and**  
37 **sections 6 and 7 of this act have the meanings ascribed to them in**  
38 **those sections.**

39 **Sec. 6. "Department" means the Department of Public**  
40 **Safety.**

41 **Sec. 7. "Director" means the Director of the Department of**  
42 **Public Safety.**

43 **Sec. 8.** NRS 486.370 is hereby amended to read as follows:  
44 486.370 ~~[As used in NRS 486.372 to 486.377, inclusive,~~  
45 ~~"motorcycle"] "Motorcycle" does not include a trimobile.~~
