AN ACT relating to brownfield sites; creating a revolving fund to
finance the remediation of brownfield sites; requiring the
Division of Environmental Protection of the State
Department of Conservation and Natural Resources to
administer the fund; providing for the uses of money in
the fund; authorizing the Administrator of the Division to
impose a fee; authorizing the State Environmental
Commission to adopt regulations; and providing other
matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 459 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 to 18, inclusive, of this
3 act.
4 **Sec. 2.** *As used in sections 2 to 18, inclusive, of this act,*
5 *unless the context otherwise requires, the words and terms defined*
6 *in sections 3 to 10, inclusive, of this act have the meanings*
7 *ascribed to them in those sections.*



- 1 **Sec. 3.** *“Administrator” means the Administrator of the*
2 *Division.*
- 3 **Sec. 4.** *“Brownfield project” means a project for the*
4 *remediation of a brownfield site for future or alternative use.*
- 5 **Sec. 5.** *“Brownfield site” has the meaning ascribed to it in 42*
6 *U.S.C. § 9601.*
- 7 **Sec. 6.** *“Brownfields Restoration Act” means the Small*
8 *Business Liability Relief and Brownfields Revitalization Act,*
9 *Public Law 107-118.*
- 10 **Sec. 7.** *“Commission” means the State Environmental*
11 *Commission.*
- 12 **Sec. 8.** *“Division” means the Division of Environmental*
13 *Protection of the State Department of Conservation and Natural*
14 *Resources.*
- 15 **Sec. 9.** *“Federal grant” means money authorized by 42*
16 *U.S.C § 9604(k) to create a revolving fund to finance the costs of*
17 *brownfield projects.*
- 18 **Sec. 10.** *“Fund” means the Fund for Brownfield Projects*
19 *created pursuant to section 11 of this act.*
- 20 **Sec. 11.** *1. The Fund for Brownfield Projects is hereby*
21 *created in the State Treasury as a revolving fund, to be*
22 *administered by the Division.*
- 23 **2.** *Money in the Fund may be used only to carry out*
24 *brownfield projects authorized pursuant to the Brownfields*
25 *Restoration Act. Interest and income earned on the money in the*
26 *Fund must be credited to the Fund. Money remaining in the Fund*
27 *at the end of a fiscal year does not revert to the State General*
28 *Fund, and the balance in the Fund for Brownfield Projects must*
29 *be carried forward.*
- 30 **3.** *All payments reimbursing the cost of cleanups for*
31 *brownfield projects, including interest, must be deposited in the*
32 *State Treasury for credit to the Fund.*
- 33 **4.** *Claims against the Fund must be paid as other claims*
34 *against the State are paid.*
- 35 **5.** *The Division may accept gifts, appropriations,*
36 *contributions, grants and bequests of money from any public or*
37 *private sources. Money so accepted must be deposited in the State*
38 *Treasury for credit to the Fund and may be used to match the*
39 *federal grant.*
- 40 **Sec. 12.** *Except as otherwise provided in section 13 of this*
41 *act, money in the Fund, including reimbursements, repayment of*
42 *principal and interest on loans and other financial assistance, and*
43 *interest earned on money in the Fund, may be used only to*
44 *finance the cleanup of brownfield sites or provide other assistance*
45 *to brownfield projects.*



- 1 **Sec. 13.** *With regard to the money from the federal grant in*
2 *the Fund, the Administrator shall not spend more than the*
3 *federally approved amounts for the administration and fiscal or*
4 *financial oversight of the Fund.*
- 5 **Sec. 14.** *The Division shall:*
 - 6 1. *Use the money in the Fund for the purposes set forth in the*
7 *Brownfields Restoration Act.*
 - 8 2. *Determine whether brownfield projects which receive*
9 *money or other assistance from the Fund comply with the*
10 *Brownfields Restoration Act.*
- 11 **Sec. 15.** *The Division may:*
 - 12 1. *Prepare and enter into any agreements with the Federal*
13 *Government for the acceptance of grants of money for the Fund.*
 - 14 2. *Bind itself to terms of such an agreement.*
 - 15 3. *Accept grants made pursuant to the Brownfields*
16 *Restoration Act.*
 - 17 4. *Manage the Fund in accordance with requirements and*
18 *objectives of the Brownfields Restoration Act.*
 - 19 5. *Provide services relating to the management and*
20 *administration of the Fund, including the preparation of any*
21 *agreement, plan or report.*
- 22 **Sec. 16.** *The Administrator may impose and collect a fee, in*
23 *an amount established by the Commission by regulation, from*
24 *each recipient that receives financial assistance from the Fund.*
25 *The fee must be used to defray the costs of administering the*
26 *Fund.*
- 27 **Sec. 17.** *The Administrator may employ any legal, fiscal,*
28 *engineering and other expert services necessary to carry out his*
29 *duties pursuant to sections 2 to 18, inclusive, of this act.*
- 30 **Sec. 18.** *The Commission may adopt such regulations as are*
31 *necessary to carry out the provisions of sections 2 to 18, inclusive,*
32 *of this act.*
- 33 **Sec. 19.** *This act becomes effective upon passage and*
34 *approval.*
