AN ACT relating to the Executive Department of State  
Government; creating the Nevada Commission on  
Minority Affairs; providing the duties of the Commission;  
requiring the Director of the Department of  
Administration to provide certain staff assistance to the  
Commission under certain circumstances; and providing  
other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** Title 18 of NRS is hereby amended by adding  
2     thereto a new chapter to consist of the provisions set forth as  
3     sections 2 to 10, inclusive, of this act.  
4     **Sec. 2.** *As used in this chapter, unless the context otherwise*  
5     *requires, “Commission” means the Nevada Commission on*  
6     *Minority Affairs created by section 3 of this act.*  
7     **Sec. 3.** 1. *The Nevada Commission on Minority Affairs,*  
8     *consisting of 11 members appointed by the Governor, is hereby*  
9     *created.*  
10    2. *The members appointed to the Commission must represent*  
11    *a variety of minority groups.*

1       3. *The Governor shall designate:*  
2       (a) *One member of the Commission to serve as Chairman;*  
3       (b) *One member of the Commission to serve as Vice*  
4 *Chairman; and*

5       (c) *Such other officers from the membership of the*  
6 *Commission as the Governor may determine to be necessary.*

7       4. *The term of office of each Chairman, Vice Chairman and*  
8 *any other officer of the Commission is 3 years.*

9       5. *Not more than four members of the Commission may be*  
10 *from the same minority group.*

11       **Sec. 4.** *Except for the initial members, the term of office of*  
12 *each member of the Commission is 3 years and commences on*  
13 *July 1 of the year of appointment. The members shall continue in*  
14 *office until their successors are appointed. Members are eligible*  
15 *for reappointment, except that no member may serve for any part*  
16 *of more than two consecutive terms. Vacancies must be filled by*  
17 *appointment for the unexpired terms by the Governor.*

18       **Sec. 5.** *Members of the Commission receive no compensation*  
19 *for their services, but are entitled to be reimbursed for all travel*  
20 *and other expenses actually and necessarily incurred by them in*  
21 *the performance of their duties, within the limits of money*  
22 *available to the Commission.*

23       **Sec. 6. 1.** *The Commission shall meet at the call of the*  
24 *Chairman as frequently as required to perform its duties, but no*  
25 *less than quarterly.*

26       2. *A majority of the members of the Commission constitutes a*  
27 *quorum for the transaction of business, and a majority of those*  
28 *present at any meeting is sufficient for any official action taken by*  
29 *the Commission.*

30       3. *The Commission shall, on or before January 31 of each*  
31 *year, submit a report to the Governor summarizing the activities,*  
32 *needs and recommendations of the Commission.*

33       **Sec. 7.** *The Commission shall, within the limits of available*  
34 *money:*

35       1. *Study matters affecting the social and economic welfare*  
36 *and well-being of minorities residing in the State of Nevada;*

37       2. *Collect and disseminate information on activities,*  
38 *programs and essential services available to minorities in the State*  
39 *of Nevada;*

40       3. *Work in coordination with the Governor to establish*  
41 *criteria and goals for the achievement of increased economic*  
42 *opportunities in this state for minorities;*

43       4. *In cooperation with the Nevada Equal Rights Commission,*  
44 *act as a liaison to inform persons regarding:*



- 1     (a) *The laws of this state that prohibit discriminatory*
- 2     *practices; and*
- 3     (b) *The procedures pursuant to which aggrieved persons may*
- 4     *file complaints or otherwise take action to remedy such*
- 5     *discriminatory practices;*
- 6     5. *To the extent practicable, strive to create networks within*
- 7     *the business community between businesses that are owned by*
- 8     *minorities and businesses that are not owned by minorities;*
- 9     6. *Advise the Governor on matters relating to minorities and*
- 10    *of concern to minorities; and*
- 11    7. *Recommend proposed legislation to the Governor.*
- 12    **Sec. 8.** *The Chairman of the Commission may, with the*
- 13    *approval of the Commission, appoint committees from its members*
- 14    *to assist in carrying out any of the functions or duties of the*
- 15    *Commission.*
- 16    **Sec. 9. 1.** *The Director of the Department of*
- 17    *Administration shall provide staff assistance to the Commission as*
- 18    *the Governor deems appropriate.*
- 19    2. *The Commission may engage the services of volunteer*
- 20    *workers and consultants without compensation as is necessary*
- 21    *from time to time.*
- 22    **Sec. 10.** *The Commission may apply for and receive gifts,*
- 23    *grants, contributions or other money from governmental and*
- 24    *private agencies, affiliated associations and other persons for the*
- 25    *purposes of carrying out the provisions of this chapter and for*
- 26    *defraying expenses incurred by the Commission in the discharge*
- 27    *of its duties.*
- 28    **Sec. 11.** *As soon as practicable after July 1, 2003, the*
- 29    *Governor shall appoint to the Nevada Commission on Minority*
- 30    *Affairs:*
- 31    1. *Four members to terms that expire on June 30, 2004.*
- 32    2. *Four members to terms that expire on June 30, 2005.*
- 33    3. *Three members to terms that expire on June 30, 2006.*
- 34    **Sec. 12.** *This act becomes effective on July 1, 2003.*
