SUMMARY—Requires state and local governmental entities to accept consular identification card for purpose of identifying person under certain circumstances. (BDR 19-823)

AN ACT relating to governmental entities; requiring state and local governmental entities to accept a consular identification card for the purpose of identifying a person under certain circumstances; clarifying that the presentation of such a consular identification card does not, by itself, convey an entitlement to any benefits; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 237 of NRS is hereby amended by adding 2 thereto a new section to read as follows:

3 1. Except as otherwise provided in subsection 2, with respect

4 to any activity or transaction in which a local government accepts

5 an identification card issued by the Department of Motor Vehicles

6 to identify a person, the local government must also accept a

7 consular identification card to identify a person.



1 2. The provisions of subsection 1 apply only to the 2 presentation of a consular identification card for purposes of 3 identification and do not convey an independent right to receive 4 benefits of any type.

6 (a) "Consular identification card" means an identification 7 card issued by a consulate of a foreign government, which 8 consulate is located within the State of Nevada.

9 (b) "Identification card issued by the Department of Motor 10 Vehicles" means an identification card of the type described in 11 NRS 483.810 to 483.890, inclusive.

12 (c) "Local government" has the meaning ascribed to it in 13 NRS 237.050.

Sec. 2. NRS 240.163 is hereby amended to read as follows:

In taking an acknowledgment, a notarial officer 16 shall determine, from personal knowledge or from other satisfactory 17 evidence, that the person making the acknowledgment is the person 18 whose signature is on the instrument. The person who signed the 19 document shall present the document to the notarial officer in 20 person.

2. In taking a verification upon oath or affirmation, a notarial
officer shall determine, from personal knowledge or from other
satisfactory evidence, that the person making the verification is the
person whose signature is on the verified statement.

3. In certifying or attesting a copy of a document or other item,
a notarial officer shall determine that the proffered copy is a
complete, accurate and authentic transcription or reproduction of
that which was copied.

4. In making or noting a protest of a negotiable instrument, a notarial officer shall verify compliance with the provisions of subsection 2 of NRS 104.3505.

5. In executing a jurat, a notarial officer shall administer an oath or affirmation to the affiant and shall determine, from personal knowledge or other satisfactory evidence, that the affiant is the person named in the document. The affiant shall sign the document in the presence of the notarial officer. The notarial officer shall administer the oath or affirmation required pursuant to this subsection in substantially the following form: Do you (solemnly swear, or affirm) that the statements in

Do you (solemnly swear, or affirm) that the statements in this document are true, (so help you God)?

9 (b) The business from requesting the customer to display a 10 credit card as an indicia of creditworthiness or financial 11 responsibility, if the only information recorded by the business 12 concerning the credit card is the type of credit card displayed, the 13 issuer of the card and the date the card expires.

14 (c) The business from requesting the customer to record the 15 account number of his credit card on the check or draft with which 16 payment on the credit card account is being made.

17 (d) The business from requesting the production of or recording 18 of the account number of a credit card as a condition of cashing a 19 check or draft if:

20 (1) The business has agreed with the issuer of the credit card 21 to cash the checks or drafts as a service to the cardholders of the 22 issuer;

(2) The issuer has agreed to guarantee any such check ordraft so cashed; and

25 (3) The cardholder has given actual, apparent or implied 26 authority for the use of his account number for this purpose.

27 2. Except as otherwise provided in this subsection, a business
28 shall not, without the customer's consent, record a customer's
29 telephone number on the credit card sales slip as a condition of
30 accepting his credit card. This subsection does not:

(a) Prohibit the recordation of personal identifying information
required for a special purpose incidental to the use of the credit card,
such as the delivery, shipping, servicing or installation of the
purchased merchandise.

(b) Apply to a transaction in which the customer receives a cash advance against his credit card or to a transaction involving the use of preprinted spaces for personal identifying information that the business accepting the credit card has a contractual obligation to record in order to complete the transaction.

40 (c) Apply to a transaction in which the customer's purchase is 41 made by the use of a device that electronically authorizes the use of 42 the credit card and processes information relating thereto.
