SUMMARY—Revises provisions governing funeral directors, embalmers and operators of cemeteries and crematories. (BDR 54-306)

AN ACT relating to professions; changing the name of the State Board of Funeral Directors, Embalmers and Operators of Cemeteries and Crematories to the Nevada State Funeral Board; removing the limitation concerning the number of consecutive terms of office a member of the Board may serve; authorizing the Board to establish certain fees by regulation; authorizing the Board to issue an order to desist or refrain from engaging in certain unlawful acts; authorizing the Board to order an immediate suspension of a license, permit or certificate under certain circumstances; revising certain provisions relating to disciplinary action; providing penalties; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

30 provides the applicant with merchantable title to the land dedicated.

31 (7) Endowment care trust fund agreement executed by the
32 proper officers of the cemetery authority.

33 (c) A statement, executed by the proper officers of the applicant,
34 setting forth:

35 (1) If the applicant is a corporation, the names and addresses
36 of the board of directors and officers.

37 (2) If the applicant is not a corporation, the names and
38 addresses of the natural persons in charge.

39 (3) The names and addresses of the trustees of the
40 endowment care fund.

41 (4) The name and address of the person in charge of
42 sales.

43 The statement must contain a description of the general character,
44 experience and fitness to engage in the cemetery business for each
45 person named.



1 (d) A complete, detailed and audited financial statement
2 showing assets, liabilities and reserve.

3 (e) An itemized statement of all estimated receipts and
4 expenditures for the succeeding 2-year period or such other period
5 as may be required by the Board.

6 (f) A map of the proposed cemetery in such detail and size as
7 may be required by the Board.

8 (g) A statement of the proposed plan of operation in such detail
9 as may be required by the Board.

10 (h) A statement of the amount deposited in the endowment care
11 fund and the type of investment made of such amount.

12 (i) A statement from the depository showing the deposit in the
13 endowment care fund of the amount required by NRS 452.120 and
14 452.130.

15 (j) Such other information as may be required by written notice
16 from the Board.

17 3. Upon request, the Board shall provide to the Administrator a
18 copy of the following information contained in an application for a
19 certificate of authority filed with the Board pursuant to this section:

20 (a) The endowment care trust fund agreement;

21 (b) The names and addresses of the trustees of the endowment
22 care fund; and

23 (c) The statements described in paragraphs (h) and (i) of
24 subsection 2.

25 **Sec. 61.** NRS 452.590 is hereby amended to read as follows:

26 452.590 1. A person who proposes to purchase or acquire
27 control of an existing cemetery authority, either by purchase of the
28 outstanding capital stock of a cemetery authority or the interest of
29 the owner or owners, and thereby to change the control of the
30 cemetery authority, shall first make application to the Board for a
31 certificate of approval of the proposed change of control in the
32 cemetery authority.

33 2. The application must contain the name and address of the
34 proposed new owners, and the Board may only issue a certificate of
35 approval after it is reasonably satisfied that the proposed new
36 owners are qualified by character, experience and business and
37 financial reputability and responsibility to control and operate the
38 cemetery in a suitable and proper manner, and that the interest of the
39 public generally will not be jeopardized by the proposed change in
40 ownership and management. The Board shall not issue a certificate
41 of approval without the approval of the Administrator.

42 3. The application must be accompanied by a filing and
43 investigation fee of \$250 ~~[, no]~~ *and any other fees related to the*
44 *application. No* part of ~~[which]~~ *the fees* is refundable.

31 Revised Statutes, appropriately change any references to an officer
32 or agency whose name is changed or whose responsibilities have
33 been transferred pursuant to the provisions of this act to refer to the
34 appropriate officer or agency.

35 (b) In preparing supplements to the Nevada Administrative
36 Code, appropriately change any references to an officer or agency
37 whose name is changed or whose responsibilities have been
38 transferred pursuant to the provisions of this act to refer to the

41 Session of the Nevada Legislature to an officer or agency whose
42 name is changed or whose responsibilities have been transferred

45 responsibility is transferred.

TEXT OF REPEALED SECTION

642.065 Regulations relating to funeral directing and establishments. The Board may adopt and enforce reasonable rules and regulations relating to the business of funeral directing, to the sanitary conditions of places where such a business or practice is conducted, with particular regard to plumbing, sewage, ventilation and equipment, and generally to carry out the various provisions of this chapter in the protection of the peace, health, safety, welfare and morals of the public.
