SUMMARY—Revises manner in which public books and other public records of governmental entities may be declared confidential. (BDR 19-790)

AN ACT relating to public records; revising the manner in which public books and other public records of governmental entities may be declared confidential; and providing other matters properly relating thereto.

## THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. NRS 239.010 is hereby amended to read as follows: 2 239.010 1. All public books and other public records of a governmental entity, the contents of which are not otherwise 3 declared by *flaw* state statute to be confidential, must be open at all 4 5 times during office hours to inspection by any person, and may be fully copied or an abstract or memorandum may be prepared from 6 7 those public books and other public records. Any such copies, 8 abstracts or memoranda may be used to supply the general public 0 with copies, abstracts or memoranda of the records or may be used 10 in any other way to the advantage of the governmental entity or of 11 the general public. This section does not supersede or in any manner affect the federal laws governing copyrights or enlarge, diminish or 12 13 affect in any other manner the rights of a person in any written book or record which is copyrighted pursuant to federal law. 14

15 2. A governmental entity may not reject a book or record 16 which is copyrighted solely because it is copyrighted.



1 3. A person may request a copy of a public record in any 2 medium in which the public record is readily available. An officer, 3 employee or agent of a governmental entity who has custody of a 4 public record shall not refuse to provide a copy of that public record 5 in a readily available medium because he has already prepared or 6 would prefer to provide the copy in a different medium.

**Sec. 2.** NRS 239.013 is hereby amended to read as follows:

8 239.013 Any records of a public library or other library which 9 contain the identity of a user and the books, documents, films, 10 recordings or other property of the library which he used are confidential and not public books or other public records within the 11 meaning of NRS 239.010. Such records may be disclosed only in 12 13 response to an order issued by a court upon a finding that the 14 disclosure of such records is necessary to protect the public safety or 15 to prosecute a crime.

16 **Sec. 3.** Any administrative regulations adopted before 17 October 1, 2003, which declare public books or other public records 18 confidential pursuant to NRS 239.010 are hereby declared void. In 19 preparing the supplements to the Nevada Administrative Code on or 20 after October 1, 2003, the Legislative Counsel shall remove any 21 such administrative regulations.
