SENATE JOINT RESOLUTION—Urging Congress to take certain
actions concerning wilderness areas and wilderness study
areas.

1 WHEREAS, The provisions of 16 U.S.C. §§ 1131 et seq.,
2 commonly referred to as the Wilderness Act, establish the National
3 Wilderness Preservation System, which consists of areas of federal
4 public land that are designated by Congress as wilderness areas; and

5 WHEREAS, Congress has designated approximately 2 million
6 acres of certain federal public lands in Nevada as wilderness areas;
7 and

8 WHEREAS, If an area of federal public land is designated as a
9 wilderness area, it must be managed in a manner that preserves the
10 wilderness character of the area and ensures that the area remains
11 unimpaired for future use and enjoyment as a wilderness area; and

12 WHEREAS, In conjunction with the provisions of the Wilderness
13 Act, the Bureau of Land Management of the Department of the
14 Interior in the late 1970s conducted an initial inventory of
15 approximately 49 million acres of federal public lands in Nevada to
16 determine the suitability of such lands for designation as wilderness

1 areas or identification as wilderness study areas and, in 1980,
2 recommended that approximately 5.1 million acres of those lands be
3 identified as wilderness study areas; and

4 WHEREAS, Until a wilderness study area is designated by
5 Congress as a wilderness area or released for multiple use, the
6 wilderness study area must be managed in a manner that does not
7 impair its suitability for preservation as a wilderness area; and

8 WHEREAS, In 1991, the Bureau of Land Management
9 recommended that Congress designate as wilderness areas
10 approximately 1.9 million acres of the 5.1 million acres of
11 wilderness study areas in Nevada and release the remainder of the
12 wilderness study areas for multiple use; and

13 WHEREAS, Although Congress recently enacted the Clark
14 County Conservation of Public Land and Natural Resources Act of
15 2002, Public Law 107-282 (2002), which released approximately
16 224,000 acres in Clark County from its current status as wilderness
17 study areas, the recommendations made by the Bureau of Land
18 Management in 1991 have largely not been acted upon by Congress,
19 and the Bureau continues to manage approximately 3.86 million
20 acres of federal public lands in Nevada identified as wilderness
21 study areas; and

22 WHEREAS, It is important that decisions concerning whether to
23 designate wilderness study areas as wilderness areas or release those
24 areas for multiple use are made in a timely manner without any
25 unnecessary delays as the identification of federal public lands as
26 wilderness study areas imposes significant restrictions on the
27 management and use of those lands; and

28 WHEREAS, It is also important to protect the ecological health
29 and existing and potential economic and recreational benefits of
30 wilderness areas and wilderness study areas in this state by using
31 reasonable and effective methods of fire suppression in those areas;
32 and

33 WHEREAS, Because a considerable amount of federal public
34 land in Nevada has been designated as wilderness areas and
35 approximately 8 percent of the federal public land in Nevada that is
36 managed by the Bureau of Land Management has been identified as
37 wilderness study areas and because such designation or
38 identification imposes significant restrictions concerning the
39 management and use of such land, including land used for mining,
40 ranching and recreation, the Legislative Commission appointed a
41 subcommittee in 2001 to conduct an interim study of wilderness
42 areas and wilderness study areas in this state; and

43 WHEREAS, During the 2001-2002 legislative interim, the
44 subcommittee met several times throughout this state and facilitated
45 important and wide-ranging discussions among many agencies,



1 organizations and persons with diverse interests, perspectives and
2 expertise concerning wilderness areas and wilderness study areas;
3 and

4 WHEREAS, The subcommittee received a great deal of valuable
5 input from those agencies, organizations and persons, including
6 many valuable recommendations for Congress to consider in
7 addressing the issues concerning wilderness areas and wilderness
8 study areas in a responsible, reasonable and fair manner; now,
9 therefore, be it

10 RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF
11 NEVADA, JOINTLY, That the members of the Nevada Legislature
12 urge Congress to:

13 1. Support efforts to ensure that adequate access to wilderness
14 areas and wilderness study areas is afforded to the appropriate
15 agencies and persons so that those agencies and persons may
16 effectively combat fires in wilderness areas and wilderness study
17 areas;

18 2. Support the use of all reasonable and effective fire
19 suppression efforts in wilderness areas and wilderness study areas
20 without strictly confining such efforts only to the tools determined
21 by the federal agencies which manage federal public lands to be the
22 minimum tools necessary;

23 3. Accept the recommendation of the Bureau of Land
24 Management to designate 1.9 million acres of certain wilderness
25 study areas in Nevada as wilderness areas while also incorporating
26 in the designation process flexibility to consider relevant
27 information such as growth to ensure the establishment of
28 appropriate boundaries for those areas and recognizing that such
29 consideration may result in a reasonable adjustment of those
30 boundaries;

31 4. Oppose any efforts to conduct another inventory of the
32 federal public lands in Nevada for purposes of creating wilderness
33 areas or wilderness study areas;

34 5. Ensure that more current information is considered before
35 acting on the recommendations of the Bureau of Land Management
36 concerning the designation of wilderness areas in Nevada as the
37 surveys of the Bureau were performed with limited time, resources
38 and technology; and

39 6. Avoid any unnecessary delays in releasing wilderness study
40 areas for multiple use by establishing a plan for addressing the
41 release of wilderness study areas in a timely manner that includes a
42 schedule or plan for the timely consideration of important issues
43 concerning wilderness study areas; and be it further

44 RESOLVED, That the Secretary of the Senate prepare and
45 transmit a copy of this resolution to the Vice President of the United



1 States as the presiding officer of the Senate, the Speaker of the
2 House of Representatives and each member of the Nevada
3 Congressional Delegation; and be it further
4 RESOLVED, That this resolution becomes effective upon
5 passage.
