BDR32-776 Repeals the Business License Fee and the Modified Business Tax - General Business and Financial Institution components; and reinstates the Business Tax. See attached spreadsheet for fiscal impact. This bill draft request results in a revenue loss to the State general fund. Revenue amounts were calculated using Economic Forums projections; Business Tax projections were calculated by using the same percentage increase applied to MBT projected revenues by the Economic Forum. Included is an estimate for the cost to notify approximately 343,000 accounts of the statute changes. Costs associated with programming and development changes for the Unified Tax System is estimated at 5,000 hours X \$170 per hour. There would be no reduction to resources for the FY06 & FY07 biennium. To repeal these taxes and reinstate the Business Tax will require all resources to be in place to handle the collection issues, delinquencies, and audits that will be performed for the period of time the repealed taxes were in affect. Activity on these taxes can continue from 3 to 8 years by current statute. In addition, this would require a major revamping of the new UTS system at a significant cost to the agency.
