First of all, I want to introduce the individual guest sitting at my desk, Jim Bennett, the former chief of the clans here for the Society for Scottish Clans. He is also the gentleman who, when I did my student teaching, had to put up with me. I have a very careful and close kinship with him. He also taught across the hall from me for many years. Secondly, coming up on April 6 is Tartan Day. The current chief of the Nevada Society for Scottish Clans, Chester Buchanan, is sitting with Ms. Angle. Other dignitaries here from the Scottish American Military Society are Kevin Welsh, who some of you may recognize, Bill Glenn, and Chuck McCloud.

Tartan Day – April 6, Local, National, and International, By Chester Buchanan:

Tartan Day was conceived by the U.S. Senate in 1998 in recognition of the valuable contributions of Scots and Americans of Scottish descent to the foundation and development of the United States. The date was selected to commemorate April 6, 1320, when Scottish nobles and barons signed the *Declaration of Arbroath*, declaring to Pope John XXII that Scotland was a sovereign nation and not under the rule of England. Also, it was the first document to put forth the concept of a "contractual monarchy," which meant that they would force Robert the Bruce out if he attempted to sell

Scotland to England. The declaration, like our *Declaration of Independence*, is seen by many as the founding document of the Scottish nation. The following extract from the declaration (translation from 14th century Latin) that is often quoted has great appeal not only to Americans, but to people throughout the world. "It is in truth not for glory, nor riches, nor honours that we are fighting, but for freedom – for that alone, which no honest man gives up but with life itself."

I would ask you to welcome the members of the Society for Scottish Clans in Nevada, and remember their Tartan Day, April 6.
