MOTIONS, RESOLUTIONS AND NOTICES

By Senators Coffin, Amodei, Titus, Mathews; Assemblymen McClain and Sherer:

Senate Joint Resolution No. 4—Proposing to amend the Nevada Constitution to limit the allowable causes for the recall of an elected public officer to misdemeanor or malfeasance in office.

Legislative Counsel's Digest:

The Nevada Constitution currently provides a procedure for the people to recall an elected public officer for any reason. (Nev. Const., Art. 2, \S 9)

This bill proposes to amend the Nevada Constitution to limit the reasons for which an elected public officer may be recalled to misdemeanor or malfeasance in office, the same grounds for which certain officers are subject to impeachment pursuant to Section 2 of Article 7 of the Nevada Constitution. This bill also requires the petition for recall to include factual support for each allegation of misdemeanor or malfeasance in office.

RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF NEVADA, JOINTLY, That Section 9 of Article 2 of the Nevada Constitution be amended to read as follows:

Sec. 9. Every public officer in the State of Nevada is subject, as herein provided, to recall from office for misdemeanor or malfeasance in office by the registered voters of the state, or of the county, district, or municipality which he represents. For this purpose, not less than twenty-five percent (25%) of the number who actually voted in the state or in the county, district, or municipality which he represents, at the election in which he was elected, shall file their petition, in the manner herein provided, demanding his recall by the people. They shall set forth in said petition, in not exceeding two hundred (200) words, the reasons why said recall is demanded [...], including factual support for each allegation of misdemeanor or malfeasance in office. If he shall offer his resignation, it shall be accepted and take effect on the day it is offered, and the vacancy thereby caused shall be filled in the manner provided by law. If he shall not resign within five (5) days after the petition is filed, a special election shall be ordered to be held within thirty (30) days after the issuance of the call therefor, in the state, or county, district, or municipality electing said officer, to determine whether the people will recall said officer. On the ballot at said election shall be printed verbatim as set forth in the recall petition, the reasons for demanding the recall of said officer, and in not more than two hundred (200) words, the officer's justification of his course in office. He shall continue to perform the duties of his office until the result of said election shall be finally declared. Other candidates for the office may be nominated to be voted for at said special election. The candidate who shall receive the highest number of votes at said special election shall be deemed elected for the remainder of the term, whether it be the person against whom the recall petition was filed, or another. The recall petition shall be filed with the officer with whom the petition for nomination to such office shall be filed, and the same officer shall order the special election when it is required. No such petition shall be circulated or filed against any officer until he has actually held his office six (6) months, save and except that it may be filed against a senator or assemblyman in the legislature at any time after ten (10) days from the beginning of the first session after his election. After one such petition and special election, no further recall petition shall be filed against the same officer during the term for which he was elected, unless such further petitioners shall pay into the public treasury from which the expenses of said special election have been paid, the whole amount paid out of said public treasury as expenses for the preceding special election. Such additional legislation as may aid the operation of this section shall be provided by law.

Amend the bill as a whole by deleting sec. 2 and the leadlines of repealed sections and adding a new section designated sec. 2, following section 1, to read as follows:

- "Sec. 2. Chapter 705 of NRS is hereby amended by adding thereto a new section to read as follows:
- 1. The provisions of this chapter do not apply to an individual, company or corporation operating a railroad in this State to the extent that such a provision is:
- (a) Preempted, either expressly or by implication, by a federal law or an administrative regulation, rule, decision, opinion or order having the force of a federal law: or
- (b) Declared to be preempted by a court of competent jurisdiction interpreting a federal law or an administrative regulation, rule, decision, opinion or order having the force of a federal law.
- 2. If a provision of this chapter is preempted, the provision is suspended and must not be enforced against the individual, company or corporation operating the railroad only for the period during which the preemption is valid and effective.
- 3. This section is intended only to codify the rules of construction applicable to the federal doctrine of preemption and must not be interpreted in a manner that is inconsistent with those rules.".

Amend the title of the bill by deleting the second line and inserting: "violations involving certain pipelines; clarifying the application of certain".

REMARKS FROM THE FLOOR

Senator Raggio requested that his remarks be entered in the Journal.

It is fitting today as we celebrate Presidents' Day for us to pause in reflection to honor our past Presidents. We used to celebrate Washington's birthday on February 22 and Lincoln's birthday on February 12, but we have gotten away from that and now honor all Presidents on this day—each of us has our favorites.

In the recent months, I have had occasion to read many of the presidential biographies. Many are well known, such as Washington, Jefferson, Adams, Reagan and Clinton. The lives of all the Presidents are interesting. I grew up thinking that Franklin D. Roosevelt was supposed to be President forever since he was elected to four terms.

Today, we look back on this day and think of their sacrifices. We think of it as a privilege to serve as President which it is. It is the highest honor to achieve in this Country. I find it a shame that we cannot get over the elections a little quicker, but for whoever is elected, it is a tremendous responsibility to maintain this Nation as a republic. Benjamin Franklin was asked what type of a government he provided at the Constitutional Convention. He stated, "A republic if you can keep it."

For over two centuries, we have maintained that, not always as the most-liked nation in the world but certainly as the most-republican, the most-democratic, the most-free country in the world. We may have some faults, but our success is owed to the leadership we have had for the past two centuries.

Today, we should reflect on the sacrifices, the responsibilities and the accomplishments of each of the Presidents who have served this Nation.
