Amend sec. 5, page 6, by deleting lines 28 through 42 and inserting:

"4. The Board shall not, on or after July 1, 2006, issue any additional temporary licenses to practice dentistry pursuant to this section.

5. Any person who, on July 1, 2006, holds a temporary license".

Amend sec. 5, page 7, by deleting lines 4 through 18.

Amend sec. 6, page 8, by deleting lines 11 through 25 and inserting:

"4. The Board shall not, on or after July 1, 2006, issue any additional temporary licenses to practice dentistry pursuant to this section.

5. Any person who, on July 1, 2006, holds a temporary license".

Amend sec. 6, pages 8 and 9, by deleting lines 32 through 44 on page 8 and lines 1 and 2 on page 9.
