"AN ACT relating to residential contractors; revising provisions governing the Recovery Fund administered by the State Contractors' Board; increasing the maximum amounts that the Board may pay from the Recovery Fund for individual claims and for multiple claims made against a single contractor; providing for retroactive application with regard to certain claims; and providing other matters properly relating thereto."

## GENERAL FILE AND THIRD READING

Senator Hardy requested that his remarks be entered in the Journal.

Senate Bill No. 18 expands A.B. No. 198 of the Sixty-sixth Legislative Session grant program. The grant program was created by the 1991 Legislature and has been very effective in helping small water districts meet the Federal Safe Drinking Water Act. Unfortunately, one of the limitations to that is that it did not allow individual well owners to participate in receiving those grants should they find that their wells will not meet the minimum federal requirements.

This bill expands the availability of that grant to those people. The grant money can be used to assist them.

Several of my colleagues in this body had a concern about whether there was anything in this legislation that would compel individual well owners to hook up to municipal water systems. We have checked with every attorney we can find, and all have assured us there is nothing in this legislation that would compel them in this manner. It may give incentive to some individual well owners to apply for grant money to pay for it if they cannot afford it. To do so, it would be at the initiative of the individual well owner exclusively. There is nothing in this legislation that would compel an individual well owner to hook up to a municipal-water facility.
