- <u>SENATE BILL 10</u>: Limiting to certain counties right of state residents to petition board of county commissioners concerning use of public roads. (BDR 35-332)
- **SENATE BILL 12**: Creates Motor Carrier Division within Department of Motor Vehicles. (BDR 43-610)
- **SENATE BILL 13**: Revises provisions governing authority of peace officers to make arrests for certain offenses. (BDR 43-363)
- **SENATE BILL 14**: Revises provisions relating to certain special license plates. (BDR 43-322)
- **SENATE BILL 33**: Authorizes Director of Department of Motor Vehicles to enter into agreements for certain placements of advertisements. (BDR 43-396)
- <u>SENATE BILL 34</u>: Increases fees for issuance and renewal of noncommercial drivers' licenses. (BDR 43-241)
