SUMMARY—Increases fees for issuance and renewal of noncommercial drivers' licenses. (BDR 43-241)

AN ACT relating to drivers' licenses; increasing the fees for the issuance and renewal of noncommercial drivers' licenses; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Existing law imposes fees of \$14.50 for an original or renewal of a driver's
2 license issued to a person 65 years of age or older and \$19.50 for an original or
3 renewal of a driver's license issued to any other person. (NRS 483.410, 483.415)
4 The revenue from the fees must be deposited in the Motor Vehicle Fund to be used
5 to construct, maintain and repair the public highways in this State. (NRS 483.410,
6 Nev. Const. Art. 9, § 5)
7 This bill would increase the fee for the issuance or renewal of a driver's license
8 by 50 cents.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 9 **Section 1.** NRS 483.410 is hereby amended to read as follows:
10 483.410 1. Except as otherwise provided in subsection 6, for
11 every driver's license, including a motorcycle driver's license,
12 issued and service performed, the following fees must be charged:

14 [A] **An original or renewal** license issued to a person
15 65 years of age or older.....[\$14] **\$14.50**

15 2. For every motorcycle endorsement to a driver's license, a
16 fee of \$5 must be charged.

17 3. If no other change is requested or required, the Department
18 shall not charge a fee to convert the number of a license from the
19 licensee's social security number, or a number that was formulated
20 by using the licensee's social security number as a basis for the
21 number, to a unique number that is not based on the licensee's social
22 security number.

23 4. The increase in fees authorized by NRS 483.347 and the fees
24 charged pursuant to NRS 483.383 and 483.415 must be paid in
25 addition to the fees charged pursuant to subsections 1 and 2.

26 5. A penalty of \$10 must be paid by each person renewing his
27 license after it has expired for a period of 30 days or more as
28 provided in NRS 483.386 unless he is exempt pursuant to that
29 section.

30 6. The Department may not charge a fee for the reinstatement
31 of a driver's license that has been:

- 32 (a) Voluntarily surrendered for medical reasons; or
- 33 (b) Cancelled pursuant to NRS 483.310.

34 7. All fees and penalties are payable to the Administrator at the
35 time a license or a renewal license is issued.

36 8. Except as otherwise provided in NRS 483.340, 483.415 and
37 483.840, all money collected by the Department pursuant to this
38 chapter must be deposited in the State Treasury for credit to the
39 Motor Vehicle Fund.

40 **Sec. 2.** This act becomes effective upon passage and approval.
