SUMMARY—Makes various changes relating to certain facilities that are engaged in scientific, medical or educational research. (BDR 50-56)

AN ACT relating to animals; requiring research facilities and product testing facilities to offer certain dogs and cats to an animal shelter or rescue organization for adoption before euthanizing or destroying the dog or cat; limiting the length of time that a research facility or product testing facility may conduct research on a dog or cat; and providing other matters properly relating thereto. THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** Chapter 574 of NRS is hereby amended by adding
- 2 thereto a new section to read as follows:
- 3 1. Except as otherwise provided in subsection 2, a research
- 4 facility or product testing facility that intends to euthanize or
- 5-destroy a dog or cat for any purpose other than scientific, medical
- 6 or educational research shall, before euthanizing or destroying the
- 7 dog or cat, effer make the dog or cat available to an employee of the facility, or a local to an animal shelter or rescue
- 8 organization for adoption. A research facility or product testing
- 9 facility may enter into a collaborative agreement with an animal
- 10 shelter or rescue organization for the purpose of carrying out the
- 11 provisions of this subsection.
- 12 2. A research facility or product testing facility is not required
- 13 to offer a dog or cat to an animal shelter or rescue organization
- 14 pursuant to subsection 1 if the dog or cat:
- 15 (a) Manifests a behavioral or temperamental defect that poses
- 16 a risk to the health and safety of the public;
- 17 (b) Manifests symptoms of a disease, injury or congenital or
- 18 hereditary condition that adversely affects, or is likely to adversely
- 19 affect, the health of the dog or cat; or
- 20 (c) Is a newborn dog or cat in need of maternal care and has
- 21 been impounded by the research facility or product testing facility
- 22 without its mother.
- 23 3. A research facility or product testing facility shall not
- 24 conduct research on any dog or cat for a period of more than 2
- 25 years., unless a medical device has been surgically implanted into the animal's body which requires long-term monitoring, or continued testing is necessary in order to reach a conclusion.
- 26 4. As used in this section:
- 27 (a) "Animal shelter or rescue organization" means a nonprofit
- 28 organization established for the purpose of rescuing animals in
- 29 need and finding permanent, adoptive homes for such animals.
- 30 (b) "Institution of higher education" has the meaning ascribed
- 31 to it in NRS 385.102.
- 32 (c) "Product testing facility" means a facility that:

- 33 (1) Is privately owned or funded; or
- 34 (2) Receives public funding, including, without limitation,
- 35 any subsidy, grant or tax exemption, either directly or indirectly,
- 36 through collaboration with an institution of higher education,

- 4 (d) "Research facility" means:
- 5 (1) A department, branch or other subsidiary of an

- 7 (2) A facility that receives public funding, including,

- 14 574.050 As used in NRS 574.050 to 574.200, inclusive [:],

- 18 2. "First responder" means a person who has successfully
- 19 completed the national standard course for first responders.
- 20 3. "Police animal" means an animal which is owned or used by

- 22 officer in performing his or her duties as a peace officer.
- 23 4. "Torture" or "cruelty" includes every act, omission or
- 24 neglect, whereby unjustifiable physical pain, suffering or death is 25 caused or permitted.
- 26 **Sec. 3.** NRS 574.200 is hereby amended to read as follows:
- 27 574.200 The provisions of NRS 574.050 to 574.510, inclusive,
- 28 and section 1 of this act do not:
- 29 1. Interfere with any of the fish and game laws contained in
- 30 title 45 of NRS or any laws for the destruction of certain birds.
- 31 2. Interfere with the right to destroy any venomous reptiles or
- 32 animals, or any animal known as dangerous to life, limb or property.
- 33 3. Interfere with the right to kill all animals and fowl used for 34 food.
- 35 4. Prohibit or interfere with any properly conducted scientific
- 36 experiments or investigations which are performed under the
- 37 authority of the faculty of some regularly incorporated medical

- 38 college or university of this State.
 39 5. Interfere with any scientific or physiological experiments
 40 conducted or prosecuted for the advancement of science or
- 41 medicine.
