AN ACT making an appropriation to the Department of Public Safety for the replacement of dispatch center consoles and portable hand-held radios; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State Highway Fund to the
2 Department of Public Safety the sum of ***\$81,329,123*** ***\$1,218,872*** for the
3 replacement of dispatch center consoles and portable hand-held radios.

4 **Sec. 2.** Any remaining balance of the appropriation made by section 1 of this
5 act must not be committed for expenditure after June 30, 2019, by the entity to
6 which the appropriation is made or any entity to which money from the
7 appropriation is granted or otherwise transferred in any manner, and any portion of
8 the appropriated money remaining must not be spent for any purpose after
9 September 20, 2019, by either the entity to which the money was appropriated or
10 the entity to which the money was subsequently granted or transferred, and must be
11 reverted to the State Highway Fund on or before September 20, 2019.

12 **Sec. 3.** This act becomes effective ***on July 1, 2017, upon passage and***
13 **approval.**
