Senate Bill 286 (2nd Reprint): Revises provisions governing the regulation of applied behavior analysis. (BDR 39-633)

Mike Morton, Committee Counsel:

<u>Senate Bill 286 (2nd Reprint)</u> creates the Board of Applied Behavior Analysis, and transfers the duties of licensing and regulating behavior analysts and assistant behavior analysts from the Board of Psychological Examiners to the Board of Applied Behavior Analysis. The bill also replaces the term "autism behavior interventionist" with "registered behavior technician," and further revises the requirements for licensure or certification.

There is one proposed amendment from Senator Gansert, which removes the Administrator of the Aging and Disability Services Division as a member of the Board of Applied Behavior Analysis and adds an additional licensed behavior analyst to the Board. The amendment also adds two additional exemptions to licensure.
