## **PROCLAMATION**

WHEREAS, Many Nevada families have strong traditions of legislative service extending across several generations; and

WHEREAS, Many past and present members of Nevada's Assembly and Senate were encouraged to serve in the Legislature by the example of a mother, a father, a grandfather, an aunt, an uncle, a father-in-law, or a sibling; and

WHEREAS, Gilman N. Folsom and son Frank Gilman Folsom served together in the 1891 and 1893 Sessions of the Legislature, one in the Senate and the other in the Assembly; and

WHEREAS, Spouses have sometimes succeeded one another in legislative office, as when Fronica E. Castle succeeded her husband Douglas A. Castle, when Frances G. Friedhoff succeeded her husband George W. Friedhoff, or when Dawn Gibbons filled in while her husband Jim Gibbons was on active military duty during Operation Desert Storm and was later elected in her own right; and

WHEREAS, Not since Assemblyman Willard W. Smith of Lincoln County married Assemblywoman Florence B. Swasey of Nye County at the end of the 1925 Session have a husband and wife both held legislative office at the same time; and

WHEREAS, This session Assemblywoman Alexis Hansen and Senator Ira Hansen, business owners from Washoe County who have been married for 38 years, are joined in the Nevada Legislature, marking the first time that a husband and wife have been elected to serve in the same session: now. therefore, be it
