Assembly Concurrent Resolution No. 3—Memorializing former Assemblyman Bob Price.

WHEREAS, The members of the Nevada Legislature note with sadness the passing on January 4, 2019, of former Assemblyman Robert E. Price, one of the longest serving Assemblymen in this State; and

WHEREAS, Bob Price was born in 1936 in DeLand, Florida, and after attending community colleges in California and Nevada, became an electrician through the International Brotherhood of Electrical Workers Apprenticeship Program; and

WHEREAS, Assemblyman Price proudly served his North Las Vegas constituents in the Nevada Assembly for a total of 28 years, in 14 regular and 5 special sessions between 1974 and 2002, serving as Chairman on the Assembly Committees on Taxation, Constitutional Amendments, Economic Development and Tourism and Transportation, Vice Chairman of the Legislative Commission and as a member of the Assembly Committee on Government Affairs and the Interim Finance Committee: and

WHEREAS, In 1979, Assemblyman Price served as one of the architects of the Sales and Use Tax Act, removing the tax on food, and in 1991, Assemblyman Price sponsored Assembly Bill No. 4 which provided Nevada's citizens greater transparency into lobbying activities and expenditures; and

WHEREAS, In 1996, Governor Bob Miller designated State Highway 375 as the "Extraterrestrial Highway," an idea to promote tourism in one of Nevada's most remote areas which was formulated by Assemblyman Price 1 year earlier; and

WHEREAS, Outside of the Legislature, Bob Price remained a loyal advocate by serving on multiple state boards and commissions, including Governor Robert List's Family Policy Committee, the State Health Coordinating Council, Nevada's 125-Year Celebration Committee, and the Nevada Committee on the Bicentennial of the United States Constitution and was long active in the National Conference of State Legislatures; and

WHEREAS, Bob Price was honored for his tireless work in 2007 when the Robert E. "Bob" Price Recreation Center in North Las Vegas was dedicated in his name; and

WHEREAS, Bob Price was an avid country music fan and in the 1950's had his own television show called "Bob Price and the Gambling Ranch Hands" and was known to serenade the Assembly with Hank Williams tunes at the end of every session; and

WHEREAS, The man who was said to be the prime example of a citizen legislator, whose kindness and sense of humor is fondly remembered and whose wish was to be remembered as one who simply tried to do his best to help; now, therefore, be it

RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE SENATE CONCURRING, That the members of the 80th Session of the Nevada Legislature hereby extend their deepest condolences to Assemblyman Price's wife, Nancy, daughters, Theresa, Amber and Cherie, sons, William, David and Tom; and be it further

Remarks by Assemblymen Thompson, Daly, Spiegel, and Mr. Speaker.

Mr. Speaker requested that the following remarks be entered in the Journal.

ASSEMBLYMAN THOMPSON:

I rise today to say a few words in remembrance of a colleague, a friend, a brother, and a fellow North Las Vegan, Assemblyman Bob Price. Robert E. Price Jr. was born in DeLand, Florida, on May 23, 1936. At the age of 19, he made his way to the great state of Nevada that was to be his home for 64 years. For 28 of those years, he served in the Nevada State Assembly. In the history of the Nevada Legislature, only 11 people have held office that long.

Here in the West, we sometimes use the word "maverick." A maverick is an unbranded range animal, a calf or a yearling, that somehow escapes the branding iron and therefore does not belong to any herd, and is not marked as anyone's property.

The word maverick is a good descriptor for Bob Price. He was one of those rarest of creatures, an unclassifiable politician. He could not be pegged as either liberal or conservative. At various times he took positions that might fall on the other side of that line. He just called it as he saw it.

Bob Price described himself as a student of the *Constitution*, and he was an avid defender of the First Amendment. He staunchly opposed a constitutional amendment to make it a crime to burn the flag. He also opposed calls for a constitutional convention. In the 1970s, he was an enthusiastic advocate for the Equal Rights Amendment. On the other hand, he sometimes angered

his female colleagues by making a motion that his remarks be entered into the Ladies' Home Journal.

Bob Price loved the theatrical side of politics. He had a flare for the dramatic and a taste for the whimsical. He is the father of the Extraterrestrial Highway. He showed up in Rachel, Nevada, at the dedication of the highway, dressed as Darth Vader. He decorated his office with wispy grey figures of space aliens with big eyes and blank faces. He could be funny and amusing, or sometimes infuriating, but he was never dull or conventional.

Assemblyman Price was a fearless advocate for what he believed to be right and had no regard for how it would play in the press. He was utterly deaf to the siren song of political expediency.

Those of us who were fortunate enough to know Bob Price will remember him as gregarious and friendly. He was everybody's friend. He had no pretentiousness; he was disarmingly humble and open. He never held a grudge and it was impossible to hold a grudge against him.

Henry David Thoreau once said, "If a man does not keep pace with his companions, perhaps it is because he hears a different drummer. Let him step to the music which he hears, however measured or far away." Bob Price took that advice to heart. He always marched to the beat of his own drum

I am convinced that when the roll is called in that great legislative chamber in the sky, Robert E. Price Jr. will be among those chosen few to answer, present.

ASSEMBLYMAN DALY:

I rise to pay tribute to Bob Price. Although I did not serve with the Assemblyman when he was here, I did know him in some of my lobbying days before that. I got to know Bob a little bit after he had left the Assembly. He actually moved to northern Nevada and lived in downtown Sparks, in Assembly District 30. I would see Bob at every single event there was, whether it was the Democratic Party, Cesar Chavez events, or AFL-CIO events.

As was said in the resolution, Bob was a member of the IBEW, International Brotherhood of Electrical Workers, Local 357 out of Las Vegas for his entire life. He was always an advocate for working people, obviously working women, and he wanted to make sure everyone got a fair shake. I have heard stories about how Bob used to play guitar on the floor during the proverbial one-minute recess—some of the freshmen will get to experience that a little bit later. I do not know about the guitar playing, but you will know what I mean about the one-minute recess. One time there was some labor issue they were getting ready and he would come onto the floor, and he had on a button that said "Union Yes." If it was not eight inches in diameter, it was not an inch. Huge button, Union Yes, he was not afraid. That is just one story.

He always gave me encouragement every time he saw me at one of those events—we were at a lot of the same things. He always gave me encouragement about fighting the good fight as we engage in our process—I will not call it a battle. He was always trying to make sure that he was putting in his two cents and trying to pass on the wisdom that he had.

ASSEMBLYWOMAN SPIEGEL:

I did not serve with Assemblyman Price, but one thing that has meant a lot to me through the years, and a lesson that he taught me, is the lesson of staying engaged and the lesson of love that this Chamber represents. Oftentimes our former colleague from Assembly District 11, who is now in the Senate, would have both Assemblyman Price and his lovely wife Nancy as his guest, whether it was for Old Timer's Day or other special days that we had. Because I sat right nearby, I would always have the opportunity to say hello and talk for a few minutes. Assemblyman Price and Mrs. Price just had the spirit of Nevada and always carried it with them. They taught me that we should always be mindful of the spirit of Nevada and be looking out for the whole state. I really appreciate that and will always remember that. Thank you very much.

Mr. Speaker requested the privilege of the Chair for the purpose of making the following remarks.

As a point of personal privilege, I would like to acknowledge that I feel like I did serve with Assemblyman Price. I got to know the family when I served as Student Body President at UNR. Then-Regent Price showed us an example, along with Assemblyman Price, of a family committed to public service over the years. Even as recently as last year, they were attending events. I also

wanted to point out something that always resonates with me, and that is the example that they set as a married couple and their love for each other. I am pleased that we are honoring Assemblyman Price here today.

Resolution adopted unanimously.

Assemblywoman Benitez-Thompson moved that all rules be suspended and that Assembly Concurrent Resolution No. 3 be immediately transmitted to the Senate.

INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 137—AN ACT relating to elections; authorizing an elector to register to vote or update voter registration information during the period for early voting and on the day of certain elections and setting forth the requirements for such registration or update; revising certain provisions related to establishing polling places within the boundaries of Indian reservations and Indian colonies; revising certain provisions relating to voting after the time that polls close; requiring a provisional ballot to include all offices, candidates and measures upon which the person casting the provisional ballot would be entitled to vote if he or she were casting a regular ballot; extending the period for early voting in certain counties and cities; and providing other matters properly relating thereto.

Assembly Bill No. 141—AN ACT relating to pharmacy benefit managers; prohibiting a pharmacy benefit manager from imposing certain limitations on the conduct of a pharmacist or pharmacy; and providing other matters properly relating thereto.

Assemblywoman Hardy moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 143—AN ACT relating to the Capitol Police Division of the Department of Public Safety; requiring the Director of the Department of Public Safety to treat peace officers appointed to the Capitol Police Division of the Department in the same manner as peace officers appointed to the Nevada Highway Patrol Division of the Department for the purposes of classification, compensation and advancement; and providing other matters properly relating thereto.

Assemblywoman Jauregui moved that the bill be referred to the Committee on Government Affairs.

By Assemblymen Jauregui, Carrillo, Duran, Flores, Martinez and Torres; Senator Denis:

Assembly Bill No. 144—AN ACT relating to taxes on retail sales; requiring the submission to the voters of the question whether the Sales and Use Tax Act of 1955 should be amended to provide an exemption from the tax for diapers; providing for the exemptions from certain analogous taxes if the voters approve this amendment to the Sales and Use Tax Act of 1955; and providing other matters properly relating thereto.

Assemblywoman Jauregui moved that the bill be referred to the Committee on Taxation.

Assembly Bill No. 145—AN ACT relating to schools; requiring the board of trustees of a school district to ensure a school police officer or person who provides police services is located in each middle school, junior high school and high school; requiring the Department of Education to provide a gate or similar device that controls access to a school upon the request of the principal; and providing other matters properly relating thereto.

Assemblywoman Miller moved that the bill be referred to the Committee on Education.

Assembly Bill No. 146—AN ACT relating to governmental administration; creating the Nevada Office of the Inspector General; setting forth the powers and duties of the Inspector General and employees of the Office; requiring a state agency or local government to cooperate with and provide assistance to the Inspector General in carrying out those duties; prohibiting retaliation against certain persons who make a lawful complaint concerning fraud, waste, abuse or corruption in a state agency or local government; prohibiting certain acts to deter or prevent the Inspector General or the employees of the Office from performing his or her duty; imposing increased penalties for certain acts of assault or battery of the Inspector General or an employee of the Office; providing penalties; and providing other matters properly relating thereto.

Assemblywoman Miller moved that the bill be referred to the Committee on Government Affairs.

Motion carried.
