## PROCLAMATION

WHEREAS, Women have helped shape events in our nation since before its inception, and while not always recognized in the history books, their hard-fought achievements have enriched all aspects of human endeavor; and WHEREAS, The United States Congress passed laws between 1981 and 1986 designating a week in March as "Women's History Week" to recognize and commemorate the contributions of women; and

WHEREAS, In 1987, Congress passed Public Law 100-9 designating March 1987 as "Women's History Month" and authorizing the President to issue a proclamation in observance of this event; and

WHEREAS, Between 1988 and 1994, Congress passed additional laws to this effect, and since 1995, Presidents of the United States have issued a series of annual proclamations designating the month of March as "Women's History Month" and highlighting contributions by women to American history in a variety of fields; and

WHEREAS, The list of extraordinary women honored in presidential proclamations includes notables in civil rights, entrepreneurship, government, journalism, literature and the arts, military service, and science and technology; and

WHEREAS, Women in Nevada have contributed mightily to our state's establishment and progress through efforts sung and unsung, working hard wherever life took them—on ranches, in mining communities, and in cities; in classrooms, concert halls, and courtrooms; and in labor unions, businesses, and elective office; and

WHEREAS, Nevada women made history this year, when the Nevada Legislature convened on February 4, 2019, after swearing in members who comprised the first female majority of any state legislature in the history of the United States; now, therefore, be it

PROCLAIMED, That we call upon Nevadans to join in celebrating March 2019 as "Women's History Month"; and be it further

PROCLAIMED, That we proudly recognize the struggles and victories of the women who have cleared the path today's women will walk.
