#### INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 240—AN ACT relating to regional planning; requiring representatives from certain counties to meet jointly for a specified period to identify issues and make recommendations regarding the orderly management of growth in their region; requiring such counties to prepare certain reports individually and jointly during that period; and providing other matters properly relating thereto.

GENERAL FILE AND THIRD READING

Assembly Bill No. 37. Bill read third time. Remarks by Assemblymen Hafen and Edwards.

#### ASSEMBLYMAN HAFEN:

Assembly Bill 37 eliminates the right of a serviceman or woman to demand a trial by court-martial instead of accepting a nonjudicial punishment. The bill also requires that a commanding officer considering imposing nonjudicial punishment consult with a judge advocate in determining whether nonjudicial punishment is appropriate, and authorizes the commanding officer to consult with a superior officer in making that determination. This bill is effective on July 1, 2019.

#### ASSEMBLYMAN EDWARDS:

Prior to 2013, our guardsmen had the right to a court-martial. That had been the standard procedure since time *infinitum*. In 2013, the Legislature did change it. However, by 2015 the guardsmen had actually reversed that decision and asked us to restore the due process aspect of a court-martial. In 2015, this Legislature passed the request and restored the due process right by unanimous votes in both houses. That was the correct decision.

We are currently being asked to take away that due process right of our guardsmen. I do not think that is the right thing to do. From the time I was an ensign in the Navy, and 28 years later, I always had that option if I needed it. Our guardsmen should have that option. It should not be taken away from them by us. This is an important right that they have had, and it is an important right that we should protect and make sure stays with them. I ask you to vote against this and not take away their due process options. Thank you.
