INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Wheeler, Ellison, Kramer, Edwards, Leavitt and Roberts:
Assembly Bill No. 241—AN ACT relating to taxation; authorizing a business entity which is engaged in business as a vehicle dealer to deduct certain amounts from its gross revenue when computing the commerce tax owed by the business entity; and providing other matters properly relating thereto.

Assemblyman Wheeler moved that the bill be referred to the Committee on Taxation.

Assembly Bill No. 242—AN ACT relating to economic development; creating the Nevada Air Service Development Commission; creating the Nevada Air Service Development Fund; providing for the management of the Fund; setting forth the duties of the Commission; requiring the Commission to develop a program to provide grants of money from the Fund to certain air carriers; establishing criteria for awarding grants of money from the Fund to certain air carriers; making an appropriation; and providing other matters properly relating thereto.

offenders under a program of lifetime supervision and certain parolees convicted of a sexual offense; and providing other matters properly relating thereto.

Assembly Bill No. 244—AN ACT relating to taxation; authorizing the board of trustees of a school district under specified circumstances to adopt a resolution establishing the formation of a Public Schools Overcrowding and Repair Needs Committee to recommend the imposition of certain taxes to fund the capital projects of the school district; providing that if such a Committee is formed and submits its recommendations to the board of county commissioners within the time prescribed, the board of county commissioners is required to submit a question to the voters at the next general election asking whether the recommended taxes should be imposed in the county; requiring the board of county commissioners to adopt an ordinance imposing any such taxes that are approved by the voters; providing for the use of the proceeds of such taxes for certain school purposes; providing for the prospective expiration of the authority of a board of trustees to establish such a Committee; and providing other matters properly relating thereto.

Assembly Joint Resolution No. 5 of the 79th Session.

Resolution read third time.

Remarks by Assemblywoman Miller.

ASSEMBLYWOMAN MILLER:

Assembly Joint Resolution 5 proposes to amend the *Nevada Constitution* to remove the constitutional provisions relating to the election and duties of the Board of Regents of the University of Nevada. The Legislature shall provide by law for the governance, control, and management of the University and the establishment of its various departments. The resolution also requires the Legislature to set by law the reasonable protection of individual academic freedoms and the promotion of intellectual, literary, scientific, mining, mechanical, agricultural, ethical, and other educational improvements. Proceeds of public lands donated for the support of the institution shall be invested by the State of Nevada as required by law.

If approved in identical form during the 2019 Legislative Session, the proposal will be submitted to the voters for final approval or disapproval at the 2020 General Election.

PROCLAIMED, That we always remember that any one of us can and should extend a hand of support and understanding to our young people.
