INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Assefa, Watts, Benitez-Thompson, Daly, Duran, Fumo, Gorelow, Martinez, Munk and Thompson:

Assembly Bill No. 269—AN ACT relating to elections; requiring the Secretary of State to establish a system for voters to obtain sample ballots electronically and by text message; authorizing a registered voter to return an absent ballot at a polling place during the period for early voting; authorizing

an applicant to elect to receive sample ballots by text message on an application to register to vote; revising provisions relating to a system for distributing sample ballots by electronic means; and providing other matters properly relating thereto.

Assemblywoman Benitez-Thompson moved that the bill be referred to the Committee on Legislative Operations and Elections.

Motion carried.

By Assemblywoman Peters:

Assembly Bill No. 270—AN ACT relating to regional transportation commissions; authorizing a regional transportation commission to sell certain property acquired through eminent domain proceedings or threat thereof at a public auction; and providing other matters properly relating thereto.

Assemblywoman Peters moved that the bill be referred to the Committee on Growth and Infrastructure.

By Assemblywoman Peters:

Assembly Bill No. 271—AN ACT relating to employment; requiring an employer who operates a call center to provide certain notice to the Labor Commissioner before relocating the call center to a foreign country; requiring such an employer to repay any incentives for economic development provided to the employer by a state agency; providing that such an employer is ineligible to receive incentives for economic development for a certain period of time; requiring a state contractor who provides customer service or related functions through a call center to perform all such functions entirely within this State; and providing other matters properly relating thereto.

Assemblywoman Peters moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblymen Roberts, Hafen, Hansen, Leavitt, Nguyen and Yeager:

Assembly Bill No. 272—AN ACT relating to law enforcement; requiring law enforcement agencies in certain counties to participate in the National Integrated Ballistic Information Network of the Bureau of Alcohol, Tobacco, Firearms and Explosives of the United States Department of Justice; and providing other matters properly relating thereto.

Assemblyman Roberts moved that the bill be referred to the Committee on Judiciary.

By Assemblywoman Neal:

Assembly Bill No. 273—AN ACT relating to local governmental financial administration; requiring the governing body of a local government to apply a certain percentage of the money collected from a license tax imposed on a marijuana establishment or medical marijuana establishment to the repayment

of money or the reduction of the amount of money loaned or transferred from an enterprise fund under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Flores moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblymen Neal, Torres and Watts:

Assembly Bill No. 274—AN ACT relating to governmental administration; revising provisions governing the disclosure of information relating to complaints filed with the Nevada Equal Rights Commission within the Department of Employment, Training and Rehabilitation; revising provisions governing the protections against reprisal or retaliatory action provided for a state or local governmental officer or employee who discloses certain governmental action; and providing other matters properly relating thereto.

Assemblyman Flores moved that the bill be referred to the Committee on Government Affairs.

By Assemblymen Torres, Watts, Assefa, Flores, Duran, Fumo, Jauregui, Martinez, McCurdy, Monroe-Moreno and Neal; Senators Denis, Parks, Cancela and Harris:

Assembly Bill No. 275—AN ACT relating to licensing; authorizing any person who is a citizen of the United States or otherwise authorized to work in the United States pursuant to a federal law, regulation, or program or policy of a federal agency or department to apply for a professional or occupational license; authorizing an applicant for a professional or occupational license who does not have a social security number to provide an individual taxpayer identification number; and providing other matters properly relating thereto.

Assemblywoman Torres moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblywoman Miller:

Assembly Bill No. 276—AN ACT relating to education; creating the Nevada State Teacher Recruitment and Retention Advisory Task Force; providing for the membership, powers and duties of the Task Force; and providing other matters properly relating thereto.

Assemblywoman Miller moved that the bill be referred to the Committee on Education.

By Assemblymen Fumo, Bilbray-Axelrod, Jauregui, Assefa, Backus, Carrillo, Gorelow, Martinez, McCurdy, Munk, Nguyen, Peters and Watts:

Assembly Bill No. 277—AN ACT relating to education; requiring each school district to establish, through negotiations with an employee

organization, a program to encourage the recruitment and retention of licensed teachers and classified employees; requiring the board of trustees of each school district to reserve a certain amount of money to carry out the program; requiring the program to be included in the scope of collective bargaining; and providing other matters properly relating thereto.

Assemblyman Fumo moved that the bill be referred to the Committee on Education.

By Assemblymen Fumo and Nguyen:

Assembly Bill No. 278—AN ACT relating to criminal justice; revising the list of persons against whom the commission of certain acts constitute domestic violence; requiring a jury trial in a justice court or municipal court under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Fumo moved that the bill be referred to the Committee on Judiciary.

By Assemblywoman Swank:

Assembly Bill No. 279—AN ACT relating to the Department of Administration; creating the Office of Project Management within the Department of Administration; requiring the Director of the Department to appoint a Chief Program Manager to administer the Office; requiring the Office to oversee certain information technology projects; authorizing the Chief Program Manager to adopt certain regulations; and providing other matters properly relating thereto.

Assemblywoman Swank moved that the bill be referred to the Committee on Government Affairs.
