### GENERAL FILE AND THIRD READING

Assembly Bill No. 206.

Bill read third time.

Remarks by Assemblyman McCurdy.

ASSEMBLYMAN McCurdy:

Assembly Bill 206 requires the chief of the Division of Emergency Management of the Department of Public Safety—as part of the emergency management planning process—to develop written plans for the mitigation of, preparation for, response to, and recovery from

emergencies or disasters. Further, the bill prescribes the contents of each of these plans and requires the chief to annually review each plan and revise as necessary. This measure also requires the Department of Health and Human Services to develop a written plan to address behavioral health needs in an emergency or disaster. Finally, the bill repeals the Committee on Training in Search and Rescue and transfers its duties to the Board of Search and Rescue. This bill will become effective on July 1, 2019.

Assembly Joint Resolution No. 2 of the 79th Session.

Remarks by Assemblymen Jauregui, Tolles, and Edwards.

### ASSEMBLYWOMAN JAUREGUI:

Assembly Joint Resolution 2 proposes to amend the *Nevada Constitution* to provide that the state of Nevada and its political subdivisions shall recognize marriages of and issue licenses to couples, regardless of gender. All legally valid marriages shall be treated equally under the law. The resolution also proposes to repeal existing provisions that only a marriage between a male and female person may be recognized and given effect in Nevada. Finally, the resolution specifies that religious organizations and members of the clergy have the right to refuse to solemnize a marriage, and no person has the right to make any claim against a religious organization or member of the clergy for refusing to perform a marriage.

#### ASSEMBLYWOMAN TOLLES:

I want to publicly thank the original sponsor and the current sponsors for bringing this bill back before this Legislature. I have many good, personal friends in the LGBT community that this is very important to. I also have friends in the faith-based community that had concerns about unintended consequences. I appreciate the amendments and I proudly support this resolution.

### ASSEMBLYMAN EDWARDS:

I rise in what I consider a resolved conundrum. On the one hand, many of you know I do not like reworking things that I think are resolved and I think the Supreme Court actually did resolve this. On the other hand, you know that I like making sure that state law and the *Nevada Constitution* are consistent with the federal laws and the *U.S. Constitution*. What really tilts the balance for me is the fact that we do have the religious protections in this bill. I think they are a great addition, I think they are wise and prudent, and therefore I will be supporting it.
