Remarks by Assemblywomen Cohen and Titus.

#### ASSEMBLYWOMAN COHEN:

Assembly Bill 49 amends various provisions of the Nevada Controlled Substances Act by one, requiring the chief medical officer or his or her designee to upload to the prescription drug monitoring program [PMP] certain information regarding a person who has suffered or is suspected of having suffered a drug overdose, rather than requiring a coroner, medical examiner, or deputy to upload such information; two, specifying that law enforcement agencies only include in the PMP information regarding the arrests involving a prescription for a controlled substance or a report of a stolen prescription for a controlled substance, as prescribed by regulation of the State Board of Pharmacy; and, three, authorizing the State Board of Pharmacy to terminate access to the PMP by an occupational licensing board if the board accesses the database for an unauthorized purpose. In addition, the State Board of Pharmacy is authorized to suspend or revoke a practitioner's registration to dispense controlled substances if he or she violates certain requirements of the PMP.

## ASSEMBLYWOMAN TITUS:

I rise in opposition to Assembly Bill 49. I appreciate the intent of this bill. I believe that, unfortunately, the bill will have unintended consequences that will negatively affect patients throughout this state. This bill does not consider the applicability or impact of potential misinformation being mistakenly uploaded by chief medical officers and law enforcement. This could lead to profiling and keep patients from receiving life-saving drugs, without any recourse, because of a clerical error.

Instead, we should consider more narrow reporting requirements to promote accurate and meaningful information gathering to combat this opioid abuse. We need meaningful and evidence-based solutions, and I urge stakeholders to seek out ways to improve reporting requirements. I cannot support this bill and urge my colleagues to vote nay on this bill.

#### ASSEMBLYWOMAN COHEN:

Assembly Bill 91 requires a guardian to apply to the court for the authority to consent to the sterilization of a protected person. The court is required to appoint an attorney and a guardian ad litem for the protected person and conduct a full evidentiary hearing. The measure provides that a court may authorize a guardian to consent to the sterilization of a protected person only if the court finds by clear and convincing evidence that the sterilization is in the best interest of the protected person, but it requires the court to consider whether any less irrevocable and intrusive means of contraception would be suitable before granting such authority.

Assembly Bill 107 relates to the electronic recording of custodial interrogations. This bill requires each law enforcement agency in this state, in collaboration with the district attorney of the county in which the law enforcement agency is located, to adopt detailed, written policies regarding the electronic recording of custodial interrogations that are conducted in a place of detention. These policies must one, be made available to all law enforcement officers and for public inspection during normal business hours, two, include the circumstances when the custodial interrogation is required and not required to be electronically recorded; and, three, be implemented no later than April 1, 2020.
