Remarks by Assemblywoman Neal.

ASSEMBLYWOMAN NEAL:

Senate Bill 32, in its second reprint, defines the terms "applicant," "disciplinary action," and "licensee" and specifies that the confidentiality provisions relating to certain records and files of

the Department of Taxation additionally apply to the imposition of disciplinary action against a person to whom the Department has issued a license, registration, permit, or certificate. The bill additionally specifies that the existing confidentiality provisions do not apply under the following circumstances: disclosure of the records and files to a grand jury, state or local law enforcement agency, or local regulatory agency under certain circumstances; disclosure of the identity of a licensee against whom disciplinary action has been taken; disclosure of certain information regarding any applications filed on or after May 1, 2017; and disclosure of the name of a marijuana licensee and the jurisdiction of the licensee pursuant to Chapters 453A or 453D of the NRS.
