### INTRODUCTION, FIRST READING AND REFERENCE

# By Senator Cannizzaro:

Senate Bill No. 242—AN ACT relating to peace officers; requiring that a suspended peace officer must be granted back pay under certain circumstances; requiring that the questioning of a peace officer by a superior officer cease under certain circumstances; prohibiting the disclosure or use of a peace officer's compelled statement in certain civil cases; providing, with limited exception, that a video of a police officer is confidential; limiting the time in which a law enforcement agency may initiate an investigation into certain alleged misconduct of a peace officer; prohibiting, with limited exception, a law enforcement agency from reassigning a peace officer while

he or she is under investigation; requiring, under certain circumstances, the dismissal of civil and administrative proceedings against a peace officer; revising provisions related to the questioning or interrogation of a peace officer; requiring, with limited exception, that the face of a peace officer be redacted from a video recorded by a portable event recording device; and providing other matters properly relating thereto.

Senator Cannizzaro moved that the bill be referred to the Committee on Government Affairs.

Senate Bill No. 243—AN ACT relating to public construction; revising the procedure for determining the prevailing rate of wages; and providing other matters properly relating thereto.

### GENERAL FILE AND THIRD READING

Senate Bill No. 77.

Bill read third time.

Remarks by Senator Hardy.

Senate Bill No. 77 includes services in the types of purchases a county hospital or a hospital in a county hospital district may make through the purchasing contracts of the company that manages the hospital or through a purchasing group without complying with the competitive bidding requirements in the Local Government Purchasing Act or for public works. If such services are for work on a project that qualifies as a public work, prevailing wages must be paid.

Currently, a county hospital or a hospital in a county hospital district may purchase supplies, materials and equipment through such purchasing contracts.

Senate Bill No. 92. Bill read third time. Remarks by Senators Ratti and Hardy.

#### SENATOR RATTI:

Senate Bill No. 92 is one of many bills we will see this Legislative Session which addresses the issues uncovered by our legislative audits of community-based living arrangements. These audits showed unfortunate conditions in which people with serious mental illness were living in congregate group settings. This bill attacks referral entities that hang-out outside hospitals and, upon discharge, refer a person to a congregate living situation which may or may not be a licensed home. The bill requires these referral agencies to become licensed. If implemented, when a hospital refers a person to an agency, it will know it has a qualified discharge and the person is going to an appropriate setting.

This bill deals with the licensing of the referral agencies and requires the Division of Health and Human Services to make a concerted effort to identify unlicensed group settings. This could be done, for example, by scanning Medicaid rolls and identifying that six individuals who are all Medicaid qualified are living at one residence and this residence is not a licensed group home. The Division could then investigate the situation. They could review the business license of a local business to see if it is licensed as a group home and aggressively go after folks who are operating group living arrangements but are not licensed to do so. I appreciate your support on this bill.

#### SENATOR HARDY:

I stand in support of this bill. One of the things we saw through the interim were pictures that were very disturbing, which were investigated, and allowed for people to be able to do this. As I understand it, this does not increase the number of investigations as much as it allows us to have a burden to do so, as well as to allow the referring agency to have the responsibility to do so.
