INTRODUCTION, FIRST READING AND REFERENCE

Senate Bill No. 489—AN ACT relating to the state business portal; requiring the Secretary of State to adopt regulations to provide that certain licenses to conduct a business in this State all expire on the same date; and providing other matters properly relating thereto.

Senate Bill No. 490—AN ACT relating to government contracts; requiring the Nevada Commission on Minority Affairs to conduct a study relating to disparities and unlawful discrimination on the basis of race or gender in the awarding of purchasing and public works contracts by the State or a local government; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Government Affairs.

By Senators Washington, Denis, Brooks, Cannizzaro, Dondero Loop, Ratti, Spearman and Woodhouse:

Senate Bill No. 491—AN ACT relating to salvaged vehicles; authorizing a salvage pool to tow and store certain abandoned vehicles and providing that such a salvage pool has a lien on the vehicle for the costs of towing and storage; revising provisions relating to obtaining a salvage title for a vehicle that is the object of certain insurance settlements; revising provisions relating to the issuance of a salvage title by the Department of Motor Vehicles; revising provisions relating to a lien on certain vehicles; and providing other matters properly relating thereto.

Senator Washington moved that the bill be referred to the Committee on Growth and Infrastructure.

GENERAL FILE AND THIRD READING

Senate Bill No. 274.

Bill read third time.

Remarks by Senator Scheible.

Senate Bill No. 274 revises terms of imprisonment for the category B felony of discharging a firearm in certain circumstances. The maximum term of imprisonment for willfully and maliciously shooting into an aircraft, occupied building, train, vessel or other structure from outside the structure or vehicle is raised from six years to ten years. The term of imprisonment for shooting from inside a structure or vehicle is revised downward from 2 to 15 years to 1 to 10 years, bringing the penalties for the 2 similar crimes into conformity with each other.

Senate Bill No. 331.

Bill read third time.

Remarks by Senator Spearman.

Senate Bill No. 331 designates the portion of Interstate Highway No. 11 situated in Nevada as the Purple Heart Highway. The Director of Nevada's Department of Transportation must erect and maintain suitable markers reflecting this designation along that portion of the highway. The Director is authorized to accept gifts, grants and donations to help pay the costs of such markers and maintenance.

The Badge of Military Merit was established in 1782, later becoming the Purple Heart in 1932. It is frequently described as the military's oldest medal. It is now awarded to members of the Armed Forces of the United States for wounds or death as a result of an act of any opposing armed force, as a result of an international terrorist attack or as a result of military operations while serving as part of a peacekeeping force. I urge my colleagues' passage.
