**AN ACT** making appropriations to the Investigation Division of the Department of Public Safety for the replacement of vehicles and computer software and hardware; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** There is hereby appropriated from the State General
- 2 Fund to the Investigation Division of the Department of Public
- 3 Safety the sum of \$540,388 for the replacement of vehicles.
- 4     **Sec. 2.** There is hereby appropriated from the State Highway
- 5 Fund to the Investigation Division of the Department of Public
- 6 Safety the sum of \$93,538 for the replacement of vehicles.
- 7     **Sec. 3.** There is hereby appropriated from the State General
- 8 Fund to the Investigation Division of the Department of Public
- 9 Safety the sum of \$58,848 for the replacement of computer
- 10 hardware and software.
- 11     **Sec. 4.** There is hereby appropriated from the State Highway
- 12 Fund to the Investigation Division of the Department of Public



1 Safety the sum of \$2,008 for the replacement of computer hardware  
2 and software.

3 **Sec. 5.** 1. Any remaining balance of the appropriations made  
4 by sections 1 and 3 of this act must not be committed for  
5 expenditure after June 30, 2021, by the entity to which the  
6 appropriation is made or any entity to which money from the  
7 appropriation is granted or otherwise transferred in any manner, and  
8 any portion of the appropriated money remaining must not be spent  
9 for any purpose after September 17, 2021, by either the entity to  
10 which the money was appropriated or the entity to which the money  
11 was subsequently granted or transferred, and must be reverted to the  
12 State General Fund on or before September 17, 2021.

13 2. Any remaining balance of the appropriations made by  
14 sections 2 and 4 of this act must not be committed for expenditure  
15 after June 30, 2021, by the entity to which the appropriation is made  
16 or any entity to which money from the appropriation is granted or  
17 otherwise transferred in any manner, and any portion of the  
18 appropriated money remaining must not be spent for any purpose  
19 after September 17, 2021, by either the entity to which the money  
20 was appropriated or the entity to which the money was subsequently  
21 granted or transferred, and must be reverted to the State Highway  
22 Fund on or before September 17, 2021.

23 **Sec. 6.** This act becomes effective upon passage and approval.
