SUMMARY—Revises provisions relating to gaming. (BDR 41-343)

AN ACT relating to gaming; revising the definition of “gaming device” to include mobile gaming; removing or repealing certain provisions relating to mobile gaming; revising certain provisions relating to publicly traded corporations registered with the Nevada Gaming Commission; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law requires the Nevada Gaming Commission and the Nevada Gaming Control Board to administer state gaming licenses and manufacturer’s, seller’s and distributor’s licenses, and to reform various acts relating to the regulation and control of gaming. (NRS 463.140) Existing law authorizes the Commission, with the advice and assistance of the Board, to adopt regulations governing the operation and licensing of mobile gaming. (NRS 463.730) Existing law defines “mobile gaming” as the conduct of gambling games through communication devices operated solely within certain establishments holding a nonrestricted gaming license that permits a person to transfer information to a computer in order to place a bet or wager, and respective information related to the display of the game, game outcomes or other comparable information. (NRS 463.0176) Existing law defines “gaming device” as any object used remotely or directly in connection with gaming, or any other game that affects the results of a wager by determining win or loss but which does not qualify as associated equipment. (NRS 463.0155) **Section 2** of this bill revises the definition of “gaming device” to include mobile gaming, thereby making mobile gaming subject to the same regulation and control as a gaming device. **Sections 1.7, 3-10, 11-19 and 20** of this bill remove or repeal all provisions with individual references to mobile gaming. **Section 19.5 of this bill** exempts from the amendatory provisions of **sections 5, 7, 8, 10, 18 and 19** **(1)** certain persons with a nonrestricted license for a mobile gaming system or such a license for the operation of a mobile gaming system **(2)** **cert**ain persons who acquire a financial interest in **such an operator of a mobile gaming system or the operation of** such a system **;** or **(3)** a successor in interest of such a person who acquired **such** a financial interest. **Section 19.5 also exempts from the amendatory provisions of section 3 of this bill employees of such an operator of a mobile gaming system described in section 19.5. Section 19.5 also provides that the provisions of law repealed by section 20 of this bill still apply to those persons or transactions described in section 19.5. Finally, section 19.5 provides that persons or transactions described in section 19.5 are not exempt from certain provisions of law.**

27 Existing law requires certain persons to apply for and obtain a finding of suitability from
 28 the Nevada Gaming Commission if the person acquires, under certain circumstances: (1)
 29 beneficial ownership of any voting security of a publicly traded corporation registered with
 30 the Commission; (2) beneficial or record ownership of any nonvoting security of a publicly
 31 traded corporation registered with the Commission; or (3) beneficial or record ownership of
 32 any debt security of a publicly traded corporation registered with the Commission. (NRS
 33 463.643) **Section 10.8** of this bill requires certain persons to notify the Chair of the Board and
 34 apply for a finding of suitability with the Commission if such a person acquires or holds a
 35 certain percentage of any class of voting securities of a publicly traded corporation registered
 36 with the Commission. **Section 10.8** also requires certain persons to notify the Chair, ~~and~~
 37 apply for a finding of suitability with the Commission and pay a sum of money to the Board
 38 if such a person obtains beneficial ownership in such a publicly traded corporation and the
 39 person has the intent to engage in certain proscribed activities, except that certain persons who
 40 acquire less than a 10 percent beneficial ownership in such a corporation through a pension are
 41 not subject to ~~the~~ such notification, ~~and~~ application and payment requirements.
 42 **Sections 1.3, 1.5 and 10.2-10.6** make conforming changes.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
 SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 463 of NRS is hereby amended by adding thereto the
 2 provisions set forth as sections 1.3 and 1.5 of this act.

3 **Sec. 1.3. 1.** *“Pension” means an employee pension or benefit plan subject*
 4 *to the Employee Retirement Income Security Act of 1974 or a state or federal*
 5 *government pension plan.*

6 **2.** *The term does not include an employee pension or benefit plan*
 7 *established by a publicly traded corporation that is registered with the*
 8 *Commission.*

9 **Sec. 1.5. “Proscribed activity” means:**

10 **1.** *An activity that necessitates a change or amendment to the corporate*
 11 *charter, bylaws, management, policies or operation of a publicly traded*
 12 *corporation that is registered with the Commission;*

13 **2.** *An activity that materially influences or affects the affairs of a publicly*
 14 *traded corporation that is registered with the Commission; or*

15 **3.** *Any other activity determined by the Commission to be inconsistent with*
 16 *holding voting securities for investment purposes only.*

17 **Sec. 1.7.** NRS 463.0136 is hereby amended to read as follows:

18 463.0136 “Associated equipment” means:

19 **1.** Any equipment or mechanical, electromechanical or electronic contrivance,
 20 component or machine used remotely or directly in connection with gaming, ~~for~~
 21 ~~mobile gaming,~~ any game, race book or sports pool that would not otherwise be
 22 classified as a gaming device, including dice, playing cards, links which connect to
 23 progressive slot machines, equipment which affects the proper reporting of gross
 24 revenue, computerized systems of betting at a race book or sports pool,
 25 computerized systems for monitoring slot machines and devices for weighing or
 26 counting money; or

27 **2.** A computerized system for recordation of sales for use in an area subject to
 28 the tax imposed pursuant to NRS 368A.200.

29 **Sec. 2.** NRS 463.0155 is hereby amended to read as follows:

30 463.0155 “Gaming device” means any object used remotely or directly in
 31 connection with gaming or any game which affects the result of a wager by
 32 determining win or loss and which does not otherwise constitute associated
 33 equipment. The term includes, without limitation:

1 1. A slot machine.

2 2. **Mobile gaming.**

3 3. A collection of two or more of the following components:

4 (a) An assembled electronic circuit which cannot be reasonably demonstrated
5 to have any use other than in a slot machine;

6 (b) A cabinet with electrical wiring and provisions for mounting a coin, token
7 or currency acceptor and provisions for mounting a dispenser of coins, tokens or
8 anything of value;

9 (c) An assembled mechanical or electromechanical display unit intended for
10 use in gambling; or

11 (d) An assembled mechanical or electromechanical unit which cannot be
12 demonstrated to have any use other than in a slot machine.

13 ~~3.~~ 4. Any object which may be connected to or used with a slot machine to
14 alter the normal criteria of random selection or affect the outcome of a game.

15 ~~4.~~ 5. A system for the accounting or management of any game in which the
16 result of the wager is determined electronically by using any combination of
17 hardware or software for computers.

18 ~~5.~~ 6. A control program.

19 ~~6.~~ 7. Any combination of one of the components set forth in paragraphs (a)
20 to (d), inclusive, of subsection ~~2.~~ 3 and any other component which the
21 Commission determines by regulation to be a machine used directly or remotely in
22 connection with gaming or any game which affects the results of a wager by
23 determining a win or loss.

24 ~~7.~~ 8. Any object that has been determined to be a gaming device pursuant to
25 regulations adopted by the Commission.

27 9. As used in this section ~~1.~~ ~~“control”~~:

28 (a) **“Control program”** means any software, source language or executable
29 code which affects the result of a wager by determining win or loss as determined
30 pursuant to regulations adopted by the Commission.

31 (b) **“Mobile gaming”** means the conduct of gambling games through
32 communications devices operated solely in an establishment which holds a
33 nonrestricted gaming license and which operates at least 100 slot machines and
34 at least one other game by the use of communications technology that allows a
35 person to transmit information to a computer to assist in the placing of a bet or
36 wager and corresponding information related to the display of the game, game
37 outcomes or other similar information. For the purposes of this paragraph,
38 **“communications technology”** means any method used and the components
39 employed by an establishment to facilitate the transmission of information,
40 including, without limitation, transmission and reception by systems based on
41 wireless network, wireless fidelity, wire, cable, radio, microwave, light, optics or
42 computer data networks. The term does not include the Internet.

43 **Sec. 3.** NRS 463.0157 is hereby amended to read as follows:

44 463.0157 1. “Gaming employee” means any person connected directly with
45 an operator of a slot route, the operator of a pari-mutuel system, the operator of an
46 inter-casino linked system or a manufacturer, distributor or disseminator, or with
47 the operation of a gaming establishment licensed to conduct any game, 16 or more
48 slot machines, a race book, sports pool or pari-mutuel wagering, including:

49 (a) Accounting or internal auditing personnel who are directly involved in any
50 recordkeeping or the examination of records associated with revenue from gaming;

51 (b) Boxpersons;

52 (c) Cashiers;

53 (d) Change personnel;

- 1 (e) Counting room personnel;
- 2 (f) Dealers;
- 3 (g) Employees of a person required by NRS 464.010 to be licensed to operate
4 an off-track pari-mutuel system;
- 5 (h) Employees of a person required by NRS 463.430 to be licensed to
6 disseminate information concerning racing and employees of an affiliate of such a
7 person involved in assisting the person in carrying out the duties of the person in
8 this State;
- 9 (i) Employees whose duties are directly involved with the manufacture, repair,
10 sale or distribution of gaming devices, associated equipment when the employer is
11 required by NRS 463.650 to be licensed, cashless wagering systems ~~[- mobile
12 gaming systems, equipment associated with mobile gaming systems]~~ or interactive
13 gaming systems;
- 14 (j) Employees of operators of slot routes who have keys for slot machines or
15 who accept and transport revenue from the slot drop;
- 16 (k) Employees of operators of inter-casino linked systems ~~[- mobile gaming
17 systems]~~ or interactive gaming systems whose duties include the operational or
18 supervisory control of the systems or the games that are part of the systems;
- 19 (l) Employees of operators of call centers who perform, or who supervise the
20 performance of, the function of receiving and transmitting wagering instructions;
- 21 (m) Employees who have access to the Board's system of records for the
22 purpose of processing the registrations of gaming employees that a licensee is
23 required to perform pursuant to the provisions of this chapter and any regulations
24 adopted pursuant thereto;

- 26 (o) Hosts or other persons empowered to extend credit or complimentary
27 services;
- 28 (p) Keno runners;
- 29 (q) Keno writers;

- 33 (u) Shift or pit bosses;
- 34 (v) Shills;
- 35 (w) Supervisors or managers;

49 software from within a licensed gaming establishment, hosting center or elsewhere
50 within this State.

51 **Sec. 4.** NRS 463.01715 is hereby amended to read as follows:

52 463.01715 1. "Manufacture" means:

1 (a) To manufacture, produce, program, design, control the design of or make
2 modifications to a gaming device, associated equipment, cashless wagering system
3 ~~{, mobile gaming system}~~ or interactive gaming system for use or play in Nevada;

4 (b) To direct or control the methods and processes used to design, develop,
5 program, assemble, produce, fabricate, compose and combine the components and
6 other tangible objects of any gaming device, associated equipment, cashless
7 wagering system ~~{, mobile gaming system}~~ or interactive gaming system for use or
8 play in Nevada;

9 (c) To assemble, or control the assembly of, a gaming device, associated
10 equipment, cashless wagering system ~~{, mobile gaming system}~~ or interactive
11 gaming system for use or play in Nevada; or

12 (d) To assume responsibility for any action described in paragraph (a), (b) or
13 (c).

14 2. As used in this section:

35 any other game, gaming device, race book or sports pool at one establishment;

36 3. A license for, or the operation of, a slot machine route; *or*

37 4. A license for, or the operation of, an inter-casino linked system . ~~{, or~~
38 ~~5. A license for, or the operation of, a mobile gaming system.}~~

39 **Sec. 6.** NRS 463.160 is hereby amended to read as follows:

40 463.160 1. Except as otherwise provided in subsection 4 and NRS 463.172,
41 it is unlawful for any person, either as owner, lessee or employee, whether for hire
42 or not, either solely or in conjunction with others:

43 (a) To deal, operate, carry on, conduct, maintain or expose for play in the State
44 of Nevada any gambling game, gaming device, inter-casino linked system, ~~{mobile~~
45 ~~gaming system,}~~ slot machine, race book or sports pool;

46 (b) To provide or maintain any information service;

47 (c) To operate a gaming salon;

48 (d) To receive, directly or indirectly, any compensation or reward or any
49 percentage or share of the money or property played, for keeping, running or
50 carrying on any gambling game, slot machine, gaming device, ~~{mobile gaming~~
51 ~~system,}~~ race book or sports pool;

52 (e) To operate as a cash access and wagering instrument service provider; or

1 (f) To operate, carry on, conduct, maintain or expose for play in or from the
2 State of Nevada any interactive gaming system,
3 ↪ without having first procured, and thereafter maintaining in effect, all federal,
4 state, county and municipal gaming licenses as required by statute, regulation or
5 ordinance or by the governing board of any unincorporated town.

6 2. The licensure of an operator of an inter-casino linked system is not required
7 if:

8 (a) A gaming licensee is operating an inter-casino linked system on the
9 premises of an affiliated licensee; or

10 (b) An operator of a slot machine route is operating an inter-casino linked
11 system consisting of slot machines only.

12 3. Except as otherwise provided in subsection 4, it is unlawful for any person
13 knowingly to permit any gambling game, slot machine, gaming device, inter-casino
14 linked system, ~~mobile gaming system,~~ race book or sports pool to be conducted,
15 operated, dealt or carried on in any house or building or other premises owned by
16 the person, in whole or in part, by a person who is not licensed pursuant to this
17 chapter, or that person's employee.

18 4. The Commission may, by regulation, authorize a person to own or lease
19 gaming devices for the limited purpose of display or use in the person's private
20 residence without procuring a state gaming license.

39 shall not approve a nonrestricted license, other than for the operation of a ~~mobile
40 gaming system,~~ race book or sports pool at an establishment which holds a
41 nonrestricted license to operate both gaming devices and a gambling game, for an
42 establishment in a county whose population is 100,000 or more unless the
43 establishment is a resort hotel.

44 2. A county, city or town may require resort hotels to meet standards in
45 addition to those required by this chapter as a condition of issuance of a gaming
46 license by the county, city or town.

47 3. The Commission may approve a nonrestricted license for an establishment
48 which is not a resort hotel at a new location if:

49 (a) The establishment was acquired or displaced pursuant to a redevelopment
50 project undertaken by an agency created pursuant to chapter 279 of NRS in
51 accordance with a final order of condemnation entered before June 17, 2005; or

52 (b) The establishment was acquired or displaced pursuant to a redevelopment

7 of that person, for the operation of any game, including a sports pool or race book,
8 which authorize gaming at the same establishment must be merged into a single
9 gaming license.

10 (b) A gaming license may not be issued to any person if the issuance would
11 result in more than one licensed operation at a single establishment, whether or not
12 the profits or revenue from gaming are shared between the licensed operations.

13 2. A person who has been issued a nonrestricted gaming license for an
14 operation described in subsection 1 ~~1~~ or 2 ~~or 5~~ of NRS 463.0177 may establish a
15 sports pool or race book on the premises of the establishment only after obtaining
16 permission from the Commission.

17 3. A person who has been issued a license to operate a sports pool or race
18 book at an establishment may be issued a license to operate a sports pool or race
19 book at a second establishment described in subsection 1 or 2 of NRS 463.0177
20 only if the second establishment is operated by a person who has been issued a
21 nonrestricted license for that establishment. A person who has been issued a license
22 to operate a race book or sports pool at an establishment is prohibited from
23 operating a race book or sports pool at:

24 (a) An establishment for which a restricted license has been granted; or

25 (b) An establishment at which only a nonrestricted license has been granted for
26 an operation described in subsection 3 or 4 of NRS 463.0177.

27 4. A person who has been issued a license to operate a race book or sports
28 pool shall not enter into an agreement for the sharing of revenue from the operation
29 of the race book or sports pool with another person in consideration for the
30 offering, placing or maintaining of a kiosk or other similar device not physically
31 located on the licensed premises of the race book or sports pool, except:

32 (a) An affiliated licensed race book or sports pool; or

33 (b) The licensee of an establishment at which the race book or sports pool
34 holds or obtains a license to operate pursuant to this section.

35 ➤ This subsection does not prohibit an operator of a race book or sports pool from
36 entering into an agreement with another person for the provision of shared services

13 the Board or Commission has not approved for testing or for operation is subject to
14 disciplinary action by the Board or Commission.

15 2. The Board shall maintain a list of approved gaming devices ~~[, mobile~~
16 ~~gaming systems]~~ and inter-casino linked systems.

17 3. If the Board suspends or revokes approval of a gaming device pursuant to
18 the regulations adopted pursuant to subsection 4 , ~~for suspends or revokes approval~~

20 ~~463.730.]~~ the Board may order the removal of the gaming device ~~for mobile~~

Sec. 21. 1. This section and sections 1, 1.3, 1.5 and 10.2 to 10.8, inclusive, of this act become effective upon passage and approval for the purpose of adopting regulations and performing any other preparatory administrative tasks to carry out the amendatory provisions of this act, and on January 1, 2020, for all other purposes.

2. Sections 1.7 to 10, inclusive, and 11 to 20, inclusive, of this act become effective on July 1, 2019.

TEXT OF REPEALED SECTIONS

463.0176 “Mobile gaming” defined. “Mobile gaming” means the conduct of gambling games through communications devices operated solely in an establishment which holds a nonrestricted gaming license and which operates at least 100 slot machines and at least one other game by the use of communications technology that allows a person to transmit information to a computer to assist in the placing of a bet or wager and corresponding information related to the display of the game, game outcomes or other similar information. For the purposes of this section, “communications technology” means any method used and the components employed by an establishment to facilitate the transmission of information, including, without limitation, transmission and reception by systems based on wireless network, wireless fidelity, wire, cable, radio, microwave, light, optics or computer data networks. The term does not include the Internet.

463.730 License required to operate, manufacture, sell or distribute mobile gaming system or to manufacture equipment associated with mobile gaming; powers and duties of Commission; regulations; conditions.

1. Except as otherwise provided in subsection 2, the Commission may, with the advice and assistance of the Board, adopt regulations governing the operation of mobile gaming and the licensing of:

(a) An operator of a mobile gaming system;

- (b) A manufacturer, seller or distributor of a mobile gaming system; and
- (c) A manufacturer of equipment associated with mobile gaming.

2. The Commission may not adopt regulations pursuant to this section until the Commission first determines that:

(a) Mobile gaming systems are secure and reliable, and provide reasonable assurance that players will be of lawful age and communicating only from areas of licensed gaming establishments that have been approved by the Commission for that purpose; and

(b) Mobile gaming can be operated in a manner which complies with all applicable laws.

3. The regulations adopted by the Commission pursuant to this section must:

(a) Provide that gross revenue received by a licensed gaming establishment or the operator or the manufacturer of a mobile gaming system from the operation of mobile gaming is subject to the same license fee provisions of NRS 463.370 as the other games and gaming devices operated at the licensed gaming establishment.

(b) Provide that a mobile communications device which displays information relating to the game to a participant in the game as part of a mobile gaming system is subject to the same fees and taxes applicable to slot machines as set forth in NRS 463.375 and 463.385.

(c) Set forth standards for the security of the computer system and its location, which may be outside a licensed gaming establishment but must be within this State, and for approval of hardware and software used in connection with mobile gaming.

(d) Define "mobile gaming system," "operator of a mobile gaming system" and "equipment associated with mobile gaming" as the terms are used in this chapter.

463.735 Enforceability of mobile gaming debts. A debt incurred by a patron in connection with playing a mobile gaming system at a licensed gaming establishment is valid and may be enforced by legal process.
