SUMMARY—Revises provisions relating to family courts. (BDR 1-629)

EXPLANATION - Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to courts; authorizing a family court or certain district courts to close to the public certain proceedings within the jurisdiction of the family court; requiring a family court or district court to seal certain records relating to proceedings within the jurisdiction of the family court; authorizing the inspection of records which have been sealed under certain circumstances; and providing other matters properly relating thereto.

#### Legislative Counsel's Digest:

Existing law provides that the family court, or in a judicial district that does not 123456789 include a family court, the district court, has original jurisdiction over juvenile justice, domestic relations, guardianship of minors, children and certain other matters. (NRS 3.0105, 3.223) Section 2 of this bill authorizes a family court or such a district court to close to the public proceedings within the jurisdiction of the family court if the proceeding involves a child: (1) upon the request of a party; or (2) is in the best interests of the child. **Section 2** also specifies the persons who may be excluded from observing or being permitted to observe any or part of the proceedings. Section 3 of this bill requires the family court or district court to seal 10 certain records related to proceedings within the jurisdiction of the family court. 11 Section 3 also authorizes the family court or district court, under certain 12 circumstances, to permit the inspection of records which have been sealed.





#### THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 3 of NRS is hereby amended by adding 2 thereto the provisions set forth as sections 2 and 3 of this act. 3

Sec. 2. Notwithstanding any other provision of law:

1. If a proceeding involves a child and is within the 4 5 jurisdiction of the family court, the family court or, in a judicial 6 district that does not include a family court, the district court, may 7 determine that all or part of the proceeding be closed to the public: 8 (a) Upon demand of either party to the proceeding; or

(b) If the closure is in the best interests of the child.

2. Except as otherwise provided in subsection 3 or 4, if a 10 proceeding is closed upon such demand of either party, all persons 11 must be excluded from the court or chambers wherein the 12

proceeding is brought, except: 13 14

(a) The officers of the court;

(b) The parties;

(c) The counsel for the parties;

(d) The employees or representatives of the counsel for the 17 18 parties:

(e) The witnesses and expert witnesses:

(f) The parents or guardians of the parties; and

(g) The siblings of the parties.

22 3. The family court or district court may, upon oral or written motion of either party, exclude the parents, guardians or siblings 23 24 of either party, or witnesses for either party, from the court or chambers wherein the proceeding is brought. If good cause is 25 26 shown for the exclusion of any such person, the family court or 27 district court shall exclude any such person from the proceeding.

Except as otherwise provided in this section, the family 28 4. 29 court or district court may permit a person access to all or part of 30 a proceeding closed pursuant to this section if the family court or 31 district court determines the access of the person is in the best 32 interests of the child.

Sec. 3. Notwithstanding any other provision of law: 33

34 In a proceeding that involves a child and is within the 1. 35 jurisdiction of the family court or, in a judicial district that does 36 not include a family court, the following papers and pleadings in 37 the proceeding must be open to public inspection in the clerk's office: 38

(a) The summons, proof of service, pleadings, orders of the 39 family court or, in a judicial district that does not include a family 40 court, orders of the district court, judgments, any defaults; and 41





1 (b) Where service is made by publication, the affidavit for 2 publication and the order directing the publication.

2. All other papers, records, including, without limitation,
electronic and video records, proceedings and evidence, including,
without limitation, exhibits and transcripts of any testimony, must,
upon the written request of either party to the proceeding, be filed
with the clerk and sealed and shall not be open to inspection
except to the parties of the proceeding or counsel for the parties.

9 3. Except as otherwise provided in subsection 4, any records 10 or papers which contain personally identifying information 11 relating to a party or child must be sealed.

4. Upon an oral or written motion, the family court or district
 court, as applicable, may order sealed or redacted any records and
 papers otherwise open to public inspection.

15 5. Any record or paper sealed pursuant to this section must be 16 made available for inspection only upon:

(a) An order of the family court or district court; or

18 (b) A petition, for good cause shown, by a party requesting 19 such inspection. If a party petitions the family court or district 20 court for such inspection, the party shall serve the petition on all 21 parties of the proceeding.
