SUMMARY—Revises provisions governing local emergency management. (BDR 36-355)

AN ACT relating to emergency management; creating the Nevada Tribal Emergency Coordinating Council; prescribing the membership and duties of the Council; revising provisions governing a local organization for emergency management; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law requires the Chief of the Division of Emergency Management of the Department of Public Safety to coordinate the activities of all organizations for emergency management within Nevada. (NRS 414.040) Section 1 of this bill creates the Nevada Tribal Emergency Coordinating Council within the Division. Section 1 requires the Chief of the Division to appoint not more than 15 members to the Council, each of whom must be a member of a federally recognized Indian tribe or nation which is located within Nevada. Section 1 requires the Council to: (1) advise the Chief regarding emergency management on tribal lands; (2) assist in the coordination of mitigation, preparedness, response and recovery activities relating to an emergency on tribal lands; and (3) submit an annual report to the Chief detailing the Council's activities during the immediately preceding calendar year and recommendations relating to emergency management on tribal lands.

2 year and recommendations relating to emergency management on tribal lands. Existing law authorizes each county and city in Nevada to establish a local organization for emergency management. A local organization for emergency management is responsible for performing functions of emergency management within the territorial limits of the political subdivision within which it is organized





and, if required, outside those territorial limits. (NRS 414.090) Section 2 of this bill makes it mandatory for a county to establish a local organization for emergency management, but, in lieu of each county establishing its own local organization for emergency management, section 2 authorizes the boards of county commissioners of two or more counties to enter into an interlocal agreement establishing one local organization for emergency management for all the counties that are parties to the agreement.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 414 of NRS is hereby amended by adding 1 2 thereto a new section to read as follows: 3 The Nevada Tribal Emergency Coordinating Council, consisting of not more than 15 members appointed by the Chief, is 4 5 hereby created within the Division of Emergency Management of 6 the Department of Public Safety. The Chief shall appoint members 7 from any federally recognized Indian tribe or nation, all or part of 8 which is located within the boundaries of this State. 9 2. The term of office of each member of the Council is 2 10 vears. The Council shall meet at the call of the Chief and at least 11 *3*. 12 once every 3 months. 13 4. The Division of Emergency Management shall provide the Council with administrative support. 14 15 5. The Council shall: (a) Advise the Chief regarding emergency management on 16 17 tribal lands; (b) Assist in the coordination of mitigation, preparedness, 18 19 response and recovery activities related to an emergency on tribal 20 lands: and 21 (c) Submit an annual report to the Chief on or before 22 January 31 of each year which must include, without limitation: 23 (1) A summary of the activities of the Council during the 24 immediately preceding calendar year; and 25 (2) Recommendations relating to emergency management on tribal lands. 26 27 The Attorney General shall enter into any agreements 6. 28 necessary to carry out the provisions of this section. **Sec. 2.** NRS 414.090 is hereby amended to read as follows: 29 30 414.090 1. [Each political subdivision] Except as otherwise provided in subsection 2, each county of this state shall, and each 31 city of this state may, establish a local organization for emergency 32 33 management in accordance with the state emergency management plan and program for emergency management. Such a political 34





subdivision may confer or authorize the conferring upon members 1 2 of the auxiliary police the powers of police officers, subject to such 3 restrictions as it imposes. Each local organization for emergency 4 management must have a director who must be appointed by the 5 executive officer or governing body of the political subdivision, and 6 who has direct responsibility for the organization, administration 7 and operation of the local organization for emergency management 8 subject to the direction and control of the executive officer or organization for emergency 9 governing body. Each local management shall perform functions of emergency management 10 11 within the territorial limits of the political subdivision within which 12 it is organized, and, in addition, shall conduct such functions outside of such territorial limits as may be required pursuant to the 13 14 provisions of NRS 414.100.

15 2. In lieu of establishing a local organization for emergency 16 management pursuant to subsection 1, the boards of county 17 commissioners of two or more counties may enter into an 18 interlocal agreement that:

19 (a) Establishes a local organization for emergency 20 management for the counties that are parties to the agreement; 21 and

22 (b) Ensures compliance with the requirements of subsection 1.

23 3. In carrying out the provisions of this chapter, each political 24 subdivision in which any emergency or disaster described in NRS 25 414.020 occurs may enter into contracts and incur obligations necessary to combat such an emergency or disaster, protect the 26 27 health and safety of persons and property and provide emergency 28 assistance to the victims of such an emergency or disaster. Each 29 political subdivision may exercise the powers vested under this 30 section in the light of the exigencies of the extreme emergency or 31 disaster without regard to time-consuming procedures and 32 formalities prescribed by law, except constitutional requirements, pertaining to the performance of public work, entering into 33 34 contracts, the incurring of obligations, the employment of temporary workers, the rental of equipment, the purchase of supplies and 35 36 materials, the levying of taxes, and the appropriation and 37 expenditure of public funds.

38 **Sec. 3.** The provisions of NRS 354.599 do not apply to any 39 additional expenses of a local government that are related to the 40 provisions of this act.

41 **Sec. 4.** This act becomes effective upon passage and approval.
