ASSEMBLY JOINT RESOLUTION—Proposing to amend the Nevada Constitution to add and revise terms relating to persons with certain conditions for whose benefit certain public entities are supported by the State.

**Legislative Counsel’s Digest:**

1     **Section 1** of Article 13 of the Nevada Constitution requires that institutions for  
2 the benefit of the insane, blind and deaf and dumb be fostered and supported by the  
3 State. This joint resolution proposes to amend the Nevada Constitution to replace  
4 the term “institutions” with “entities” and to revise the description of the persons  
5 who benefit from these entities from: (1) “insane” to “persons with significant  
6 mental illness”; (2) “blind” to “persons who are blind or visually impaired”; and (3)  
7 “deaf and dumb” to “persons who are deaf or hard of hearing.” This joint resolution  
8 also proposes to amend the Nevada Constitution to add entities for the benefit of  
9 persons with intellectual or developmental disabilities to the types of entities that  
10 shall be fostered and supported by the State.

1 RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF  
2 NEVADA, JOINTLY, That Section 1 of Article 13 of the Nevada  
3 Constitution be amended to read as follows:

4 Section ~~[.]~~ 1. ~~[Institutions]~~ *Entities* for the benefit of  
5 ~~[the Insane, Blind and Deaf and Dumb,]~~ *persons with*  
6 *significant mental illness, persons who are blind or visually*  
7 *impaired, persons who are deaf or hard of hearing and*  
8 *persons with intellectual disabilities or developmental*  
9 *disabilities,* and such other benevolent ~~[institutions]~~ *entities*  
10 as the public good may require, shall be fostered and  
11 supported by the State, subject to such regulations as may be  
12 prescribed by law.
