AN ACT making appropriations to and authorizing expenditures of money by the Nevada Supreme Court for the replacement of computer hardware and software; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Expenditure of \$64,353 not appropriated from the
2 State General Fund or the State Highway Fund is hereby authorized
3 during Fiscal Year 2021-2022 and Fiscal Year 2022-2023 by the
4 Nevada Supreme Court from the Administrative Office of the
5 Courts budget account for the replacement of computer hardware
6 and software.

7 **Sec. 2.** 1. There is hereby appropriated from the State
8 General Fund to the Nevada Supreme Court the sum of \$13,652 for
9 the Judicial Programs and Services Division budget account for the
10 replacement of computer hardware and software.

11 2. Any remaining balance of the appropriation made by
12 subsection 1 must not be committed for expenditure after June 30,
13 2023, by the entity to which the appropriation is made or any



1 entity to which money from the appropriation is granted or
2 otherwise transferred in any manner, and any portion of the
3 appropriated money remaining must not be spent for any purpose
4 after September 15, 2023, by either the entity to which the money
5 was appropriated or the entity to which the money was subsequently
6 granted or transferred, and must be reverted to the State General
7 Fund on or before September 15, 2023.

8 **Sec. 3.** Expenditure of \$19,503 not appropriated from the State
9 General Fund or the State Highway Fund is hereby authorized
10 during Fiscal Year 2021-2022 and Fiscal Year 2022-2023 by the
11 Nevada Supreme Court from the Uniform System of Judicial
12 Records budget account for the replacement of computer hardware
13 and software.

14 **Sec. 4.** Expenditure of \$7,802 not appropriated from the State
15 General Fund or the State Highway Fund is hereby authorized
16 during Fiscal Year 2021-2022 and Fiscal Year 2022-2023 by the
17 Nevada Supreme Court from the Judicial Education budget account
18 for the replacement of computer hardware and software.

19 **Sec. 5.** 1. There is hereby appropriated from the State
20 General Fund to the Nevada Supreme Court the sum of \$42,903 for
21 the Court of Appeals budget account for the replacement of
22 computer hardware and software.

23 2. Any remaining balance of the appropriation made by
24 subsection 1 must not be committed for expenditure after June 30,
25 2023, by the entity to which the appropriation is made or any
26 entity to which money from the appropriation is granted or
27 otherwise transferred in any manner, and any portion of the
28 appropriated money remaining must not be spent for any purpose
29 after September 15, 2023, by either the entity to which the money
30 was appropriated or the entity to which the money was subsequently
31 granted or transferred, and must be reverted to the State General
32 Fund on or before September 15, 2023.

33 **Sec. 6.** 1. There is hereby appropriated from the State
34 General Fund to the Nevada Supreme Court the sum of \$164,801 for
35 the Supreme Court budget account for the replacement of computer
36 hardware and software.

37 2. Any remaining balance of the appropriation made by
38 subsection 1 must not be committed for expenditure after June 30,
39 2023, by the entity to which the appropriation is made or any
40 entity to which money from the appropriation is granted or
41 otherwise transferred in any manner, and any portion of the
42 appropriated money remaining must not be spent for any purpose
43 after September 15, 2023, by either the entity to which the money
44 was appropriated or the entity to which the money was subsequently



1 granted or transferred, and must be reverted to the State General
2 Fund on or before September 15, 2023.

3 **Sec. 7.** Expenditure of \$1,952 not appropriated from the State
4 General Fund or the State Highway Fund is hereby authorized
5 during Fiscal Year 2021-2022 and Fiscal Year 2022-2023 by the
6 Nevada Supreme Court from the Specialty Court budget account for
7 the replacement of computer hardware and software.

8 **Sec. 8.** 1. There is hereby appropriated from the State
9 General Fund to the Nevada Supreme Court the sum of \$9,753 for
10 the Supreme Court Law Library budget account for the replacement
11 of computer hardware and software.

12 2. Any remaining balance of the appropriation made by
13 subsection 1 must not be committed for expenditure after June 30,
14 2023, by the entity to which the appropriation is made or any
15 entity to which money from the appropriation is granted or
16 otherwise transferred in any manner, and any portion of the
17 appropriated money remaining must not be spent for any purpose
18 after September 15, 2023, by either the entity to which the money
19 was appropriated or the entity to which the money was subsequently
20 granted or transferred, and must be reverted to the State General
21 Fund on or before September 15, 2023.

22 **Sec. 9.** This act becomes effective upon passage and approval.
