SUMMARY—Makes appropriations to and authorizes expenditures by the Office of the Military for maintenance projects at certain facilities and the replacement of computer hardware and software, certain equipment and shop tools. (BDR S-1124)

AN ACT making appropriations to and authorizing expenditures by the Office of the Military for maintenance projects at certain facilities and the replacement of computer hardware and software, certain equipment and shop tools; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State 2 General Fund to the Office of the Military the sum of \$530,024 for 3 maintenance projects at certain Nevada Army National Guard 4 facilities.

5 2. Expenditure of \$741,824 not appropriated from the State 6 General Fund or the State Highway Fund is hereby authorized 7 during Fiscal Year 2021-2022 and Fiscal Year 2022-2023 by 8 the Office of the Military for the same purpose as set forth in 9 subsection 1.





Any remaining balance of the appropriation made by 1 3. 2 subsection 1 must not be committed for expenditure after June 30, 3 2023, by the entity to which the appropriation is made or any entity to which money from the appropriation is granted or 4 5 otherwise transferred in any manner, and any portion of the 6 appropriated money remaining must not be spent for any purpose 7 after September 15, 2023, by either the entity to which the money 8 was appropriated or the entity to which the money was subsequently 9 granted or transferred, and must be reverted to the State General Fund on or before September 15, 2023. 10

11 Sec. 2. 1. There is hereby appropriated from the State 12 General Fund to the Office of the Military the sum of \$39,750 for 13 the replacement of computer hardware and software.

14 2. Any remaining balance of the appropriation made by subsection 1 must not be committed for expenditure after June 30, 15 16 2023, by the entity to which the appropriation is made or any 17 entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the 18 19 appropriated money remaining must not be spent for any purpose 20 after September 15, 2023, by either the entity to which the money 21 was appropriated or the entity to which the money was subsequently 22 granted or transferred, and must be reverted to the State General 23 Fund on or before September 15, 2023.

24 **Sec. 3.** 1. There is hereby appropriated from the State 25 General Fund to the Office of the Military the sum of \$43,180 for 26 the replacement of equipment and shop tools.

27 2. Expenditure of \$84,872 not appropriated from the State 28 General Fund or the State Highway Fund is hereby authorized 29 during Fiscal Year 2021-2022 and Fiscal Year 2022-2023 by 30 the Office of the Military for the same purpose as set forth in 31 subsection 1.

32 Any remaining balance of the appropriation made by 3. 33 subsection 1 must not be committed for expenditure after June 30, 34 2023, by the entity to which the appropriation is made or any 35 entity to which money from the appropriation is granted or otherwise transferred in any manner, and any portion of the 36 37 appropriated money remaining must not be spent for any purpose after September 15, 2023, by either the entity to which the money 38 39 was appropriated or the entity to which the money was subsequently 40 granted or transferred, and must be reverted to the State General 41 Fund on or before September 15, 2023.

42 **Sec. 4.** This act becomes effective upon passage and approval.
