AN ACT making appropriations to the Office of Finance in the Office of the Governor for the costs associated with the replacement of the Advantage Financial and Human Resources System with the Enterprise Resource Planning System and furnishings for the operations center for the System; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1     **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the Office of Finance in the Office of the Governor  
3 the sum of \$23,567,659 for the costs associated with the  
4 replacement of the Advantage Financial and Human Resources  
5 System with the Enterprise Resource Planning System.  
6     2. Any remaining balance of the appropriation made by  
7 subsection 1 must not be committed for expenditure after June 30,  
8 2023, by the entity to which the appropriation is made or any



1 entity to which money from the appropriation is granted or  
2 otherwise transferred in any manner, and any portion of the  
3 appropriated money remaining must not be spent for any purpose  
4 after September 15, 2023, by either the entity to which the money  
5 was appropriated or the entity to which the money was subsequently  
6 granted or transferred, and must be reverted to the State General  
7 Fund on or before September 15, 2023.

8 **Sec. 2.** 1. There is hereby appropriated from the State  
9 Highway Fund to the Office of Finance in the Office of the  
10 Governor the sum of \$5,615,901 for the costs associated with the  
11 replacement of the Advantage Financial and Human Resources  
12 System with the Enterprise Resource Planning System.

13 2. Any remaining balance of the appropriation made by  
14 subsection 1 must not be committed for expenditure after June 30,  
15 2023, by the entity to which the appropriation is made or any  
16 entity to which money from the appropriation is granted or  
17 otherwise transferred in any manner, and any portion of the  
18 appropriated money remaining must not be spent for any purpose  
19 after September 15, 2023, by either the entity to which the money  
20 was appropriated or the entity to which the money was subsequently  
21 granted or transferred, and must be reverted to the State Highway  
22 Fund on or before September 15, 2023.

23 **Sec. 3.** 1. There is hereby appropriated from the State  
24 General Fund to the Office of Finance in the Office of the Governor  
25 the sum of \$32,055 for the costs of furnishings for the operations  
26 center for the Enterprise Resource Planning System.

27 2. Any remaining balance of the appropriation made by  
28 subsection 1 must not be committed for expenditure after June 30,  
29 2023, by the entity to which the appropriation is made or any  
30 entity to which money from the appropriation is granted or  
31 otherwise transferred in any manner, and any portion of the  
32 appropriated money remaining must not be spent for any purpose  
33 after September 15, 2023, by either the entity to which the money  
34 was appropriated or the entity to which the money was subsequently  
35 granted or transferred, and must be reverted to the State General  
36 Fund on or before September 15, 2023.

37 **Sec. 4.** 1. There is hereby appropriated from the State  
38 Highway Fund to the Office of Finance in the Office of the  
39 Governor the sum of \$7,519 for the costs of furnishings for the  
40 operations center for the Enterprise Resource Planning System.

41 2. Any remaining balance of the appropriation made by  
42 subsection 1 must not be committed for expenditure after June 30,  
43 2023, by the entity to which the appropriation is made or any  
44 entity to which money from the appropriation is granted or  
45 otherwise transferred in any manner, and any portion of the



1 appropriated money remaining must not be spent for any purpose  
2 after September 15, 2023, by either the entity to which the money  
3 was appropriated or the entity to which the money was subsequently  
4 granted or transferred, and must be reverted to the State Highway  
5 Fund on or before September 15, 2023.

6 **Sec. 5.** This act becomes effective upon passage and approval.
