SUMMARY—Revises provisions relating to business entities.

AN ACT relating to business entities; revising provisions relating to service of process on management persons; making various changes to definitions relating to corporations; authorizing a corporation to include a federal forum selection clause in its articles of incorporation or bylaws; revising provisions relating to the breach of a fiduciary duty by a director or officer of a corporation; making various changes relating to meetings of stockholders held by means of remote communication; revising provisions relating to voting agreements of stockholders; revising provisions relating to notice of meetings of stockholders; revising provisions relating to insolvent corporations; revising provisions relating to discretionary indemnification of directors, officers, employees and agents of corporations; providing an exception to the requirement that a corporation issue a certificate of membership; establishing and revising provisions relating to distributions made by limited-liability companies; revising provisions relating to the form of contributions to capital of members of a limited-liability company or series; making various changes relating to the standard of voting for actions taken by corporations, limited partnerships and limited-liability companies; revising provisions relating to dissenter's rights; and providing other matters properly relating thereto.



Legislative Counsel's Digest:

1 Existing law establishes various provisions relating to business entities,
2 including private corporations and limited-liability companies. (Chapters 78 and 86
3 of NRS) This bill revises certain provisions relating to business entities and makes
4 certain other changes generally relating to business entities.

5 **Section 1** of this bill removes the requirement that a clerk of the court mail to
6 certain management persons of a business entity true and attested copies of the
7 process served on the registered agent of the entity, and instead requires that the
8 party serving the registered agent mail to such management persons a copy of any
9 document served upon the registered agent.

10 **Section 38** of this bill repeals the selectively applicable definitions of "market
11 value," "publicly traded corporation," "resident domestic corporation" and
12 "Securities Exchange Act," respectively, and replaces the definitions in **section 2** of
13 this bill in order to expand the applicability of such definitions to the entirety of
14 chapter 78 of NRS. **Sections 3, 7 and 8** of this bill make conforming changes
15 related to the definition of the "Securities Exchange Act."

16 **Section 4** of this bill authorizes a corporation to include a federal forum
17 selection clause in its articles of incorporation or bylaws under certain
18 circumstances.

19 **Section 5** of this bill expressly provides that the directors and officers of a
20 corporation may consider one or more facts, circumstances, contingencies or
21 constituencies when exercising their respective powers.

22 **Section 6** of this bill revises the definition of "distribution," as it relates to
23 distributions made by corporations, by delineating that the term applies to all
24 holders of shares of any one or more classes or series of the capital stock of the
25 corporation. **Sections 9 and 10** of this bill make conforming changes related to
26 distributions made by corporations.

27 **Section 11** of this bill authorizes a meeting of stockholders to be held solely by
28 means of remote communication unless otherwise prescribed by the board of
29 directors. **Section 11** also provides that, in addition to the stockholders, the
30 corporation may permit certain other persons to attend the remote meeting.
31 Moreover, **section 11** provides that the corporation must implement measures to
32 verify the identity of the permitted persons.

33 **Section 12** of this bill provides that the record date for a meeting of
34 stockholders of the corporation: (1) must be fixed through a resolution adopted by
35 the board of directors; and (2) must not precede the day on which the resolution is
36 adopted by the board of directors, regardless of the effective date of the resolution.

37 **Section 12** also provides that the date upon which the stockholders of record
38 are entitled to give written consent for certain actions taken by the corporation must
39 not precede the day on which the resolution fixing such a date is adopted by the
40 board of directors, regardless of the effective date of the resolution.

41 **Section 13** of this bill: (1) establishes provisions concerning the validity and
42 enforceability of certain voting agreements; and (2) revises provisions relating to
43 the limitation on the duration of certain voting agreements.

44 **Section 14** of this bill revises the form of notice for meetings of stockholders
45 by requiring the notice to include the following information: (1) the date of the
46 meeting; (2) if the meeting is to be held by means of remote communication, the
47 form of the remote communication; and (3) if the meeting is not going to be held
48 solely by means of remote communication, the physical location of the meeting.
49 **Section 14** additionally applies these changes to the form of notice required for
50 adjourned meetings of stockholders.

51 **Section 14** also: (1) revises provisions related to notice by publication; and (2)
52 establishes provisions authorizing certain publicly traded corporations to provide
53 notice by proxy statement under certain circumstances.



54 **Section 14.5** of this bill expressly provides that whenever a corporation is
55 insolvent and in certain other circumstances, any creditors holding at least 10
56 percent of the outstanding indebtedness, or stockholders owning at least 10 percent
57 of the outstanding stock entitled to vote, may petition a district court for a writ of
58 injunction and the appointment of receivers or trustees.

59 **Section 15** of this bill expands the circumstances by which a corporation may
60 discretionally indemnify a person who is or was a party to an action, or threatened
61 to be made a party to an action, by authorizing the corporation to indemnify any
62 such person who is or was serving at the request of the corporation as a manager of
63 a limited-liability company.

64 **Section 16** of this bill provides exception for corporations that are associations
65 or unit-owners' associations from the requirement that corporations issue a
66 certificate of membership to any person who becomes a member of the corporation.

67 **Section 19** of this bill defines the term "distribution" for the purposes of
68 **section 21** of this bill concerning noneconomic members of limited-liability
69 companies and **sections 23 and 24** of this bill relating to the circumstances by
70 which a limited-liability company is authorized to or prohibited from making
71 distributions and certain other provisions of law relating to limited-liability
72 companies.

73 **Sections 22 and 25-27** of this bill require that a vote of approval for certain
74 actions taken by a limited-liability company be determined by a specified
75 proportion "in interest" of the members, as defined by **section 18** of this bill.
76 **Section 38** makes a conforming change by repealing the definitions of the term
77 "majority in interest." **Section 20** of this bill makes a conforming change relating to
78 the placement of **section 18** in the Nevada Revised Statutes.

79 **Section 22.5** of this bill provides that the provisions concerning the form of
80 contributions to capital of a member of a limited-liability company or a series apply
81 to the entirety of chapter 86 of NRS.

82 **Section 32** of this bill provides the circumstances under which a vote of the
83 stockholders of a domestic corporation is not required to authorize a merger in
84 which the corporation is a constituent entity.

85 **Section 33** of this bill provides that a plan of merger, conversion or exchange
86 involving a domestic limited partnership must be approved, in relevant part, by a
87 majority of the total contributions of the limited partners.

88 **Section 34** of this bill provides that a plan of merger, conversion or exchange
89 involving a domestic limited-liability company must be approved by: (1) a majority
90 of the total contributions of the members, if there is one class of members; or (2) a
91 majority of the total contributions of each class of members, if there are two or
92 more classes of members.

93 **Section 35** of this bill revises the applicability of the limitations on dissenter's
94 rights. **Section 36** of this bill makes various changes related to the notification of
95 stockholders concerning corporate actions creating dissenter's rights, including,
96 without limitation, authorizing a domestic corporation to send an advance notice
97 statement to the stockholders if a proposed corporate action creating dissenter's
98 rights is submitted for approval pursuant to a written consent of the stockholders or
99 taken without a vote of the stockholders.

100 **Section 37** of this bill makes various changes to provisions related to the
101 prerequisites for a demand by a stockholder for payment of the shares of the
102 stockholder, including requiring such a stockholder to file a statement of intent
103 under certain circumstances.

104 **Sections 29 and 30** of this bill define the terms "advance notice statement" and
105 "statement of intent," respectively. **Section 31** of this bill makes conforming
106 changes related to the placement of the definitions in the Nevada Revised Statutes.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 75.160 is hereby amended to read as follows:

2 75.160 1. Every nonresident of this State who, on or after
3 October 1, 2013, accepts election or appointment, including
4 reelection or reappointment, as a management person of an entity, or
5 who, on or after October 1, 2014, serves in such capacity, and every
6 resident of this State who accepts election or appointment or serves
7 in such capacity and thereafter removes residence from this State
8 shall be deemed, by the acceptance or by the service, to have
9 consented to the appointment of the registered agent of the entity as
10 an agent upon whom service of process may be made in all civil
11 actions or proceedings brought in this State by, on behalf of or
12 against the entity in which the management person is a necessary or
13 proper party, or in any action or proceeding against the management
14 person for a violation of a duty in such capacity, whether or not the
15 person continues to serve as the management person at the time the
16 action or proceeding is commenced. The acceptance or the service
17 by the management person shall be deemed to be signification of the
18 consent of the management person that any process so served has
19 the same legal force and validity as if served upon the management
20 person within this State.

21 2. Service of process must be effected by serving the registered
22 agent with a true copy in the manner provided by law for service of
23 process. In addition, the ~~{clerk of the court in which the civil action~~
24 ~~or proceeding is pending}~~ *party serving the registered agent* shall,
25 within 7 days after *such* service, send by registered or certified mail,
26 postage prepaid, ~~{true and attested}~~ copies of the ~~{process,}~~
27 *documents served upon the registered agent*, together with a
28 statement that service is being made pursuant to this section,
29 addressed to the management person at the address as it appears on
30 the records of the Secretary of State, or if no such address appears,
31 at the address last known to the *-serving* party. ~~{desiring to make the~~
32 ~~service.}~~

33 3. The appointment of the registered agent is irrevocable. If
34 any entity or management person fails to appoint a registered agent,
35 or fails to file a statement of change of registered agent pursuant to
36 NRS 77.340 before the effective date of a vacancy in the agency
37 pursuant to NRS 77.330 or 77.370, on the production of a certificate
38 of the Secretary of State showing either fact, which is conclusive
39 evidence of the fact so certified to be made a part of the return of
40 service, or if the street address of the registered agent of the entity is
41 not staffed as required pursuant to NRS 14.020, which fact is to be
42 made part of the return of service, the management person may be



1 served with any and all legal process, or a demand or notice
2 described in NRS 14.020, by delivering a copy to the Secretary of
3 State or, in the absence of the Secretary of State, to any deputy
4 secretary of state, and such service is valid to all intents and
5 purposes. The copy must:

6 (a) Include a specific citation to the provisions of this section.
7 The Secretary of State may refuse to accept such service if the
8 proper citation is not included.

9 (b) Be accompanied by a fee of \$10.

10 ↪ The Secretary of State shall keep a copy of the legal process
11 received pursuant to this section in the Office of the Secretary of
12 State for at least 1 year after receipt thereof and shall make those
13 records available for public inspection during normal business
14 hours.

15 4. In all cases of service pursuant to subsection 3, the
16 defendant has 40 days, exclusive of the day of service, within which
17 to answer or plead. Before such service is authorized, the plaintiff
18 shall make or cause to be made and filed an affidavit setting forth
19 the facts, showing that due diligence has been used to ascertain the
20 whereabouts of the management person to be served, and the facts
21 showing that direct or personal service on, or notice to, the
22 management person cannot be made.

23 5. If it appears from the affidavit that there is a last known
24 address of the management person, the plaintiff shall, in addition to
25 and after such service on the Secretary of State, mail or cause to be
26 mailed to the management person at such address, by registered or
27 certified mail, a copy of the summons and a copy of the complaint,
28 and in all such cases the defendant has 40 days after the date of the
29 mailing within which to appear in the action.

30 6. Service pursuant to subsection 3 provides an additional
31 manner of serving process, and does not affect the validity of any
32 other valid service.

33 7. In any action in which any management person has been
34 served with process pursuant to subsection 2, the time in which a
35 defendant is required to appear and file a responsive pleading must
36 be computed from the date of mailing by the ~~clerk of the court.~~
37 *servicing party*. The court may grant an extension of time as may be
38 necessary to afford the management person reasonable opportunity
39 to defend the action.

40 8. In a charter or other writing, a management person or owner
41 of any entity may consent to be subject to the nonexclusive
42 jurisdiction of the courts of, or arbitration in, a specified jurisdiction,
43 or the exclusive jurisdiction of the courts of this State, or the
44 exclusivity of arbitration in a specified jurisdiction or this State, and
45 to be served with process in the manner prescribed in the charter or



1 other writing. Notwithstanding any other provision of this
2 subsection, except by agreeing to arbitrate any arbitrable matter in a
3 specified jurisdiction or in this State, an owner of an entity who is
4 not a management person may not waive its right to maintain a legal
5 action or proceeding in the courts of this State with respect to
6 matters relating to the organization or internal affairs of an entity.
7 Without limiting or affecting the enforceability under the laws of
8 this State governing corporations of any consent or agreement by a
9 management person or stockholder of a corporation, this subsection
10 does not apply to an entity which is a corporation.

11 9. This section does not limit or affect the right to serve
12 process in any other manner now existing or hereafter enacted. This
13 section is an extension of, and not a limitation upon, the right
14 otherwise existing of service of legal process upon nonresidents.

15 10. As used in this section:

16 (a) "Charter" means the articles of organization or an operating
17 agreement of a limited-liability company, the certificate of limited
18 partnership or partnership agreement of a limited partnership or the
19 certificate of trust or governing instrument of a business trust.

20 (b) "Entity" means a domestic:

- 21 (1) Corporation, whether or not for profit;
- 22 (2) Limited-liability company;
- 23 (3) Limited partnership; or
- 24 (4) Business trust.

25 (c) "Management person" means a director, officer, manager,
26 managing member, general partner or trustee of an entity.

27 (d) "Owner" means a member of a limited-liability company,
28 limited partner of a limited partnership or beneficial owner of a
29 business trust.

30 (e) "Registered agent" has the meaning ascribed to it in
31 NRS 77.230.

32 **Sec. 2.** NRS 78.010 is hereby amended to read as follows:

33 78.010 1. As used in this chapter:

34 (a) "Approval" and "vote" as describing action by the directors
35 or stockholders mean the vote of directors in person or by written
36 consent or of stockholders in person, by proxy or by written consent.

37 (b) "Articles," "articles of incorporation" and "certificate of
38 incorporation" are synonymous terms and, unless the context
39 otherwise requires, include all certificates filed pursuant to NRS
40 78.030, 78.180, 78.185, 78.1955, 78.209, 78.380, 78.385, 78.390,
41 78.725 and 78.730 and any articles of merger, conversion, exchange
42 or domestication filed pursuant to NRS 92A.200 to 92A.240,
43 inclusive, or 92A.270. Unless the context otherwise requires, these
44 terms include restated articles and certificates of incorporation.

45 (c) "Directors" and "trustees" are synonymous terms.



- 1 (d) "Entity" means a foreign or domestic:
2 (1) Corporation, whether or not for profit;
3 (2) Limited-liability company;
4 (3) Limited partnership; or
5 (4) Business trust.

6 (e) *"Market value" when used in reference to the shares or*
7 *property of any resident domestic corporation, means:*

8 (1) *In the case of shares, the highest closing sale price of a*
9 *share during the 30 calendar days immediately preceding the date*
10 *in question on the principal United States securities exchange*
11 *registered under the Securities Exchange Act on which the shares*
12 *are listed, or, if the shares are not listed on any such exchange, the*
13 *fair market value on the date in question of a share as determined*
14 *by the board of directors of the resident domestic corporation in*
15 *good faith.*

16 (2) *In the case of property other than cash or shares, the*
17 *fair market value of the property on the date in question as*
18 *determined by the board of directors of the resident domestic*
19 *corporation in good faith.*

20 (f) *"Publicly traded corporation" means a domestic*
21 *corporation that has a class or series of voting shares which is:*

22 (1) *A covered security under section 18(b)(1)(A) or (B) of*
23 *the Securities Act of 1933, 15 U.S.C. § 77r(b)(1)(A) or (B), as*
24 *amended; or*

25 (2) *Traded in an organized market and that has at least*
26 *2,000 stockholders and a market value of at least \$20,000,000,*
27 *exclusive of the value of such shares held by the corporation's*
28 *subsidiaries, senior executives, directors and beneficial*
29 *stockholders owning more than 10 percent of such shares.*

30 (g) "Principal office" means the office, in or out of this State,
31 where the principal executive offices of a domestic or foreign
32 corporation are located.

33 ~~(h)~~ (h) "Receiver" includes receivers and trustees appointed by
34 a court as provided in this chapter or in chapter 32 of NRS.

35 ~~(e)~~ (i) "Registered agent" has the meaning ascribed to it in
36 NRS 77.230.

37 ~~(h)~~ (j) "Registered office" means the office maintained at the
38 street address of the registered agent.

39 ~~(i)~~ (k) *"Resident domestic corporation" means a domestic*
40 *corporation that has 200 or more stockholders of record. A*
41 *resident domestic corporation does not cease to be a resident*
42 *domestic corporation by reason of events occurring or actions*
43 *taken while the resident domestic corporation is subject to NRS*
44 *78.411 to 78.444, inclusive.*



1 *(l) "Securities Exchange Act" means the Act of Congress*
2 *known as the Securities Exchange Act of 1934, as amended, 15*
3 *U.S.C. §§ 78a et seq.*

4 *(m) "Stockholder of record" means a person whose name*
5 *appears on the stock ledger of the corporation as the owner of record*
6 *of shares of any class or series of the stock of the corporation. The*
7 *term does not include a beneficial owner of shares who is not*
8 *simultaneously the owner of record of such shares as indicated in*
9 *the stock ledger.*

10 2. General terms and powers given in this chapter are not
11 restricted by the use of special terms, or by any grant of special
12 powers contained in this chapter.

13 **3. As used in this section:**

14 *(a) "Share" has the meaning ascribed to it in NRS 78.429.*

15 *(b) "Subsidiary" has the meaning ascribed to it in NRS 78.431.*

16 *(c) "Voting shares" has the meaning ascribed to it in*

18 **Sec. 3.** NRS 78.045 is hereby amended to read as follows:

19 78.045 1. The Secretary of State shall not accept for filing
20 any articles of incorporation or any certificate of amendment of
21 articles of incorporation of any corporation formed pursuant to the
22 laws of this State which provides that the name of the corporation
23 contains the word "bank" or "trust," unless:

24 (a) It appears from the articles or the certificate of amendment
25 that the corporation proposes to carry on business as a banking or
26 trust company, exclusively or in connection with its business as a
27 bank, savings and loan association, savings bank or thrift company;
28 and

29 (b) The articles or certificate of amendment is first approved by
30 the Commissioner of Financial Institutions.

31 2. The Secretary of State shall not accept for filing any articles
32 of incorporation or any certificate of amendment of articles of
33 incorporation of any corporation formed pursuant to the provisions
34 of this chapter if it appears from the articles or the certificate of
35 amendment that the business to be carried on by the corporation is
36 subject to supervision by the Commissioner of Insurance or by the
37 Commissioner of Financial Institutions, unless the articles or
38 certificate of amendment is approved by the Commissioner who will
39 supervise the business of the corporation.

40 3. Except as otherwise provided in subsection 7, the Secretary
41 of State shall not accept for filing any articles of incorporation or
42 any certificate of amendment of articles of incorporation of any
43 corporation formed pursuant to the laws of this State if the name of
44 the corporation contains the words "engineer," "engineered,"



1 “engineering,” “professional engineer,” “registered engineer” or
2 “licensed engineer” unless:

3 (a) The State Board of Professional Engineers and Land
4 Surveyors certifies that the principals of the corporation are licensed
5 to practice engineering pursuant to the laws of this State; or

6 (b) The State Board of Professional Engineers and Land
7 Surveyors certifies that the corporation is exempt from the
8 prohibitions of NRS 625.520.

9 4. Except as otherwise provided in subsection 7, the Secretary
10 of State shall not accept for filing any articles of incorporation or
11 any certificate of amendment of articles of incorporation of any
12 corporation formed pursuant to the laws of this State if the name of
13 the corporation contains the words “architect,” “architecture,”
14 “registered architect,” “licensed architect,” “registered interior
15 designer,” “registered interior design,” “residential designer,”
16 “registered residential designer,” “licensed residential designer” or
17 “residential design” unless the State Board of Architecture, Interior
18 Design and Residential Design certifies that:

19 (a) The principals of the corporation are holders of a certificate
20 of registration to practice architecture or residential design or to
21 practice as a registered interior designer, as applicable, pursuant to
22 the laws of this State; or

23 (b) The corporation is qualified to do business in this State
24 pursuant to NRS 623.349.

25 5. The Secretary of State shall not accept for filing any articles
26 of incorporation or any certificate of amendment of articles of
27 incorporation of any corporation formed pursuant to the laws of this
28 State which provides that the name of the corporation contains the
29 word “accountant,” “accounting,” “accountancy,” “auditor” or
30 “auditing” unless the Nevada State Board of Accountancy certifies
31 that the corporation:

32 (a) Is registered pursuant to the provisions of chapter 628 of
33 NRS; or

34 (b) Has filed with the Nevada State Board of Accountancy under
35 penalty of perjury a written statement that the corporation is not
36 engaged in the practice of accounting and is not offering to practice
37 accounting in this State.

38 6. The Secretary of State shall not accept for filing any articles
39 of incorporation or any certificate of amendment of articles of
40 incorporation of any corporation formed or existing pursuant to the
41 laws of this State which provides that the name of the corporation
42 contains the words “common-interest community,” “community
43 association,” “master association,” “unit-owners’ association” or
44 “homeowners’ association” or if it appears in the articles of
45 incorporation or certificate of amendment that the purpose of the



1 corporation is to operate as a unit-owners' association pursuant to
2 chapter 116 or 116B of NRS unless the Administrator of the Real
3 Estate Division of the Department of Business and Industry certifies
4 that the corporation has:

5 (a) Registered with the Ombudsman for Owners in Common-
6 Interest Communities and Condominium Hotels pursuant to NRS
7 116.31158 or 116B.625; and

8 (b) Paid to the Administrator of the Real Estate Division the fees
9 required pursuant to NRS 116.31155 or 116B.620.

10 7. The provisions of subsections 3 and 4 do not apply to any
11 corporation, whose securities are publicly traded and regulated by
12 the Securities Exchange Act, ~~[of 1934,]~~ which does not engage in
13 the practice of professional engineering, architecture or residential
14 design or interior design, as applicable.

15 8. The Commissioner of Financial Institutions and the
16 Commissioner of Insurance may approve or disapprove the articles
17 or amendments referred to them pursuant to the provisions of this
18 section.

19 **Sec. 4.** NRS 78.046 is hereby amended to read as follows:

20 78.046 1. The articles of incorporation or bylaws of a
21 corporation may require, to the extent not inconsistent with any
22 applicable jurisdictional requirements ~~[]~~ *and the laws of the United*
23 *States*, that any, all or certain ~~[internal]~~ :

24 (a) *Concurrent jurisdiction actions must be brought solely or*
25 *exclusively in the court or courts specified in the requirement; and*

26 (b) *Internal* actions must be brought solely or exclusively in the
27 court or courts specified in the requirement, which must include at
28 least one court in this State.

29 2. Unless otherwise expressly set forth in the articles of
30 incorporation or bylaws, ~~[such a]~~ *any* requirement *described in*
31 *subsection 1* must not be interpreted as prohibiting any corporation
32 from consenting, or requiring any corporation to consent, to any
33 alternative forum in any instance.

34 ~~[2.]~~ 3. The provisions of this section do not create or authorize
35 any cause of action against a corporation or its directors or officers.

36 ~~[3.]~~ 4. As used in this section:

37 (a) *“Concurrent jurisdiction action” means any action, suit or*
38 *proceeding against the corporation or any of its directors or*
39 *officers, that:*

40 (1) *Asserts a cause of action under the laws of the United*

43 *or a forum of this State or any other state; and*

11 (1) Brought in the name or right of the corporation or on its
12 behalf, including, without limitation, any action subject to
13 NRS 41.520;

14 (2) For or based upon any breach of any fiduciary duty owed
15 by any director, officer, employee or agent of the corporation in
16 such capacity; or

17 (3) Arising pursuant to, or to interpret, apply, enforce or
18 determine the validity of, any provision of this title, the articles of
