SUMMARY—Revises the grounds for disciplinary action against a licensed contractor. (BDR 54-268)

AN ACT relating to contractors; revising the grounds for disciplinary action against a licensed contractor by the State Contractors’ Board to include certain acts related to another person’s application for a contractor’s license; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law provides for the licensure and regulation of contractors by the
2 State Contractors’ Board. (Chapter 624 of NRS) Existing law sets forth certain acts
3 or omissions that constitute cause for disciplinary action against a licensed
4 contractor by the Board. (NRS 624.3016) This bill provides that knowingly
5 making, or causing to be made, any false or misleading statement or representation,
6 or knowingly omitting any material fact, in connection with the application of
7 another person for a contractor’s license for the purpose of assisting the applicant to
8 obtain the license constitutes cause for disciplinary action by the Board.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 624.3016 is hereby amended to read as
2 follows:
3 624.3016 The following acts or omissions, among others,
4 constitute cause for disciplinary action under NRS 624.300:



1 1. Any fraudulent or deceitful act committed in the capacity of
2 a contractor, including, without limitation, misrepresentation or the
3 omission of a material fact.

4 2. A conviction of a violation of NRS 624.730, or a conviction
5 in this State or any other jurisdiction of a felony relating to the
6 practice of a contractor or a crime involving moral turpitude.

7 3. Knowingly making a false statement in or relating to the
8 recording of a notice of lien pursuant to the provisions of
9 NRS 108.226.

10 4. Failure to give a notice required by NRS 108.227, 108.245,
11 108.246 or 624.520.

12 5. Failure to comply with NRS 624.920, 624.930, 624.935 or
13 624.940 or any regulations of the Board governing contracts for
14 work concerning residential pools and spas.

15 6. Failure to comply with NRS 624.860 to 624.875, inclusive,
16 or any regulations of the Board governing contracts for work
17 concerning residential photovoltaic systems used to produce
18 electricity.

19 7. Failure to comply with NRS 624.600.

20 8. Misrepresentation or the omission of a material fact, or the
21 commission of any other fraudulent or deceitful act, to obtain a
22 license.

23 9. Failure to pay an assessment required pursuant to
24 NRS 624.470.

25 10. Failure to file a certified payroll report that is required for a
26 contract for a public work.

27 11. Knowingly submitting false information in an application
28 for qualification or a certified payroll report that is required for a
29 contract for a public work.

30 12. Failure to notify the Board of a conviction or entry of a
31 plea of guilty, guilty but mentally ill or nolo contendere pursuant to
32 NRS 624.266.

33 13. Failure to provide a builder's warranty as required by NRS
34 624.602 or to respond reasonably to a claim made under a builder's
35 warranty.

36 *14. Knowingly making, or causing to be made, any false or*
37 *misleading statement or representation, or knowingly omitting any*
38 *material fact, in connection with the application of another person*
39 *for a contractor's license for the purpose of assisting the applicant*
40 *to obtain the license.*

41 **Sec. 2.** This act becomes effective upon passage and approval.
