AN ACT making appropriations to the Department of Public Safety for costs related to the Joint Emergency Training Institute and the replacement or purchase of computer hardware and associated software, radio equipment and certain weapons; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** There is hereby appropriated from the State General
- 2 Fund to the Department of Public Safety the sum of \$2,000,000 for
- 3 the Director’s Office budget account for costs related to the Joint
- 4 Emergency Training Institute.
- 5 **Sec. 2.** There is hereby appropriated from the State General
- 6 Fund to the Training Division of the Department of Public Safety
- 7 the sum of \$29,401 for the replacement of computer hardware and
- 8 associated software.
- 9 **Sec. 3.** There is hereby appropriated from the State Highway
- 10 Fund to the Training Division of the Department of Public Safety



1 the sum of \$30,601 for the replacement of computer hardware and
2 associated software.

3 **Sec. 4.** There is hereby appropriated from the State General
4 Fund to the Training Division of the Department of Public Safety
5 the sum of \$10,043 for the purchase of radio equipment.

6 **Sec. 5.** There is hereby appropriated from the State Highway
7 Fund to the Training Division of the Department of Public Safety
8 the sum of \$10,453 for the purchase of radio equipment.

9 **Sec. 6.** There is hereby appropriated from the State General
10 Fund to the Training Division of the Department of Public Safety
11 the sum of \$8,468 for the replacement of taser weapons.

12 **Sec. 7.** There is hereby appropriated from the State Highway
13 Fund to the Training Division of the Department of Public Safety
14 the sum of \$8,812 for the replacement of taser weapons.

15 **Sec. 8.** There is hereby appropriated from the State General
16 Fund to the Nevada Office of Cyber Defense Coordination of the
17 Department of Public Safety the sum of \$5,550 for the replacement
18 of computer hardware and associated software.

19 **Sec. 9.** There is hereby appropriated from the State General
20 Fund to the Department of Public Safety the sum of \$9,190 for the
21 Dignitary Protection budget account for the replacement of
22 computer hardware and associated software.

23 **Sec. 10.** There is hereby appropriated from the State General
24 Fund to the Department of Public Safety the sum of \$13,664 for the
25 Dignitary Protection budget account for the purchase of portable
26 radios.

27 **Sec. 11.** There is hereby appropriated from the State General
28 Fund to the Department of Public Safety the sum of \$12,960 for the
29 Dignitary Protection budget account for the replacement of taser
30 weapons.

31 **Sec. 12.** Any remaining balance of the appropriations made by
32 sections 1 to 11, inclusive, of this act must not be committed for
33 expenditure after June 30, 2025, by the entity to which the
34 appropriation is made or any entity to which money from the
35 appropriation is granted or otherwise transferred in any manner, and
36 any portion of the appropriated money remaining must not be spent
37 for any purpose after September 19, 2025, by either the entity to
38 which the money was appropriated or the entity to which the money
39 was subsequently granted or transferred, and must be reverted to the
40 fund from which it was appropriated on or before September 19,
41 2025.

42 **Sec. 13.** This act becomes effective upon passage and
43 approval.
