AN ACT making appropriations to the Division of Public and Behavioral Health of the Department of Health and Human Services for the replacement of computer hardware and associated software, the replacement of office furniture and equipment and deferred maintenance projects; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

- 1 **Section 1.** There is hereby appropriated from the State General

- 6 **Sec. 2.** There is hereby appropriated from the State General

3 **Sec. 3.** There is hereby appropriated from the State General
4 Fund to the Division of Public and Behavioral Health of the
5 Department of Health and Human Services the sum of \$790,431 for
6 the Southern Nevada Adult Mental Health Services budget account
7 for the replacement of computer hardware and associated software.

8 **Sec. 4.** There is hereby appropriated from the State General
9 Fund to the Division of Public and Behavioral Health of the
10 Department of Health and Human Services the sum of \$312,817 for
11 the Southern Nevada Adult Mental Health Services budget account
12 for the replacement of laboratory equipment.

13 **Sec. 5.** There is hereby appropriated from the State General
14 Fund to the Division of Public and Behavioral Health of the
15 Department of Health and Human Services the sum of \$179,035 for
16 the Southern Nevada Adult Mental Health Services budget account
17 for the replacement of utility carts and ice makers.

18 **Sec. 6.** There is hereby appropriated from the State General
19 Fund to the Division of Public and Behavioral Health of the
20 Department of Health and Human Services the sum of \$264,870 for
21 the Northern Nevada Adult Mental Health Services budget account
22 for deferred maintenance projects.

23 **Sec. 7.** There is hereby appropriated from the State General
24 Fund to the Division of Public and Behavioral Health of the
25 Department of Health and Human Services the sum of \$398,960 for
26 the Northern Nevada Adult Mental Health Services budget account
27 for the replacement of computer hardware and associated software.

28 **Sec. 8.** There is hereby appropriated from the State General
29 Fund to the Division of Public and Behavioral Health of the
30 Department of Health and Human Services the sum of \$159,355 for
31 the Community Health Services budget account for the replacement
32 of computer hardware and associated software.

33 **Sec. 9.** There is hereby appropriated from the State General
34 Fund to the Division of Public and Behavioral Health of the
35 Department of Health and Human Services the sum of \$88,121 for
36 the Lakes Crossing Center budget account for the replacement of
37 computer hardware and associated software.

38 **Sec. 10.** There is hereby appropriated from the State General
39 Fund to the Division of Public and Behavioral Health of the
40 Department of Health and Human Services the sum of \$151,500 for
41 the Lakes Crossing Center budget account for deferred maintenance
42 projects.

43 **Sec. 11.** There is hereby appropriated from the State General
44 Fund to the Division of Public and Behavioral Health of the
45 Department of Health and Human Services the sum of \$347,494 for



1 the Rural Clinics budget account for the replacement of computer
2 hardware and associated software.

3 **Sec. 12.** There is hereby appropriated from the State General
4 Fund to the Division of Public and Behavioral Health of the
5 Department of Health and Human Services the sum of \$96,183 for
6 the Rural Clinics budget account for the replacement of office
7 furniture and equipment.

8 **Sec. 13.** There is hereby appropriated from the State General
9 Fund to the Division of Public and Behavioral Health of the
10 Department of Health and Human Services the sum of \$35,736 for
11 the Rural Clinics budget account for the replacement of telephone
12 system equipment.

13 **Sec. 14.** Any remaining balance of the appropriations made by
14 sections 1 to 13, inclusive, of this act must not be committed for
15 expenditure after June 30, 2025, by the entity to which the
16 appropriation is made or any entity to which money from the
17 appropriation is granted or otherwise transferred in any manner, and
18 any portion of the appropriated money remaining must not be spent
19 for any purpose after September 19, 2025, by either the entity to
20 which the money was appropriated or the entity to which the money
21 was subsequently granted or transferred, and must be reverted to the
22 State General Fund on or before September 19, 2025.

23 **Sec. 15.** This act becomes effective upon passage and
24 approval.
